









# FREQUENTLY ASKED QUESTIONS (FAQs)

Joint Admission Counselling (JAC) Delhi - 2024

### **Frequently Asked Questions**

1. What is the procedure for Online Registration and Counselling Fee Payment?

Please read JAC Delhi 2024 admission brochure available on <a href="https://jacdelhi.admissions.nic.in">https://jacdelhi.admissions.nic.in</a> carefully for clarification of all procedures.

2. My JEE Mains examination result has been declared in a different category/subcategory/region. Can I register for JAC counseling under a different category/subcategory/region?

Yes! JAC Delhi registration portal will ask you to specify your category/sub-category/region (Whether Delhi or Outside Delhi) independent of what was mentioned by you in JEE (Main) application form. Only the candidate's name, JEE (Main) Roll Number and CRL Rank will be authenticated from JEE (Main) result.

- 3. What is the source of latest information about the admission, institute, etc.?

  Latest information is available on <a href="https://jacdelhi.admissions.nic.in">https://jacdelhi.admissions.nic.in</a> and the individual institute's website.
- 4. Are there any management quota seats in JAC Delhi?

There is **NO MANAGEMENT QUOTA** seat in any of the participating university/institute. Candidates are advised that they should not believe in unscrupulous elements claiming that they can arrange Management Quota seats.

5. How many round(s) of counselling will be conducted in JAC DELHI-2024.?

The counselling will be conducted in **Five** rounds (Round 1 to Round 5). Online Registration and Choice Filling will be permitted in only before 1<sup>st</sup> Round. No new registration and change of choice filling will be allowed after registration window is closed.

6. When will the online registration and choice filling start?

Online registration and choice filling will start from 31-05-2024.

7. When and where will the list of selected candidates be displayed?

Seat allotment status will be made available on **Candidate's Login** after declaration of seat allotment result in each round as specified in the counselling schedule.

8. What will be the minimum marks criteria for a candidate if he/she is eligible for seats under multiple reservation categories/subcategories?

The minimum marks criteria applicable for the ALLOTTED seat will be applicable. Please refer admission brochure.

9. I am from outside Delhi and belong to PD/OBC category. Am I eligible to apply under these categories?

Yes! please refer admission brochure for details regarding university/institute wise eligibility and number of seats under these categories.

### 10. A student who has done schooling from Delhi can apply under outside Delhi quota? No!

### 11. Who is a Delhi Region candidate?

The students who have passed qualifying exams (i.e., 12th) from the schools located in Delhi (having PIN CODE of Delhi), irrespective of the location of their hometown, would be considered as "Delhi Candidate".

### 12. Are schools located in NCR, but outside Delhi borders, considered as Delhi schools?

No, "Delhi" candidates must have passed qualifying exams (i.e., 12th) from the schools having PIN CODE of Delhi in their address.

### 13. Who is a Delhi Region candidate for Open Schooling/ Patrachar Vidyalaya/Distance Education?

For a candidate, who has passed the qualifying examination through Patrachar Vidyalaya, Delhi / National Institute of Open School, Delhi (NIOS), the criterion for deciding the region shall be the location of his/her centre of examination. In other words, if the centre of examination is located in the NCT of Delhi, the candidate shall be considered under the Delhi Region and if the centre of examination is located outside NCT of Delhi, he/she shall be considered under the Outside Delhi Region.

### 14. Are there any seats reserved for different categories?

Yes! please refer admission brochure for information regarding number of seats and eligibility criteria for different categories in each of the participating university/institute.

### 15. Is there any Relaxation in Marks for Reserved Categories?

Yes! candidates belonging to certain reserved categories shall be allowed a concession in minimum eligibility requirements. Please refer admission brochure for details.

### 16. What is the branch wise seat distribution in the participating institutes?

Please refer admission brochure.

### 17. Are there any seats reserved for single girl child candidates?

Seats are reserved for Single Girl Child candidate (Girl having no brother and sister (except twin sister)), who have passed 10+2 from schools located in NCT of Delhi for admission to B. Tech. courses in DTU and IGDTUW. Please refer Seat Matrix in the Admission brochure for more details.

### 18. Will a Girl candidate who does not have a living sibling will be considered as Single Girl Child?

Please refer the Certificate for Single Girl Child to be submitted in support of Single Girl Child quota for answer of this query.

#### 19. Do you have any quota for sports and Olympiads?

There is no quota for any of these categories through JAC. However, IGDTUW offers 02 seats in Sports Quota during special SPOT ROUND. Whereas, IIITD gives some bonus marks to applicants with specific achievements. For details, please refer admission brochure.

### 20. What is the validity of Bonus marks?

Scores/Certificates for Bonus fields mentioned in Information brochure will only be considered for giving Bonus marks.

### 21. What is priority discipline under sports category?

For priority and high priority disciplines please refer IIITD website (iiitd.ac.in).

22. I did my 12th schooling from Delhi, however my OBC certificate is issued form other state, will I be considered for Delhi-OBC category benefit?

Please refer Section 3.3 of the admission Brochure.

23. I got less than 60% in the aggregate of Physics, Chemistry and Mathematics, but my overall marks are more than 60%, will I be eligible for admission in NSUT, DTU, IGDTUW and DSEU?

No! a student is eligible only if he/she has (i) secured 60 % or more marks in the aggregate of Physics, Chemistry and Mathematics, and (ii) passed English as a subject of study of the Senior School Certificate Examination Level (Core or Elective). Some relaxation is given to reserved category students, please refer to admission brochure for details.

24. I got 80% in Mathematics in XII in CBSE, but my aggregate of 5 subjects is less than 80%, will I be eligible for admission in IIIT-Delhi?

A candidate who has secured 70% or more marks in the aggregate of best of five subjects including Physics, Chemistry & Mathematics subject to 70% or more marks in Mathematics in the qualifying examination AND having JEE Main 2024 Rank (Paper I) shall be eligible for admission in IIIT-Delhi. For seats belonging to reserved category, the minimum marks criteria are different. Please refer the admission brochure for details.

25. I have taken up improvement exam and now have 70% or above marks in mathematics and aggregate. Can I apply for IIITD?

Yes! Students, who have taken up improvement exam and have now secured 70% or above marks in mathematics and aggregate are eligible to apply for IIITD.

- 26. I have studied Mathematics as an additional subject in class 12th. Can I apply?

  Yes!
- 27. I don't have CSE in class 12th. Am I eligible for admission to B.Tech.(CSE)?

  Yes!

### 28. I have done 10+2 from NIOS. Am I eligible?

Yes!

### 29. I passed 12th in 2022 can I apply?

Yes! provided you have qualified JEE Main in 2024 and satisfy the eligibility criteria of Counselling.

30. Is there any separate application form for registration-cum-counselling for B. Tech. admissions in NSUT, DTU, IGDTUW, IIITD and DSEU.?

No! A common application form has to be filled on website https://jacdelhi.admissions.nic.in

#### 31. What is the last day of fee payment?

A candidate has to pay an amount of Rs. 95,000/- when he is allotted a seat in any round of counselling, as per the schedule specified in the counselling schedule, available at <a href="https://jacdelhi.admissions.nic.in">https://jacdelhi.admissions.nic.in</a>. His provisional admission will be confirmed, once he pays, online, the admission fee and his documents are verified online. In case the candidate does not pay the seat acceptance fee of Rs. 95,000/-, the document verification process will not commence. The last date of payment for different rounds of counselling is mentioned in the counselling schedule available at <a href="https://jacdelhi.admissions.nic.in">https://jacdelhi.admissions.nic.in</a>.

### 32. How will the seats of participating institutes be allotted to candidates?

Seat Allotment for B. Tech. admissions in DTU, NSUT, IGDTUW and DSEU will be strictly based on Combined Rank List (CRL) merit in JEE (Main)–2024. Seat Allotment in IIITD will be based on IIITD Merit list which will be prepared as (i) final percentile score obtained in JEE Mains 2024 Paper-I (ii) bonus points, if any, as described in Chapter 8 (Maximum upto 2 points). IIITD merit list will be based on the total of the above two. In case of a tie, candidate with a higher rank in JEE (Main) 2024 shall rank higher.

33. What, if a candidate refuses to take admission against a seat allotted to him in any round of counselling?

The candidate will not be considered in the remaining rounds of the counselling.

34. Can a candidate change or re-order his/her choices, delete earlier choices and add new choices?

Editing of choices is NOT permitted after the registration window is closed.

35. Can I change my choices after first counselling?

Editing of choices is NOT permitted after the registration window is closed. Please refer to Admission Information Brochure.

### 36. What will happen in case of a tie (two students having same marks) in the merit list of IIIT- Delhi?

In case of a tie, the candidate with higher rank in JEE (Main) 2024, as issued by the NTA shall rank higher.

### 37. How will I be intimated about the second and further rounds of counselling?

The starting dates for different rounds of counselling are mentioned in the detailed counselling schedule available on <a href="https://jacdelhi.admissions.nic.in">https://jacdelhi.admissions.nic.in</a>. You have to regularly visit the website <a href="https://jacdelhi.admissions.nic.in">https://jacdelhi.admissions.nic.in</a> after the first counselling for further details.

## 38. Which rank will be considered for the seat allotment to candidate who have applied for seats reserved under a specified category/ sub-category?

Seat allotment for all categories will be done on the basis of CRL (All India Rank) and Merit list of IIIT-D as explained in the admission brochure.

### 39. Do we have to send the filled-in application form?

No! however, the candidates are advised to download and retain a copy of the online registration form, filled choices, etc.

### 40. What documents need to be uploaded for document verification?

Please refer to information brochure.

### 41. What is the fees structure for B.Tech. programme?

For fee details, refer to <a href="https://jacdelhi.admissions.nic.in">https://jacdelhi.admissions.nic.in</a> or you may visit the individual institute website also for details of Hostel, Mess Fee.

#### 42. Is mess facility available?

Yes, mess facility is available in all the institutes.

### 43. Is transport facility (university/institute bus) available?

No, but all the institutes are well connected to metro and other public transport.

#### 44. What is the last date for withdrawal of admission?

Please refer detailed counselling schedule available on <a href="https://jacdelhi.admissions.nic.in">https://jacdelhi.admissions.nic.in</a> for last date of withdrawal.

### 45. If I want to cancel my admission after it has been confirmed in an earlier round?

A candidate can withdraw his/her admission as per the procedure specified in the admission brochure/Counselling Schedule.

#### 46. In how much time request of withdrawal will be processed?

Seat Acceptance Fee refunds for withdrawals/cancellation will be processed for refund within 20 days after last date of withdrawal as specified in the counselling schedule available on <a href="https://jacdelhi.admissions.nic.in">https://jacdelhi.admissions.nic.in</a>.

### 47. Where can I find about the placement record of last year?

For placement record please visit the individual institute's website.

### 48. Is there any relaxation in marks (Qualifying examination) for EWS category candidates?

There is no marks relaxation for EWS category candidates in any of the participating institute/university.

### 49. What is the meaning of freeze, float and withdrawal (After you have been allotted a seat in any participating University/Institute)?

- a) **FREEZE**: A candidate, who has been allotted a seat and is satisfied with the presently allotted seat to him/her and do not wish to be considered for upgradation of seat in subsequent round of counselling, can opt for the freeze option in order to confirm the seat presently allotted to him.
- b) <u>FLOAT</u> A candidate who has been allotted a seat but wants to confirm the seat presently allotted to him and also at the same time wants to be considered for upgradation of seat in later round of counselling on the basis of his already filled choices, should opt for the float option.
- c) <u>WITHDRAWAL</u> A candidate who has been allotted a seat but is not satisfied with the currently allotted seat to him and do not want to be considered for allotment in any subsequent rounds of counselling, should opt for the withdraw option. The candidates, who opt this option, will be treated to have withdrawn from all the remaining rounds of counselling. The seat allotted to such candidates will be cancelled and shall be treated vacant.

#### 50. What is the criteria of seat conversion during the counselling?

Refer to JAC Admission Information Brochure.

#### 51. What is the list of documents to be uploaded by candidates for registration?

- a. Marks sheet of the qualifying examination, i.e. Class XII or equivalent.
- b. Certificate of High School or equivalent examination (i.e. Class X) as a proof of Date of Birth.
- c. Bonus point document(s), if eligible for IIITD bonus point.
- d. Certificate of category (SC/ST/OBC-NCL/EWS) / sub-category Certificates (CW/PD/KM/SG). In case of OBC-NCL/EWS category, the certificate must be issued on or after April 01, 2024.
- e. CRL Rank Scorecard.
- f. Identity Proof of the Applicant.
- g. For PD sub-category:
  - i. A certificate of physical disability issued by the Competent Authority as per the

- provision of the Persons with Disabilities Act 2016 in the prescribed format as given under the Act.
- ii. The Candidate with benchmark disabilities shall produce the medical certificate issued by the Govt. Hospitals duly notified by the Govt. of NCT of Delhi/Other State government and further duly verified by the Chief Medical Officer of the concerned Government Hospital.
- iii. A certificate, duly recommended by any of the Vocational Rehabilitation Centres for the handicapped, including Vocational Rehabilitation Centre for the handicapped, 9-11 Vikas Marg, Karkarduma, Delhi 110092, established by the Ministry of Labour and Employment.
- iv. Persons with Dyslexic disability can also apply under PD category and they will be required to submit a UDID Card during the verification.
- h. For Defence (CW) sub-category, candidate needs to submit all the documents/certificates specified corresponding to the priority applicable to him/her, combined in a single pdf file.
- Kashmiri Migrant (KM) candidates must upload/submit all the documents/certificates specified corresponding to the priority applicable to him/her, combined in a single pdf file.
