



## Counselling Schedule- JAC Delhi -2026

### A. Important dates for Online Registration for B. Tech /B. Arch

#### Important Instructions

1. Registration is open as per the below mentioned timelines – May 28, 2026 to June 09, 2026 and then again for a Three day from June 26, 2026 to June 28, 2026 before Round 2 as per the timings mentioned. Candidates may also edit their choices during this period. Registration will not be allowed any further before any round throughout the JAC Delhi Admission Cycle. Applications received without prescribed registration fee of Rs.1500/- shall not be considered.
2. Registration Fee is non - refundable.
3. Candidates are advised to fill maximum choices/preferences in the given timeline of Registration and Choice Editing, in order to maximize their chance to get admission and later to be considered for Upgradation through JAC Delhi.
4. Choice Editing will be available only when the registration is open as mentioned in S.No.1 above and there will be no further window of choice editing.
5. Seat conversion as per Section 3.2 of the Information Brochure may take place once the registered claimants in the merit list for any seat in any category/sub-category gets exhausted.
6. All certificates related to category/sub-category should be available with the candidates in the correct prescribed format when he/she reports for document verification. No additional time will be given to produce the required certificate.
7. Seat Acceptance Fee payment in any round will start immediately after the result is published and will be open only till 2:00 pm of the last day of the physical reporting for document verification of that round. All candidates have to report as per the given schedule after payment of their seat acceptance fee.
8. There may be no fresh registrations before Spot Round (if any) so those candidates who are interested to participate in spot round of JAC Delhi 2026 should register as per schedule.

- 2) Defence Category (CW) **candidates falling in Priority VI, VII, VIII and IX are not required to report at NSUT**. They are required to report only at the time of admission along with “all requisite documents complete in all respects for claiming reservation under Defence sub-category” as per the Counselling Schedule at the respective Institute/ University.
- 3) It is mandatory for the candidates, belonging to above mentioned sub-categories, to get the documents verified in order to avail the benefits of the claimed subcategories and bonus points.
