Powers and Functions of the Standing Committee

- Subject to general control and directives of the General Council, the Standing Committee shall be responsible for the management and administration of the affairs of the institute in accordance with rules and bye-laws made thereunder for the furtherance of the objects and shall have all powers which may be necessary expedient for the purpose including:
 - (a) To carry out the broad policies and objects of the Institute as set out in the Memorandum of Association or as laid down by the General Council or in accordance with such directives as the Government of India may issue to the Institute.
 - (b) To sanction expenditure for carrying out the administration of the Institute in accordance with the budget estimates approved by the General Council.
 - (c) To invest the funds of the Institute
 - (d) To create such posts as are necessary to administer the Institute and recruit and appoint staff except that the prior approval of the Government of India shall be required for the appointment to the post of Director of the Institute.
- The Standing committee may delegate such powers as it considers appropriate to the Director or other officers of the Institute.
- The Standing Committee may make bye-laws for the conduct of the business of the Institute. These shall, however, be subject to the approval of the General council.
- Without prejudice to the generality of the preceding sub-rule, the bye-laws may be made about the following:-
 - (i) Rules for admission
 - (ii) Fees and other charges in respect of training imparted to students and in respect of treatment rendered to the patients
 - (iii) Wage structure of the workshop and pricing policy of the goods manufactured in the workshop of sale.
 - (iv) Management of funds.
 - (v) Service conditions of the staff.
- Provided that the Standing Committee may with the approval of the General Council, adopt
 Government of India Rules and /or Regulations regarding Service Conditions of the staff,
 with or without modifications as may be considered necessary. This power to adopt may be
 exercised for a specific period or on long-term basis.

- Provided further that till such time as bye-laws as contemplated in these Rules are actually made or adopted, rules and practices in respect of mattes specified above as were in force immediately prior to the registration of the Society shall remain operative and in force.
