MINUTES OF THE MEETING OF THE SCREENING COMMITTEE HELD ON 10th March, 2023 TO CONSIDER NEW PROJECT PROPOSALS FOR FINANCIAL YEAR 2022-23 UNDER DISTRICT DISABILITY REHABILITATION CENTRE (DDRC)

A meeting of the Screening Committee was held on 10th March, 2023 under the Chairpersonship of Shri Rajeev Sharma, Joint Secretary (DEPwD) to consider the new proposals of Implementing Agencies received through State Governments under District Disability Rehabilitation Centre (DDRC) for Financial Year 2021-22 and 2022-23.

2. The Committee was apprised of the guidelines of the Scheme. The Committee was informed that the new proposals which would be approved by it shall be considered for release of funds subject to fulfillment of all other terms & conditions of the scheme. Following deliberations were made by Screening Committee during scrutiny of new proposals:-

(i) The Committee discussed the parameters for keeping in mind while reviewing the proposals and recommending sanction. It should be obligatory upon all the organizations seeking grant-in-aid to submit a valid recognition/permission from concerned authority in the State Govt. and under PWD Act, 1995 or RPwD Act, 2016. Further, their staff and professionals should also conform to the requirements under the Scheme.

- ii. Those Implementing Agencies whose project have been recommended by the Screening Committee shall be intimated for immediate sending the audited accounts as per revised scheme norms effective from 01.04.2023 proposals for the year 2021-22 and 2022-23 for consideration of release of GIA.
- iii. Those organizations whose project cases have been recommended by the Screening Committee shall be got inspected first in order to ensure satisfactory functioning prior to consideration of any GIA.
- iv. Processing of already recommended new cases in the previous and current meeting should be taken on priority on receipt of requisite documents and State Govt. recommendations for the current year.
