2. Background

India is signatory to the UN Convention on the Rights of Persons with Disabilities (UNCPRD). Article 9 of UNCPRD casts an obligation on all the signatory governments to take appropriate measure to ensure to persons with disabilities access, on an equal basis with others to the physical environment, to transportation, to information and communications technologies and systems, and to other facilities and services open or provided to the public, both in urban and in rural areas.

With reference to the Right of Persons with Disabilities Act 2016, wherein it mandates that all establishments should ensure that all their buildings are accessible as per standards. The Department of Empowerment of Persons with Disabilities is the Nodal Department pertaining to disability affairs, working proactively towards mainstreaming and empowering Persons with Disabilities through the development of universally accessible ecosystems. In view of the growing demand for an inclusive, safe, and comfortable experience for Persons with Disabilities, ensuring incorporation of accessible features in the built environment is the need of the hour and for the same, accessibility at core is essential to be imparted in the minds of implementing agencies to ensure the universal accessibility.

For this purpose, to ensure all the establishment are accessible to all, the Department of Empowerment of Persons with Disabilities, Ministry of Social Justice & Empowerment, Government of India invites "Expression of Interest" from the NGOs/registered societies/trusts etc. to showcase their interest for the empanelment with this Department as "Accessibility Auditors in Built Environment". The interested entities may then send their organizational profile along with the details of qualification, relevant professional course which authorizes the NGOs/registered societies etc. to conduct accessibility audits in the built environment.

3. Aims & Objective

The core objective of empanelment of accessibility auditor is to cater the growing demand for an inclusive, safe and comfortable experience for all and especially Persons with Disabilities (PwD). It shall benefit to engage a high number access auditors across the nation as compared to the lakhs of buildings in the country. The EoI is floated with an idea to seek professional expertise available on this matter in the country both in terms of professional experience and educational background.

4. EOI processing fees

A non-refundable processing fee for Rs. 1,000/- (One Thousand Rupees only) in the form of a Demand draft or a Pay Order drawn in favour of "PAO, Ministry of Social Justice and Empowerment" Payable at New Delhi has to be submitted along with the EOI response. Bids received without or with inadequate EOI processing fees shall be liable to get rejected.

5. Venue & Deadline for submission of proposal

5.1 Proposal, in its complete form in all respects as specified in the EOI, must be submitted to DEPwD at the address specified herein earlier. In exceptional circumstances and at its discretion, DEPwD may extend the deadline for submission of proposals by issuing an amendment to be made available on the DEPwD website, in which case all rights and

obligations of DEPwD and the bidders previously subject to the original deadline will thereafter be subject to the deadline as extended.

6. Validity of offer:

The offer for EOI as per this document shall be valid for a period of three (3) months initially which may be extended further, if required.

7. Terms of Reference

- 7.1 At its discretion, DEPwD may also open the window of empanelment of more access auditors by the means of floating the EOI periodically during the financial year.
- 7.2 The validity of the empanelment shall be applicable upto 05 years from the date of issue of empanelment.
- 7.3 The work undertaken by the empanelled access auditors based on the empanelment with Govt. of India, needs to be shared in a form of accessibility report from time to time with this Department.
- 7.4 For the purpose of evaluation, DEPwD at its discretion may conduct random accessibility checks based on the report submitted by the access auditors without any prior information to the agency.
- 7.5 The empanelled agency's team of access auditors must comprise of persons with disabilities such as, wheelchair user, 100% blind, speech and hearing impaired while conducting the access audit. This is for the purpose of evaluating the existing situation of the built environment with the PwDs point of view and their ease of access at different location of the building/premise. This would also help to record their deliberations including key suggestions, highlighting the key challenges and missing accessibility features which may enhance their experience while accessing the built environment. Such PwDs may not necessarily be a full-time part of the empanelled access auditors' firm/agency/NGO/Trust/Society etc. but may be outsourced for the purpose of conducting access audit in the built environment.
- 7.6 The PwDs that shall be the part of access audit team must have the respective UDID cards with more than 40% benchmark disability.
- 7.7 The accessibility audit must be undertaken considering the latest accessibility guidelines notified in the Right of Persons with Disabilities, (Amendment) Rules, 2023 for various sectors.
- 7.8 The selected NGOs/institution/society/trust etc. shall be required to undertake a short course/training on universal accessibility in built environment as conducted by DEPwD before the issue of empanelment.

8. Instructions to bidders

- 8.1 The Expression of Interest is to be submitted in the manner prescribed below:-
- **8.2** All information as detailed below is to be submitted in two hard copies in separately sealed envelopes and one soft copy in pen drive:
 - a) Applicant's Expression of Interest as per Format-1.

 - c) Experience of the organization as per Format-3.

- d) List of three (03) experts/ consultants on payroll and other team composition as per Format-4.
- e) Financial strength of the company as per Format-5.
- f) Additional information as per Format-6.
- g) Declaration as per Format-7.
- h) Power of Attorney in favour of Authorized Signatory with long and short signatures of Authorized person.
- **8.3** EOI document have been hosted on the website https://disabilityaffairs.gov.in/ and may be downloaded from the website.
- **8.4** The bidders are expected to examine all instructions, forms, terms and other details in the EOI document carefully. Failure to furnish complete information as mentioned in the EOI document or submission of a proposal not substantially responsive to the EOI documents in every respect will be at the Bidder's risk and may result in rejection of the proposal.

9. Eligibility requirements: -

- a. Following will be the minimum pre-qualification criteria. Each eligible access auditors should possess all the following pre-qualification criteria. Responses not meeting the minimum pre-qualification criteria will be rejected and will not be evaluated. Screening of EOIs shall be carried out as per eligibility conditions mentioned in this document and based on verification of testimonials submitted.
- b. In addition to this, empanelment will be based on clearing the minimum eligibility criteria as mentioned in the table below. Further qualification to deliver the duties to perform services on ground will be subject to discretion to the buyer in case of the project.
- c. The assessment shall be a combination of both educational qualifications and on ground experience of the similar work undertaken in previous years.

10. Criteria of qualification

- d. EOI will be evaluated for short listing inter alia based on their past technical experience of handling similar type of project, educational background, strength of their man power, financial strength of firm and presentation / proposal to the selection committee whose decision will be final.
- e. Agencies who qualify as per the eligibility conditions will be provided a brief about the Accessibility India Campaign and Creation of Barrier Free Environment under SIPDA Scheme of the Department. The agencies may be required to make a presentation, if required, to a selection committee show-casing their proposals.
- f. DEPwD will take up references and reserves the right to pay due heed to the Bidder's performance elsewhere and any past experience from DEPwD.

11. Response:

- 11.1 Bidders must ensure that their Bid response is submitted as per the formats attached with this document. Special comments on the objectives and scope of the service projected in the enquiry may also be submitted along with the offer.
- 11.2 Application in sealed cover super scribed, as "EOI for providing services regarding accessibility audit under DEPwD"

12. Conflict of Interest

12.1 Where there is any indication that a conflict of interest exists or may arise, it shall be the responsibility of the Bidder to inform DEPwD, detailing the conflict in writing as an attachment to this Bid.

- 12.2 DEPwD will be the final arbiter in cases of potential conflicts of interest. Failure to notify DEPwD of any potential conflict of interest will invalidate any verbal or written agreement.
- **12.3** A Conflict of Interest is where a person who is involved in the procurement has or may be perceived to have a personal interest in ensuring that a particular Bidder is successful. Actual and potential conflicts of interest must be declared by a person involved in a Bid process.
