OFFICE MEMORANDUM

Subject:- Training Center validation under National Action Plan (NAP) for Skill Development of Persons with Disabilities under SIPDA – regd.

In continuation to this Department's O.M. of even number dated 20th June, 2019, notifying the Centre Guidelines in respect of National Action Plan (NAP) for Skill Training of Persons with Disabilities (PwDs) under Scheme for Implementation of Persons with Disabilities Act (SIPDA), 2016, the undersigned is directed to inform to all the concerned that in order to implement the centre guidelines, validation of training centres has been made mandatory by the Department before allocation of target to ETPs or allowing training at any centre. Accordingly, proposals of only those ETPs will be considered for allocation of the project / target of skill training under NAP whose Training Centres will be:

- a. Validated by the Department or an agency authorized by the Department for this purpose; or
- b. Having valid accreditation under SMART (Skill Management and Accreditation of Training Centres) of National Skill Development Corporation.
- 2. In this regard, it has further been decided to assign the task of audit and validation of the centres to Skill Council for Persons with Disabilities (SCPwD). The Council has agreed for the centre audit as per the rates mentioned below:

Description of Work- related to Centre Audit	Centres of the Organizations under administrative control of DEPwD (MSJE)	Profit making	Centres of all other ETPs whether Private or Government
Per Training Centre for first sector	0	Rs. 5,000/-	Rs. 10,000/-
For each additional sector	0	Rs. 2,500/-	Rs. 5,000/-

- 3. Criteria of centre audit / validation will be as per the centre guidelines notified by the Department vide O.M. dated 20th June, 2019. All the Organizations empanelled as Training Partner (ETP) with the Department are advised to prepare their centers (presently not having valid SMART accreditation) as per centre guidelines and get them audited / validated from SCPwD. The ETPs having centres with SMART accreditation may send the details of their centres to the Department in prescribed proforma Self Assessment Report- annexed with Centre Guidelines of the Department.
- 4. Expenditure on account of centre audit and validation through SCPwD will be borne by the ETPs. The ETPs are requested to co-ordinate with SCPwD about readiness of their training centers for validation under intimation to this Department and pay the fee directly to SCPwD as per the rates mentioned in the table at para 2 above.
