CIRCULAR

RECRUITMENT TO THE POST OF CHIEF COMMISSIONER FOR PERSONS WITH DISABILITIES UNDER THE DEPARTMENT OF EMPOWERMENT OF PERSONS WITH DISABILITES, MINISTRY OF SOCIAL JUSTICE & EMPOWERMENT.

Applications are invited for the post of Chief Commissioner for Persons with Disabilities, Department of Empowerment of Persons with Disabilities under the Ministry of Social Justice & Empowerment, Government of India.

1 NAME OF THE POST: Chief Commissioner for Persons with Disabilities.

2. <u>HEADQUARTERS</u>: New Delhi.

3. <u>PAY SCALE</u>: Pay scale and allowances as admissible to the Secretary to the Government of India. The pay scale

and present pay is Rs. 2,25,000/- per month (fixed) as

per 7th Central Pay Commission dispensation.

Where a Chief Commissioner being a retired Government servant or a serving employee of any institution or autonomous body funded by the Government, is in receipt of pension in respect of such previous service, the salary, admissible to him under these rules shall be reduced by the amount of the pension, and if he had received in lieu of a portion of the pension, the commuted value thereof, by the amount of such commuted portion of the pension.

4. AGE LIMIT: Not exceeding 60 years as on 01.01.2020 subject to provision mentioned at SI. No. 8 hereunder.

5. EDUCATIONAL QUALIFICATION:

I. Essential: Graduation from a recognized university.

II. Desirable: Preference shall be given to persons having recognized degree or diploma in social work or law or management or human rights or rehabilitation or, education of persons with disabilities.

6. EXPERIENCE:

Should have experience of at least twenty-five years in a Group "A" level post in the Central Government or a State Government or a public sector undertaking or a semi-Government or an autonomous body dealing with disability related matters or social sector or as a senior level functionary in registered national and international voluntary organizations in the field of disability or social development:

Provided that out of the total of twenty five years of experience, he/ she should have at least three years of experience in the field of rehabilitation or empowerment of persons with disabilities.

7. <u>MODE OF RECRUITMENT</u>:

The mode of recruitment to the post of Chief Commissioner for Persons with Disabilities is by Direct Appointment for all categories of persons. If he is in the service under the Central Government or State Government, he shall seek retirement from such service before his appointment to the post.

8. TERM OF THE OFFICE OF CHIEF COMMISSIONER:

- a. The term of the office of Chief Commissioner shall be for a period of three years from the date on which he assumes office, or till he attains the age of sixty five years, whichever is earlier.
- b. A person may serve as Chief Commissioner for a maximum period of two terms subject to the condition that he has not attained the age of sixty five years.

9. POWERS DUTIES AND FUNCTIONS OF THE CHIEF COMMISSIONER:

The powers, duties and functions shall be as laid down in Rights of Persons with Disabilities Act, 2016 and / or Rules framed thereunder as amended time to time.

10. OTHER TERMS AND CONDITIONS OF SERVICE OF THE CHIEF COMMISSIONER:

(i) LEAVE:

The Chief Commissioner shall be entitled to such leave as is admissible to Government servants under the Central Civil Services (Leave) Rules, 1972.

(2) LEAVE TRAVEL CONCESSION

The Chief Commissioner shall be entitled to such Leave Travel Concession as admissible to the Group 'A' officers of equivalent level under Central Civil Services (Leave Travel Concession) Rules, 1988.

(3) The Chief Commissioner shall be entitled to such medical benefits as admissible to the Group 'A' officers of equivalent level under Central Government Health Schemes.

11. RESIDUARY PROVISIONS:

Condition of service of the Chief Commissioner, in respect of which no express provision has been made in these rules and orders for the time being, is the same, as applicable to a Secretary to the Government of India.
