Minutes of the third meeting of the Governing Body of the National Fund for Persons with Disabilities, held on 12th September, 2019 at 11:30 AM in the Conference Room, 5th Floor, Antyodaya Bhawan, CGO Complex, Lodhi Road, New Delhi.

List of participants is at **Annexure- I**.

Ms. Shakuntala D. Gamlin, Secretary, DEPwD, while welcoming the participants stated that last meeting of the Governing Body was held on 30th July 2018. Meanwhile, the Department has taken steps to implement the scheme framed under it. She requested Dr. Prabodh Seth, Joint Secretary, DEPwD to briefly explain the agenda points for consideration of the Governing Body.

2. Dr Prabodh Seth, Joint Secretary, DEPwD stated that since inception of the National Fund for Persons with Disabilities, two meetings of Governing Body were held on 09.01.2018 and 30.07.2019. In between, National Fund has been registered under Section 12A of the Income Tax Act and PAN (No: AACTN8946J) & TAN(No: DELN18701E) have also been obtained. He also stated that the Department has received proposals from individuals and organisations seeking financial assistance under the scheme of National Fund for organising exhibitions and participation in international events. These were scrutinized by Screening Committee in its meeting held on 15.01.2019, which recommended three proposals for financial assistance. The Governing Body would like to consider these proposals for release of fund. The Governing Body would also need to consider extending engagement of the existing auditor for another period of one year and extension of existing staff of the Fund.

	As regards bills submitted by the agency towards processing of various cases such as scrutiny, accounting and appeal cases in respect of the erstwhile two funds including CIT (appeal) cases, the Governing Body decided that these Bills may be processed based on activities in each case separately. The Governing Body authorized Secretary, DEPwD to decide release of fund to the agency in such cases accordingly.
Agenda Point No 6: Release of TA to the participants and their escorts for attending National IT Challenge for Youth with Disabilities held in NIT Kurukshetra during 25 -26 July 2019.	Governing Body noted the fact that though national IT Challenge organized by NIT, Kurushetra is supported under Awareness Generation Programme of the Department, TA is not paid to the participating PwDs and their escorts. The Governing Body approved the proposal of reimbursement of Travel Allowances to the participants of the National IT Challenge (NITC) for youth with disabilities held during 25-

Agenda Point No 7: Opening of Bank Account of National Fund at SBI Shastri Bhawan.	26 July 2019, and to one escort/parent each. Total estimated amount of release as approved by Governing Body in this regard is Rs 12.00 Lakh The Governing Body passed a Resolution for opening of the new Savings Bank Account in the name of National Fund for Persons with Disabilities at SBI Shastri Bhawan, New Delhi. It also authorized JS & CEO to be the signing authority for transaction of this Account. It was decided to nominate Shri K.V.S. Rao, Director and Shri Vikash Prasad, Director to act as authorized signatories on cheques and for other similar account transaction purposes. The Governing Body further authorized JS & CEO to designate Directors or Deputy Secretary Level Officers to act as signing authority in place of the above two nominated officers as and when necessary. Copy of the Resolution signed by the Members of the Governing Body is at Annexure III.
Agenda Point No 8: Consideration of New Proposals	Governing Body noted that new proposals have been received in the Department seeking financial assistance under the National Fund and suggested that these proposals may be placed before the screening committee for its consideration at the earliest. The Governing Body authorised Secretary, DEPwD to approve the proposals for release of funds to individuals/ Organisations based on the recommendations of the Screening Committee. In such cases, ex- post-facto approval of Governing Body may be taken in its immediate next meeting.
Any other Item	 Governing Body noted current fund position as under: Fixed Deposit - Rs 251,02,52,185/- where value on maturity will be Rs 266,36,55,828/- by September 2019. Saving Bank Accounts - Rs 5,23,66,143/- The Governing Body Noted that Income Tax Department has directly debited Rs 19,62,05,793/- from Saving Bank Account of erstwhile Trust Fund at SBI Shastri Bhawan towards outstanding demand from AY 2016 - 17.
