Deaf/ relevant area in Rehabilitation of Disabilities or Master's degree in any subject with a Certificate or Diploma in teaching the deaf from a recognized University/Institution with 55% marks or equivalent grade, if such marks or grades are awarded.

## (C) Desirable qualifications/requirements:-

- (i) Ph.D in the related area.
- (ii) Experience of Research, Publication in National and International Journals in the field of Rehabilitation of the Speech and Hearing disability.
