MINUTES OF THE MEETING OF THE SCREENING COMMITTEE HELD ON 3rd November, 2021

TO CONSIDER NEW PROJECT PROPOSALS FOR FINANCIAL YEAR 2020-21 UNDER

DEENDAYAL DISABLED REHABILITATION SCHEME (DDRS)

A meeting of the Screening Committee was held on 3rd November, 2021 under the Chairpersonship of Ms. Tarika Roy, Joint Secretary (DEPwD) to consider the new proposals of NGOs received through State Governments under Deendayal Disabled Rehabilitation Scheme (DDRS) for Financial Year 2020-21. One of the members of the Screening Committee Shri Subhash Joshi (Paliwal) attended the meeting through Video Conferencing and other member Mrs. Sushma Gupta attended the meeting in person. The entire Programme Division including Director Shri. Vikash Prasad and Under Secretary Shri. Md. Marazuddin assisted the Screening Committee.

- 2. The Screening Committee was informed that as per para 3.6.1.6 of DDRS Scheme-guidelines, the proposals duly recommended by the State Govt. were required to be considered by this Committee. A comprehensive statement (Annexure-I) containing state-wise number of model-projects across the country was presented to the Committee. The statement giving an overall picture of pan-India coverage of the 518 model projects under DDRS was reviewed.
- 3. The Committee was apprised of the guidelines of the Scheme as well as the proposed changes envisaged in the scheme the EFC, which will be applicable if approved from FY 2022-23.
- 4. The Committee was informed that the new proposals which would be approved by it shall be considered for release of funds subject to fulfillment of all other terms & conditions of the scheme. Following deliberations were made by Screening Committee during scrutiny of new proposals:-
 - (i) The Committee discussed the parameters for keeping in mind while reviewing the proposals and recommending sanction. It should be obligatory upon all the organizations seeking grant-in-aid to submit a valid recognition/permission from concerned authority in the State Govt. and under PWD Act, 1995 or RPwD Act, 2016. Further, their teaching staff and professionals should also in conform to the requirements under the Scheme.
 - (ii) The over-all scenario of the pan-India coverage of the various model projects of DDRS was reviewed. It has been felt that there would be budget constraints if more and more new organizations in the same district, especially of the similar model projects are included. The cost norms of the projects under DDRS have been enhanced by 2.5 times the earlier rates with effect from 1st April, 2018 which means that fewer NGOs can be supported as compared to earlier. Further, under NITI Aayog's Output-Outcome Monitoring Framework (OOMF), emphasis is to be given to expand the outreach of this scheme in every district of the country to ensure pan India coverage. This will lead to optimal utilization of funds for the intended purposes and will benefit beneficiaries of all the States/UTs. Hence, considering the objective of Pan-India coverage within the availability of limited budget, districts where NGOs are being given support through the DDRS scheme should preferably not be covered while considering new applications in those districts so that more districts can be covered across India through this scheme.
 - (iii) Expenditure Finance Committee has reduced budget to Rs. 650.00 crore as against proposed 761.00 crore for the period from FY 2021-22 to 2025-26 leading to

restrictions in adding new projects under DDRS. Emphasis is on adding more new projects in DDRC.

- (iv) Those organization whose projects have been recommended by the Screening Committee shall be intimated for immediately sending the proposals for the year 2021-22 for consideration of release of GIA.
- (v) Those organizations whose project cases have been recommended by the Screening Committee shall be got inspected first in order to ensure satisfactory functioning prior to consideration of any GIA.
- (vi) Processing of already recommended new cases in the previous and current meeting should be taken on priority on receipt of requisite documents and State Govt. recommendations for the current year.
- (vii) The NGOs recommended herein should be verified and checked with updated list of NGOs/voluntary organizations blacklisted/debarred/banned by any other Department of Govt. of India.
- (viii) Recommendations of this Committee will be valid till the end of financial year subsequent to the year in which the meeting is held i.e. since the meeting is held during 2021-22, the recommendations will remain valid till 31.03.2023.
- 4. The proposals considered by the Screening Committee along with its recommendation/remarks are contained in <u>Annexure-II</u>. In all, 48 proposals pertaining to the year 2020-21 were taken up for consideration by the Screening Committee. Out of these 48 cases the decision of the Screening Committee is as under:
 - a) 08 cases were recommended
 - b) 40 cases were not recommended
