**Subject: Submission of applications for skill development of Persons with Disabilities through PM - DAKSH - DEPwD Portal - reg.**

Ma'am/Sir,

As you are aware that the Department of Empowerment of Persons with Disabilities (DEPwD) implements a "National Action Plan (NAP) for Skill Development of Persons with Disabilities (PwDs)" which was launched in March, 2015. NAP is implemented under the umbrella scheme – “**Scheme for Implementation of Rights of Persons with Disabilities Act (SIPDA)**” as per the Common Norms guidelines of M/o Skill Development and Entrepreneurship (MSDE). It is a Central Sector Scheme implemented across the country under which training programme is conducted via a network of training partners (ETPs) empanelled from Government (GOs) and Non-Government Organizations (NGOs) as well as organizations of the Department such as National Handicapped Finance and Development Corporation (NHFDC), National Institutes (NIs) and Composite Regional Centres (CRCs).

2. The Department has recently developed an online portal ‘**PM-DAKSH**’ for submission of applications for the National Action Plan for Skill Development of PwDs and for implementation of the scheme. The PM -DAKSH portal shall provide end-to-end facilities for PwDs like Unique Disability Identity (UDID) based seamless registration, enrolling in skill training out of a list of 250+ courses, exploring ETPs in their State/District providing skill training, access to study materials, as well as detailed information on the trainers/Empanelled Training Partners (ETPs). 3. *The details of information to be captured in EOI application and PSP are enclosed herewith for your kind reference.*

4. *The process of on-boarding the organization on PM-DAKSH*

**portal is as follows:**

Visit the PM-DAKSH portal (viz. <https://www.pmdaksh.depwd.gov.in>) → Click on Register Tab → Click on Training Organizations → Fill all required fields → click on Register → Login details received on registered e-mail → Click on login tab on home page → Login with user ID and password → apply for EOI Tab → fill all required details → submit → click on apply for PSP → Fill all required fields and Submit.

5. The Department has approved the Project Specific Proposal (PSP) of the above ETPs/NIs/CRCs/SHI schools recently in which the targets have been assigned.

6. In view of the above, in case the above ETPs/NIs/CRCs are interested for future association with this Department for skill training, the ETPs/NIs/CRCs are required to get empanelled with the Department for skilling of PwDs and apply the EOI application as well as the Project Specific Proposal (PSP) through **PM-DAKSH - DEPwD portal** viz. <https://www.pmdaksh.depwd.gov.in> so that the intended organizations can be on-boarded on PM-DAKSH portal and skill training of PwDs can be imparted through this portal.
