<u>ORDER</u>

<u>Subject: Shivam Foundation Samiti, Bhopal, Madhya Pradesh -- Blacklisting of</u> <u>the organization regarding</u>

Whereas, the Organization named Shivam Foundation Samiti, Bhopal, Madhya Pradesh was empanelled by this Department as an Empanelled Training Partner (ETP) for Skill training of PwDs under National Action Plan under SIPDA on 04.07.2016.

- 2. Whereas, considering Project Specific Proposal of Shivam Foundation Samiti received on 01-08-2016, this Department issued an Offer Letter dated 21.02.2017 to the ETP for conducting skill training of 450 PwDs in 7 trades and the organization vide letter no. Reg.No.27137Dated08/01/1996 dated 01.03.2017 submitted its acceptance of all the terms and conditions as contained in Offer Letter.
- 3. Whereas, this Department released 1^{st} installment of Rs.17,93,227/- on 25.03.2017 to the organization towards 30% of total estimated cost for starting the skill training program for 450 PwDs.
- 4. Whereas, the organization consented to adhere to all the terms & conditions of Grant-in-Aid as well as guidelines of Common Norms which inter-alia included:
 - Acceptance Letter of this Department's Offer Letter which inter-alia seeks the proposed date of commencement and completion of the project by organization.
 - O Submission of documents such as list of PwDs trainees for each batch separately within one week of the start of the trainees including their address, bank details, %age of disability, mobile number etc.
 - Submission of documents such as disability certificates, Aadhar card, Bank Passbook/ statement of all the trainees.
 - o The organization will abide by the conditions for grant-in-aid as provided in

the scheme.

- That organization will not change the place of training location without the prior approval of DEPwD in writing.
- o That organization would submit Monthly Progress report on the project.
- o In case of training partner has furnished any false information/document and is established as false, it will be debarred from the benefit and an action will be initiated for recovery of the amount spent with an interest of 10% p.a. Such training organization will also be black-listed for future and appropriate legal action can be taken against them.
- 5. Whereas, in reply to this Department's Offer Letter, organization indicated in their acceptance letter dated 01.03.2017 to commence training as soon as possible to start the training and completed the project after receiving the $1^{\rm st}$ installment.
- 6. Whereas, status report on skill training was sought by this Department's vide several letters issued from time and time but no response received from ETP.
- 7. Whereas, ETP failed to submit periodic status of training, beneficiaries details/ list and any other document mentioned at Para 4 above.
- 8. Whereas, considering no response from the organization, Department had issued a "Show Cause Notice" on 10.04.2012, as to why action may not be taken for negligence, non-adherence to terms & conditions of grant-in-aid & guidelines of NAP under SIPDA and lack of sincerity.
- 9. Whereas, no reply was received in response to Show Cause Notice also, Shivam Foundation, Madhya Pradesh, vide a final show cause notice dated 09.06.2022, was again directed to submit the documents for consideration of 2^{nd} & 3^{rd} Installment of grant and failing which it will presume that organization has nothing to submit in this regard and a decision based on information available will be taken. Still, ETP has not sent any reply to the department's letter.
- 10. Whereas, the above stated facts clearly reflect negligence, non-adherence to the terms & conditions of Grant-In-Aid & guidelines of National Action Plan under SIPDA and lack of sincerity on the part of "Shivam Foundation Samiti".
- 11. Thus, in the matter of utilization of grant-in-aid released during 2016-17, Shivam Foundation Samiti failed to submit the utilization certificate of GIA released and other documents of the PwDs even after giving sufficient opportunities by the Department.
- 12. Now, taking into consideration all the above mentioned facts, it has been decided by the competent authority in public interest, to blacklist the organization namely,

Shivam Foundation Samiti, Bhopal, Madhya Pradesh for further financial assistance under various schemes of this Ministry and initiating action for recovery of entire amount of grant-in-aid along with penal interest @10% from the date of receipt of grant-in-aid of Rs. 17,93,227/- (Rupees Seventeen Lakh Ninety Three Thousand Two Hundred Twenty Seven only).
