## Scheme of Assistance to Disabled Persons for Purchase/Fitting of Aids/Appliances (ADIP Scheme)

The ADIP Scheme has been in operation since 1981. The Scheme was last revised w.e.f. 01.04.2022.

#### **Objectives:**

To provide durable, modern and scientifically manufactured aids and assistive devices to PwDs for promoting their physical, social and psychological rehabilitation, thereby reducing the effects of disabilities and enhancing their educational and economic potential.

## **Eligibility of Beneficiaries:**

- i. An Indian citizen of any age.
- ii. Holding at least 40% disability (Benchmark disability). In case of Motorised Tricycle/Motorised Wheelchair and High end Prosthesis at least 80% disability certificate is required.
- iii. Having monthly income from all sources not exceeding Rs.30,000/- per month.
- iv. In case of dependents, the income of parents/guardians not exceeding Rs. 30,000/- per month.
- v. Not having received assistance during the last 3 years for the same purpose from any source. However, for children below 12 years of age, the minimum time of assistance is one year.

## **Quantum of Assistance**

For aids/ appliances costing upto Rs. 15000/- - Full subsidy

For aids/ appliances costing from Rs. 15001/- to

Rs. 30000/- - Subsidy 50% or upto Rs. 15000/-

For aids/appliances costing above Rs. 30001/- - GOI shall bear 50% of cost and remainder shall be

contribute by State or Implementing agency or

beneficiary

#### **Income criteria**

Upto Rs. 22,500/- per month - Full cost of aid/appliance

Rs.22,501/- to Rs. 30,000/- per month - 50% of the cost of aid/appliance

- Cochlear Implant:- Cost ceiling of Cochlear Implant Rs.7.00 Lakh for children with pre-lingual hearing loss between 1 to 5 years of age and Rs.6.00 Lakh in case of children with acquired hearing loss between 5 to 18 years.
- Motorized/Wheelchair and Tricycle:- Motorized Tricycles/ Wheelchair are provided to persons having at least 80% locomotor disability. This is provided to persons aged 16 years and above, once in 5 years. Extent of subsidy is upto Rs.50,000/-. Person having mental impairment shall not be eligible.
- ➤ **High End Prosthesis:** High end Prosthesis to persons with disability having at least 80% disability. Extent of subsidy would be Rs.30,000/-. Provided once in five years.

## **Implementing Agencies**

- ✓ Societies registered under act 1860, Registered charitable trusts
- ✓ IRCS and other Autonomous Bodies headed by District Collector. Chief Executive Officer/District Development Officer
- ✓ NIs/CRCs/RCs/DDRCs/National Trust/ALIMCO/ National/State Handicapped Development Corporations
- ✓ Local Bodies, Hospitals
- ✓ Nehru Yuva Kendras
- ✓ Any other organization as deemed fit by the DEPwDs.

## The funds under the ADIP Scheme are utilized for the following purposes:-

- > <u>Camp Activities</u>/ <u>District-wise Camps</u> -Financial assistance is released for holding camps by the Implementing Agencies at the district level for distribution of aids and assistive devices.
- ➤ <u>Headquarter activity</u>- Financial assistance is provided to ALIMCO, National Institutes, Composite Regional Centres (CRCs) and some well established Non Governmental Organizations (NGOs) to provide aids and assistive devices to eligible beneficiaries at their headquarters.
- > <u>Special Camps</u>- Special camps are held by the Ministry through ALIMCO/National Institutes, on the requests received from Members of Parliament and other dignitaries.
- ➤ <u>ADIP-SSA( Samagra Shiksha Abhiyan)</u>-Aids and assistive devices are distributed by ALIMCO to the Children with Special Needs (CWSN) below 18 years of age and attending school. For which 60% of funds are contributed by the Department under ADIP Scheme and 40% by Ministry of Education under their Scheme of Samagra Shiksha Abhiyan (SSA).
- Registration of beneficiaries online Mode- Registration of beneficiaries is also being done through ARJUN PORTAL (ADIP MIS portal-www. adip.disabilityaffairs.gov.in). Beneficiaries are now may register themselves directly by login on the MIS portal for requisite aids and appliance and can also make request for repair/replacement of already received item.
