**Minutes of the 6th Meeting of Central Advisory Board on disability held on
27.12.2023.**

2. The 6th meeting of Central Advisory Board on disability started with National Anthem followed by lighting of lamp by the dignitaries.

3. Shri Rajesh Aggarwal, Secretary, DEPwD welcomed Dr. Virendra Kumar , Hon'ble Union Minister for Social Justice and Empowerment cum-Chairperson of the Central Advisory Board. He also welcomed other members of the Board including Hon'ble Ministers from Goa, Odisha, Tamil Nadu and Uttar Pradesh, representatives from various Central Ministries/Departments/organizations and non-official members.

4. In his introductory remarks, the Secretary highlighted the significance of inclusive education, special education, vocational training, and initiatives in the health and pharmaceutical sectors for overall rehabilitation of PwDs. He elaborated on the ongoing efforts led by the State of Odisha, particularly in early intervention through Aanganwadi workers. The Secretary emphasized the anticipation of comprehensive discussions encompassing a spectrum of topics, including disability pension schemes and the dissemination of best practices across diverse sectors. Moreover, he highlighted the priority of soliciting insights from the Board members and engaging in practical discussions concerning entrepreneurship, customized courses for Persons with Disabilities (PwDs), and employment opportunities for PwDs. Attention was also drawn towards various aspects of life, such as tourism, entertainment, religious tourism, and sports, which necessitate inclusion in mainstream discourse and action. A special reference was made to the upcoming Purple Fest scheduled to take place in Goa, coinciding with the presence of the Goa Minister at the Board meeting. Emphasizing the potential of such events, the Secretary underscored their capacity to provide opportunities for individuals with disabilities to showcase their talents, concurrently fostering broader awareness about persons with disabilities and their role in society.

5. Dr. Virendra Kumar, the Honorable Minister for Social Justice and Empowerment, extended a warm welcome to the Honorable Ministers representing various States/UTs and expressed appreciation for the efforts

dedicated to the empowerment of Persons with Disabilities by various States/UTs. Additionally, he highlighted the role of Central Advisory Board meetings in fostering inspiration among other States and Union Territories and serve as a platform for sharing exemplary practices showcased by different States/UTs, providing an invaluable opportunity for learning and implementing similar initiatives in their respective jurisdictions by other States/UTs. Emphasizing the forward-looking approach of the Honorable Prime Minister's vision - "Sabka Saath, Sabka Vikas, Sabka Vishwas, aur Sabka Prayas," the Honorable Minister for Social Justice and Empowerment further discussed the vision for 2047, aiming to make India Aatmanirbhar (self-reliant). He highlighted the imperative need for sincere efforts to empower Persons with Disabilities, enabling their active participation in social services, which, in turn, will contribute to the country's promising future. Further highlighting that, he deliberated on importance of the employment opportunities which open doors towards realizing empowerment, the Minister emphasized that "Karmaveer" Divyangjan would not only foster development of nation but also support oneself and their families. He also urged that states need to further boost their efforts towards implementing the provisions of the Rights of Persons with Disabilities Act, 2016 by referring to "Pathways to Access". Further, underscoring the importance of Central Advisory Board meeting, Hon'ble Minister emphasized upon bringing together all stakeholders to share best practices which can be replicated across states for empowerment of persons with disabilities. He stated that persons with disabilities being important stakeholder towards nation building are going to play pivotal role in accelerating towards Atmanirbhar Bharat@ 2047. Furthermore, HMSJE set the tone of the meeting by highlighting key concerns which need to be brought into action at earliest which are as follows;

- All provisions of the Right of Persons with Disabilities Act, 2016 (RPwD Act, 2016) should be considered by all stakeholders/States/UTs/Ministries etc.
- Unsatisfactory work report from various States/UTs despite of granting the extension to complete the retrofitting of the buildings within a period of 5 years as per the act.
- Generation of UDID cards needs to be expedited; as on date more than 1 Cr UDID cards have been generated. States/UTs should consider this on priority.

- Unsatisfactory performance recorded by various States/UTs in claiming the benefits of DDRS/DDRC scheme etc.

6. The following agenda items were placed for discussion for the Central Advisory Board:-

- vi. Status of implementation of the UDID project including linkage of UDID to various schemes and programmes of Central Ministries/Departments and States/UTs.
- vii. Review of the major Schemes/Programmes of the Department.
- viii. Review of the National Institutes under Department.
- ix. Organizing 'Purple Fest' by all States/UTs on annual basis for inclusion and empowerment of persons with disabilities.

- xii. Use of the provision of 'Biometric Exception' for Aadhaar Card in case of such PwDs who are unable to provide their finger prints.

7. Shri Rajesh Yadav, Joint Secretary, DEPwD and Member-Secretary of the Central Advisory Board made a brief presentation on each of the above agenda points for deliberations of the Central Advisory Board. A copy of the presentation is at **Annexure II**.

8. Gist of submissions made by Members of the Board are as under:

i. Shri. Ashok Chandra Panda, Hon'ble Minister for Social Security and Empowerment of Persons with Disabilities, Odisha

Providing insights into the proactive measures undertaken by the State of Odisha in alignment with the agenda items, Shri. Ashok Chandra Panda, Hon'ble Minister offered a comprehensive overview. He emphasized the State's commitment to empowerment through their State institute for Persons with Disabilities, detailing the array of services offered. Notably, Odisha currently has 08 District Disability Rehabilitation Centers (DDRCs) and expressed a readiness to establish additional DDRCs within the state.

Drawing attention to the noteworthy Purple Fest held in Bhubaneswar, the Hon'ble Minister highlighted the State's dedication for creating inclusive and engaging events. Furthermore, he highlighted the effective distribution of disability pension to persons with disabilities within the state, ensuring accessibility and support.

In a plea to the Board, the Hon'ble Minister sought increased sports opportunities for Persons with Disabilities in Odisha, emphasizing the transformative impact such initiatives can have on the community's well-being and inclusion.

ii. Subhash Phal Desai, Hon'ble Minister of State Welfare, Goa.

Affirming their commitment to being a leading state in providing facilities to Persons with Disabilities, the Hon'ble Minister of State Welfare, Goa, described the steps undertaken by them in this regard. The Hon'ble Minister expressed enthusiasm about the upcoming Purple Fest scheduled from 8th to 13th January in Goa and highlighted the inclusive and vibrant nature of the event.

Hon'ble Minister from Goa expressed concern over obstacles such as a shortage of doctors, inadequate health support, difficulty in availing the Unique Disability ID (UDID) etc.

Further, the Hon'ble Minister requested the CAB to explore the idea of matchmaking of persons with disabilities based upon available skill set in the employment sector. It was further requested that wider public awareness could be brought in through introduction of dedicated broadcasting channel for persons with disabilities on television networks.

iii. Dr. M. Mathiventhan, Hon'ble Minister of Forest, Tamil Nadu

The Hon'ble Minister highlighted the establishment of a dedicated directorate for the welfare of Persons with Disabilities (PwDs) in 1993, showcasing the state's long-standing commitment to inclusive policies. With a State fund budget of Rs. 10 crore, Tamil Nadu has implemented various initiatives, including special courts for PwDs and a monthly provision of Rs. 2000/- benefitting approximately 2.3 lakh beneficiaries. Additionally, a disability pension of Rs. 1,500/- per month has been extended to support 1.5 lakh PwDs.

The State has identified 23 categories of assistive devices and established a Welfare Board with 11 lakh registered PwDs. Notable initiatives include 100% travel concession for PwDs on government buses, scholarships spanning from primary to postgraduate levels, and the distribution of grocery kits during the pandemic and recent flood crisis in Tamil Nadu. The Minister brought attention to the "Rights" project funded by World Bank, focusing on doorstep delivery of rehabilitation and welfare services.

The Hon'ble Minister requested support from the Board, mainly sought grants under the Accessible India Campaign (AIC) for 17 government buildings. Additionally, appeals were made for the inclusion of remaining beneficiaries under the Indira Gandhi Pension Scheme, allocation of funds for awareness generation programs, and ensuring the timely release of grants-in-aid to NGOs under the Deendayal Disabled Rehabilitation Scheme (DDRS). The Hon'ble Minister raised concerns about the challenges faced by NGOs due to the consistently unavailable E-Anudaan portal, leading to a request for the central government to accept offline proposals.

iv. Shri. Narendra Kashap, Hon'ble Minister of State, U.P.

Highlighting the initiatives taken by the State towards empowerment of persons with disabilities, Hon'ble Minister conveyed that a State Advisory Board on disability has been established in the State. Further, it was brought to the notice of the Board that the State was in the process of initiating Sugamya Bharat Abhiyan in three phases with a view to make the public infrastructure accessible for the Divyangjan. The Hon'ble Minister also informed about other measures taken by the State towards empowerment of Divyangjan which included multiple sittings of the Disability Assessment

Board, establishment of Kaushal Vikas Yojana Kendras for imparting vocational training to persons with disabilities, identification of posts for persons with disabilities in State Government establishments, an artificial limb centre in Shakuntala Mishra University, education centres with residential facilities, operations of two higher educational institutions specializing in services for persons with disabilities and provision of disability pension. The minister requested the Board to catalyze the process of releasing pending funds to expedite the state's endeavour towards empowerment of persons with disabilities. Further the State showcased its interest in hosting a fest in line with Purple fest being organized by the Govt. of Goa.

v. RCI chairperson highlighted the poor quality of professionals for which States/UTs needs to showcase a joint effort and help to procure the services of good professionals in this sector. Moreover, inclusive education in State Board should be made mandatory and syllabus including the disability should be taught.

vi. Suggestions made by other Members representing States/UTs and Central Ministries/Departments are as under:

- Talent hunt events may be organized as part of Purple Festival.
- Placing of orders outside GEMS Portal may be permitted to expedite the process of procurement and distribution of assistive devices to persons with disabilities.
- Linking of UDID with Railway Concession Passes so as to avoid multiple layers of passes and permission.
- Financial Assistance may be provided by the Central Government for establishing a Group Home.
- Ayushman Bharat Cards may be linked with UDID Cards.
- Early identification of children with disabilities may be expedited by introducing initiatives to involve medical interns in process of screening in addition to further capacity building of ANMs and ASHA Workers.
- State Government of Meghalaya informed the Central Advisory Board about implementation of “MegAbility” App launched for persons with disabilities.

- Further, suggested that job opportunities for rehabilitation professionals may be encouraged closer to their domicile states.
 - Introduction of the idea of inclusivity in early years of education for all children.
 - For economic empowerment, the role market relevant to skill development in addition to giving effective visibility to the talents of persons with disabilities.
 - Introduction of the post of nodal officer for implementation of Rights of Persons with Disabilities Act, 2016 in every government office.
 - States may be encouraged to perform effective needs assessment exercises and put forth their demands for skilled rehabilitation professional.
 - An untapped market for assistive devices worth 87,000 crores in the neighboring countries to India may be explored
 - The need to introduce effective regulatory practices to produce assistive devices of global standards.
 - The effectiveness of innovation, industry, research and funding to project India as global player in production, distribution, maintenance, repair and overhaul (MRO) practices in the assistive devices industry.
 - Training of DDRS/C staff should be done in National Institutes.
- vii. Furthermore, following submissions/suggestions were made by nominated members during the Board meeting:
- The creation of accessible build toilets in rural areas/slums for PwDs.
 - Diversifying the establishment of DDRCs among organizations.
 - Free coaching schemes should be explored.
 - There is a substantial lack of awareness about NI/CRCs to State officials.
 - To amplify the awareness programs about National Trust schemes.
 - Providing training to mothers of children with Hearing impairment and converting them into rehabilitation professionals.

- Provision for Compulsory Screening of hearing in Newborns (Universal Neonatal Screening).
- Need for enhanced awareness and increased publicity of UDID cards in rural areas.
- The provision of lift and escalator facility in Railways needs to be ensured considering the massive footfall of various categories of people at railway stations.
- Urgent need to address the improper and poor condition of toilets for PwDs in Railways.
- An effective monitoring of CRCs needs to be established.
- Collaboration between various sectors/NGO etc. should be explored in various sectors with the Govt. of India.
- More usage of technological devices and development of the same needs to be explored.
- Professional studies should be included in the UGC syllabus for the students to create a general awareness about the disability sector.
- Research in divyang friendly technology should be facilitated.
- A lot of work should be done in creating awareness and sensitization of RPwD, Act followed with the sensitization of bureaucrats and judicial services.
- Employment Opportunities through developing an application based program which incorporate profile based skill set and job matching.
- Creation of a livelihood opportunity based upon locally relevant skills and resources should be explored.
- ESIC reimbursement schemes should be restarted.
- Aadhar biometric which includes eyes and facial recognition should be considered.
- Appointing IAS Divyangjans as brand ambassadors and icons so as to inspire more PwDs.
- CSR funding for creation of small scale employment for PwDs may be explored such as a small business over a tricycle etc.

- Promoting insurance for Divyangjans, particularly at birth and proposed the establishment of a separate ministry
- Implementation of a self-employment scheme for Divyangjans, along with the establishment of a protection cell and ensuring clean washrooms.

9. After detailed deliberations, agenda wise recommendations of the Central Advisory Boards are as under:-

Agenda item 1(A): Confirmation of the Minutes of the last meeting of Central Advisory Board held on 24.06.2022

The minutes of the last meeting of the Central Advisory Board held on 24.06.2022 were confirmed.

Agenda item 2: Identification of posts for persons with benchmark disabilities in State Government Establishments by States/UTs

The following were the points highlighted in the presentation:

- i. Section 34 of the RPwD Act, 2016, provides reservation of 4% in vacancies in Government establishments to PwBDs.
- ii. Central Government on 04.01.2021 notified 3566 suitable posts in Central Government establishments (CGEs).
- iii. State Governments being the appropriate Government for identifying suitable posts w.r.t. State Government Establishments (SGEs). There are many complaints related to non-compliance of the Section 34 of the RPwD Act, 2016 both in CGEs and SGEs

The Board recommended to all States/UTs to:

- a) implement reservation provisions of RPwD Act, 2016 in letter and spirit.
- b) complete the exercise of identification of posts suitable for various categories of persons with disabilities at earliest, if not yet, done so; and
- c) conduct training of the State Government officials of various organisations and sensitizing them about the provisions of reservation for PwDs and the process of identifying suitable posts for persons with

benchmark disabilities on the lines of list notified by Central Government on 04.01.2021.

Agenda 3: WP 29329 of 2021 Seema Girija Lal vs Union of India

In the Writ Petition (Civil) No. 29329 of 2021 filed by Ms. Seema Girija Lal against Union of India and others, the Hon'ble Supreme Court of India categorically directed the State Governments to ensure appointment of the Commissioners by 31st August 2023 and ensure compliance with the provisions of the RPwD Act, 2016. The Board recommended to all States/UTs to complete the compliance as per Hon'ble Supreme court order. Order of the Hon'ble Court is at **Annexure III**.

Agenda Item No. 4: Supreme Court Matter Contempt Petition No. 1653 of 2018 arising out of W.P. (C) No. 412 of 2016 - Shri Gaurav Bansal Vs Shri Dinesh Kumar & Others.

- i. In 2016, PIL filed in the Supreme Court seeking intervention for rehabilitation of persons with mental illness who have been cured but languishing in various mental health care institutions.
- ii. As per Hon'ble Court's directions, DEPwD developed the dashboard titled as 'Manoashraya'. capture data on RH/HH covering:- availability of institutions, facilities provided capacity and occupancy, region-wise distribution (State-wise). Order of the Hon'ble Court is at **Annexure IV**.
- iii. The Dashboard is linked with Tele-MANAS of MoHFW.
- iv. The matter is listed for hearing on 19.01.2024.

The Board recommended to the States/UTs to ensure

- a) that there is no duplicity in the data filled in the Manoshrava.
- b) that the detail be updated regularly in the Manoshrava.
- c) regular monitoring and inspection of MHI/RH/HH; and
- d) that the persons who have been successfully cured of mental illness are not languishing in the MHI and are rehabilitated in the RH/HH.

Agenda Item 5: Status of implementation of Accessible India Campaign including notification of sector specific accessibility standards.

The presentation mainly highlighted the achievements of the Campaign in respect of Buildings, transportation and Website accessibility followed with the latest status of the formulation of the sector specific accessibility guidelines/standards.

I. The following were the points highlighted in respect of Buildings :

- A total of 623 Buildings are made accessible (i.e. 47.5% of 1341 funded buildings) of 21 States/UTs
- A total of 1100 Central Government Building made accessible

II. The following were the points highlighted in respect of transportation :

- All 35 International Airport and 55 out of 69 Domestic Airports are made accessible
- Out of 1,45,747 buses, 42,348 (29.05%) buses are partially accessible, and 8,695 (5.96%) buses are fully accessible. Out of 3533 bus station, 3120 are made accessible in respected to 24 States/UTs
- Fully accessible Railway Stations = 709 (Type A1, A & B)
- Partially accessible Railway Stations = 50%

III. The following were the points highlighted in respect of Websites :

- Total 767 both Central and State Govt. websites have been made accessible.
- 19 news channels having telecasted 2447 accessible news bulletin and in General Entertainment Category (GEC), 17 channels have telecast 3686 accessible scheduled programs/movies.

IV. Status of sector specific guidelines of 20 Ministries/Departments

Out of 20 Ministries/Departments, 07 Ministries/Departments with guidelines have been notified under Rule 15 of the Right of Persons with Disabilities (Amendment) Rules 2023, followed by 03 Ministries/Departments that have adopted the guidelines of other

Ministries/Departments. Furthermore, 03 Ministries/Departments are under draft and final notification stage at DEPwD level whereas, remaining Ministries/Departments with guidelines are awaited for notification in the official gazette by the concerned Ministry/Department.

The Board recommended to all States/UTs to:

- a) submit pending utilization certificated or initiate the process of refunding the unutilized amount in Central Nodal Accounts
- b) submit the information regarding the websites made accessible by ERNET India in response to the letter issued to all Principal Secretaries of Social Welfare departments
- c) consider the grievances received for the inaccessible built environment and take necessary action in this matter considering the mandatory provision of RPwD Act, 2016 in terms of providing accessible infrastructure.
- d) take immediate action for compliance of Section 45(1) of the RPwD Act, 2016 which mandates that all the existing public buildings be made accessible within a period of 5 years from the date of notification of accessibility standards i.e. by 14.06.2022.
- e) adopt and ensure the implementation of the sector specific accessibility guidelines notified under Rules 15 of the RPwD (Amendment) Rule, 2023 in the concerned domain

The Board further recommended to all 20 Ministries/Departments to

- ensure the compliance audit of the provisions of Ministries/Department's respective sector specific guidelines, timely to monitor the 100% accessibility and prevent any discrepancy on ground.
- expedite notification of their sector specific accessibility standards so that the same could be included under the RPwD Rules, by DEPwD.
- Ministry of Railway and Civil Aviation may make the remaining railway stations and airports completely accessible.

Agenda 6 : Status of implementation of the UDID project including linkage of UDID to various schemes and programmes of Central Ministries/Departments and States/UTs

- I. Highlighting the importance of the UDID Project, it was stated that the UDID project is being implemented since 2016-17 with a view to creating a National Database for PwDs and also to issue Unique Disability ID cards to each PwD.
- II. Department mandated requirement of UDID cards for availing benefits under schemes of Department including associated organizations.
- III. So far more than 1.04 crore lakh e-UDID cards generated. However the States/UTs were requested to bridge the gap of 60 lakh UDID card certification.

The Board recommended to all States/UTs to expedite the process of digitization of manual certificate of disability issued earlier and to develop joint coordination mechanism at the district level to implement the project on campaign mode to achieve saturation. Further, to link their schemes with UDID.

Agenda Item No. 7: Review of the major Schemes / Programmes of the Department

- i. Assistance to Disabled Persons for Purchase / Fitting of Aids and Appliances (ADIP)
 - ii. Scholarship Scheme for Students with Disabilities
 - iii. Deendayal Divyangjan Rehabilitation Scheme (DDRS)
 - iv. National Action Plan for Skill Development of Persons with Disabilities under Scheme for Implementation of Persons with Disabilities Act (SIPDA)
 - v. Research on Disability related Technology, Products and Issues under SIPDA Scheme
-
- I. Highlighting a record-high annual budget, both the Department and ALIMCO reported significant budget increases. Currently, 103 ALIMCO centres are operational nationwide.

- II. Concerns were raised about the Scholarship Scheme, particularly in the Northern Eastern Regions where students are reportedly not receiving scholarships. There was a call to promote Overseas Schemes among Persons with Disabilities (PwDs) to encourage applications for studying abroad.
- III. Regarding DDRS, States were urged to actively participate, considering the allocated budget of 650 crores this year. The emphasis was on establishing at least one center at the district level. The Board was informed about a letter from the Department requesting space for ALIMCO at district hospitals, seeking state cooperation and coordination.
- IV. For Research and Development, States were urged to foster a research culture, with the department offering assistance.

The Board recommended to all States/UTs to popularise these schemes and encourage reputed organisations to apply for grant-in-aid as per eligibility criteria.

Agenda item 8: Review of the National Institutes under Department

The presentation focused on the nine National Institutes (NIs) operating under the Department, each accompanied by its respective Composite Regional Centers (CRCs). It was highlighted that currently, no CRCs are associated with the Indian Sign Language Research and Training Center (ISLRTC) and the National Institute of Mental Health Rehabilitation (NIMHR). Presently, only 25 CRCs are operational throughout India, underscoring the pressing need to establish additional CRCs.

Recognizing the importance of expanding CRCs, the Board recommended to State/UTs to contribute available land or space within their regions for the establishment of CRCs, with the emphasis on providing such resources free of cost. This collaborative effort aims to facilitate the establishment of a greater number of CRCs to address the evolving needs and demands effectively, Guidelines for establishment of CRCs is at **Annexure V**.

Agenda 9: Organizing ‘Purple Fest by all States/UTs on annual basis for inclusion and empowerment of persons with disabilities

Purple fest is an inclusive event organized by the Govt. of Goa in the first week of January. The event aimed at showcasing inclusive world of Persons with Disabilities by organizing various events, workshops, showcasing potential of PwDs and way ahead for their inclusion. On similar lines, Jammu and Kashmir have also organized event from 28-29th Dec 2023. Similarly, this Department have organized 8 Divya Kala Shakti and 11 Divya Kala Mela across the country.

The Board recommended to all States/UTs to organize such events on the lines of purple fest and ensure that the best practices and innovative intervention aimed at inclusion of PwDs are adequately shared amongst other States/UTs for multiplier effect.

Agenda 10: New Initiatives of the Department

- I. New initiatives ranging across different schemes and divisions of the department were highlighted such as;
 - a. **Modernisation of ALIMCO:**
 - New models of aids and ADs launched
 - IIT and NID collaboration
 - Massive Footprint expansion
 - b. **National Trust:**
 - Paperless process for all schemes/activities
 - UDID linkage for Niramya scheme
 - Mentors Training Program on Self Advocacy for Divyangjan
 - c. **National Divyangjan Finance and Development Corporation:**
 - Divya Kala Mela across country to encourage entrepreneurs
 - Collaboration with Entrepreneurship Development Institute of India
 - Full database compilation for post loan tracking of business
 - d. **Accessible India Campaign :**

- Memorandum of Understanding with Council of Architecture - Universal accessibility auditor course.
 - Making 75 pilgrimage places accessible for PwDs.
 - Training of State officer for universal accessibility
- e. PM-DAKSH – Skilling for PwDs.
 - f. Online case monitoring for CCPD.
 - g. Publication of Pathways to access – Court orders on disability rights.
 - h. Release of UDID aggregated data of PwDs.
 - i. 4th ISL dictionary of 10,500 words launched.
 - j. 2 new CDEICs at NIMHR and CRC Gorakhpur sanctioned.
 - k. 4 new CRCs at Jammu, Chattarpur, Madurai and Jaipur approved.

- II. The CAB was requested to take note to the initiatives and encouraged the States and UTs to give visibility to the initiatives.

Agenda item 11: Developing dedicated schemes to provide high support to persons with benchmark disabilities having such needs in terms of RPwD (Amendment) Rules, 2019

The presentation highlighted few points which are as follows:

- I. The Government notified the RPwD (Amendment) Rules, 2019 on 08.03.2019 inserting therewith Chapter VA which relates to persons with benchmark disability requiring high support.
- II. Rule 14A (9) of these Rules provides that the State Government/UT may develop dedicated schemes to provide high support to such persons with benchmark disabilities.

III. Most of the States/UT have not developed any scheme/programmes for persons with benchmark disability requiring high support.

Central Advisory Board urged to all States/UTs to develop dedicated schemes to provide high support to such persons with benchmark disabilities.

Agenda Item No. 12: The utilisation of the 'Biometric Exception' provision for Aadhaar Cards, specifically addressing Persons with Disabilities (PwDs) unable to provide fingerprints.

Under this agenda following are the points that were highlighted;

- i. The Parliamentary Standing Committee in its 45th Report dated April 2023 *inter alia* mentioned about the difficulties faced by persons with particular type of disability due to which they are unable to provide their finger prints and get the Aadhar card.
- ii. The Committee was informed that there is a provision of Biometric exception for such persons.
- iii. The Committee desired the issue to be placed before the Central Advisory Board.
- iv. DEPwD *vide* letter dated June 2023 requested Unique Identification Authority of India to create awareness about the provision of Biometric Exception amongst the implementation authorities so that the benefits of the said provision is made available to the concerned persons

The Board took note of the action taken by DEPwD and also urged Unique Identification Authority of India to take up the matter on a priority basis.

Agenda 2 - Identification of posts for persons with benchmark disabilities in State Government Establishments by States/UTs

- ▶ Section 34 of the RPwD Act, 2016, provides reservation of 4% in vacancies in Government establishments to PwBDs.
- ▶ Central Government on 04.01.2021 notified 3566 suitable posts in Central Government establishments (CGEs).
- ▶ State Governments are the appropriate Government for identifying suitable posts w.r.t. State Government Establishments (SGEs).
- ▶ There are many complaints related to non compliance of the Section 34 of the RPwD Act, 2016 both in the CGEs and SGEs.

- ▶ **The Central Advisory Board may deliberate on this issue and urge the States/UTs to:**
 - ❖ implement reservation provision of RPwD Act, 2016 in letter and spirit;
 - ❖ complete the exercise of identification of posts suitable for various categories of persons with disabilities at earliest, if not yet, done so; and
 - ❖ conduct training of the State Government officials of various organisations and sensitizing them about the provisions of reservation for PwDs and the process of identifying suitable posts for persons with benchmark disabilities on the lines of list notified by Central Government on 04.01.2021.

**Agenda item 3: WP 29329 of 2021 Seema Girija Lal vs
Union of India**



Agenda 3 - WP 29329 of 2021 Seema Girija Lal vs Union of India

- ▶ In the Writ Petition (Civil) No. 29329 of 2021 filed by Ms. Seema Girija Lal against Union of India and others, the Hon'ble Supreme Court of India categorically directed the State Governments to ensure appointment of the Commissioners by 31st August 2023 and ensure compliance with the provisions of the RPwD Act, 2016.
- ▶ The case is next listed for hearing on 22nd January, 2024.

▶ **The Central Advisory Board may recommend all States/UTs to complete the compliance as per Hon'ble Supreme court order before 10th January, 2024.**

- ▶ **Information as obtained from States/UTs regarding compliance of provisions of RPwD Act, 2016 :**
 - ❖ 34 States/UTs except **Ladakh and Maharashtra** notified RPwD Rules.
 - ❖ 34 States/UTs **except Dadar & Nagar haveli & Daman & Diu and Ladakh** constituted State Advisory Boards.
 - ❖ 35 States/UTs except **Ladakh** constituted District level Committees.
 - ❖ 34 States/UTs except **Arunachal Pradesh and West Bengal** designated Special Courts.
 - ❖ 27 States/UTs except **Andhra Pradesh, Andaman & Nicobar Islands, Chandigarh, Chhatisgarh, Himachal Pradesh, Jharkhand, Lakshdweep, Punjab, and Tripura** have independent Commissioners for PwDs.
- ▶ **Many States are yet to ensure compliance for many other provisions of RPwD Act, 2016 namely :**
 - ❖ Appointment of Public Prosecutor
 - ❖ Appointment of Nodal Officer in District Education office
 - ❖ Constitution of Assessment Board for high support needs
 - ❖ State fund for PwDs
 - ❖ Designated authority to provide limited guardianship
 - ❖ Appointment of authority for registration of institutions working in disability sector

- ▶ In 2016, PIL filed in the Supreme Court seeking intervention for rehabilitation of persons with mental illness who have been cured but languishing in various mental health care institutions.
- ▶ As per Hon'ble Court's directions, DEPwD developed the dashboard titled as '**Manoashraya**'. capture data on RH/HH covering:- availability of institutions, facilities provided capacity and occupancy, region-wise distribution (State-wise).
- ▶ The Dashboard is linked with **Tele-MANAS** of MoHFW.
- ▶ The matter is listed for hearing on 19.01.2024.

- ▶ **The Central Advisory Board may deliberate on this issue and may advise the States/UTs to ensure:**
 - ❖ that there is **no duplicity** in the data filled in the Manoshraya;
 - ❖ that the details be updated regularly in the Manoshraya;
 - ❖ that the regular **monitoring and inspection** of MHI/RH/HH; and
 - ❖ that the persons who have been successfully cured of mental illness are not languishing in the MHI and are rehabilitated in the RH/HH.

**Agenda item 5: Status of implementation of
Accessible India Campaign including notification of
sector specific accessibility standards**



Achievements of the Campaign



- Completed Buildings 623 (47.5% of 1341 funded buildings) of 21 States/Uts
- All 1100 Central Government Building made accessible

- All 35 International Airport and 55 out of 69 Domestic Airports are made accessible
- Out of 1,45,747 buses, 42,348 (29.05%) buses are partially accessible, and 8,695 (5.96%) buses are fully accessible. Out of 3533 bus station, 3120 are made accessible in respected to 24 States/Uts
- Fully accessible Railway Stations = 709 (Type A1, A & B)
- Partially accessible Railway Stations = 50%

- Total 767 both Central and State Govt. websites have been made accessible.
- 19 news channels having telecasted 2447 accessible news bulletin and in General Entertainment Category (GEC), 17 channels have telecast 3686 accessible scheduled programs/movies.

- CAB may urge to all State/UT Governments**
 - To submit **pending UCs** or initiate the process of refunding the unutilised amount. Also to utilise the unutilised amount in CNA account or refund the same.
 - To submit the information regarding websites made accessible by ERNET India in response to the letter issued to all Principal Secretaries of Social Welfare departments vide letter dated 30.11.2023
 - To consider the grievances received for the inaccessible built environment and take necessary action in this matter considering the mandatory provision of RPwD Act, 2016 in terms of providing accessible infrastructure.
 - To take immediate action for compliance of Section 45(1) of the RPwD Act, 2016 which mandates that all the existing public buildings be made accessible within a period of 5 years from the date of notification of accessibility standards i.e. by 14.06.2022.

- ▶ UDID project being implemented since 2016-17 with a view to creating a National Database for PwDs and also to issue Unique Disability ID cards to each PwD.
- ▶ So far more than [1.04 crore lakh e-UDID cards](#) generated.
- ▶ Department mandated requirement of UDID cards for availing benefits under schemes of Department including associated organizations.
- ▶ There is less progress in digitization of the manual certificate of Disability issued earlier by the States/UTs on the UDID portal – [State-wise pendency position](#)

▶ **The Board may urge :-**

- ❖ States/UTs to expedite the process of digitization of manual certificate of disability issued earlier;
- ❖ the States/UTs to develop joint coordination mechanism at the district level to implement the project on campaign mode to achieve saturation; and
- ❖ States/UTs to link their schemes with UDID.

- ❖ **Deendayal Divyangjan Rehabilitation Scheme** to provide grant-in-aid to NGOs for 8 model projects relating to rehabilitation of persons with disabilities: **Annual Budget ~ 130 Cr.** – [Map of DDRS.](#)
- ❖ **National Action Plan for skill development of PwDs** implemented since 2015, focussed on skilling of PwDs of 21 disability types from the age group 15 to 59 for 200+ NCVET approved courses. This scheme is now implemented through PM-DAKSH : **Annual Budget ~ 56 Cr.**
- ❖ **Research on Disability related Technology, Products and Issues** : **Annual Budget ~ 2.37 Cr.**

- ▶ The Government notified the RPwD (Amendment) Rules, 2019 on 08.03.2019 inserting therewith Chapter VA which relates to persons with benchmark disability requiring high support.
- ▶ Rule 14A (9) of these Rules provides that the State Government/UT may develop dedicated schemes to provide high support to such persons with benchmark disabilities.
- ▶ Most of the States/UT has not developed any scheme/programmes for persons with benchmark disability requiring high support.

▶ **Central Advisory Board may urge all States/UTs to develop dedicated schemes to provide high support to such persons with benchmark disabilities.**

Agenda item 12: Use of the provision of ‘Biometric Exception’ for Aadhaar Card in case of such PwDs who are unable to provide their finger prints



Biometric Exception' for Aadhaar Card in case of PwDs

- ▶ The Parliamentary Standing Committee in its 45th Report dated April 2023 *inter alia* mentioned about the difficulties faced by persons with particular type of disability due to which they are unable to provide their finger prints and get the Aadhar card.
- ▶ The Committee was informed that there is a provision of Biometric exception for such persons.
- ▶ The Committee desired the issue to be placed before the Central Advisory Board.
- ▶ *DEPwD* vide letter dated June 2023 requested Unique Identification Authority of India to create awareness about the provision of Biometric Exception amongst the implementation authorities so that the benefits of the said provision is made available to the concerned persons.

▶ **Central Advisory Board may take note of the action taken by DEPwD and also urge Unique Identification Authority of India to take up the matter on a priority basis.**

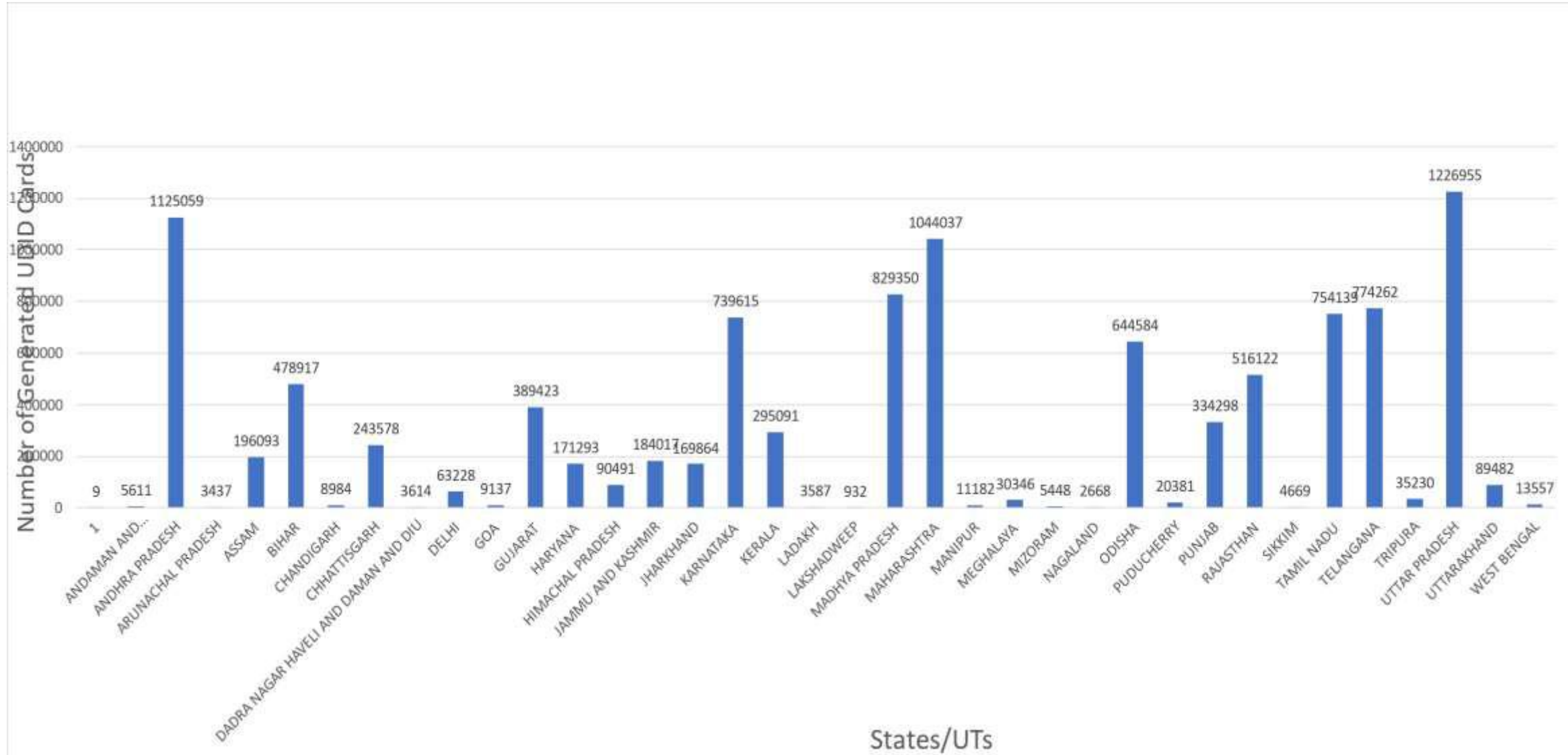

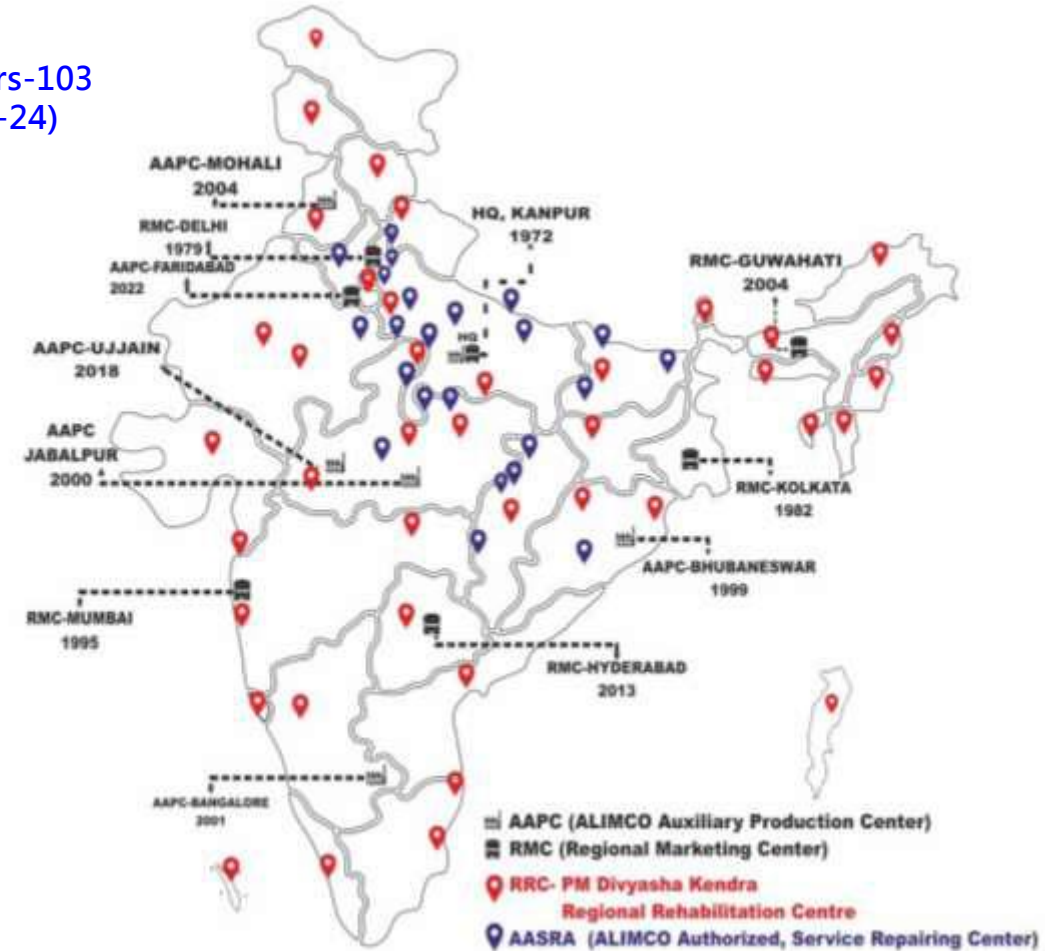

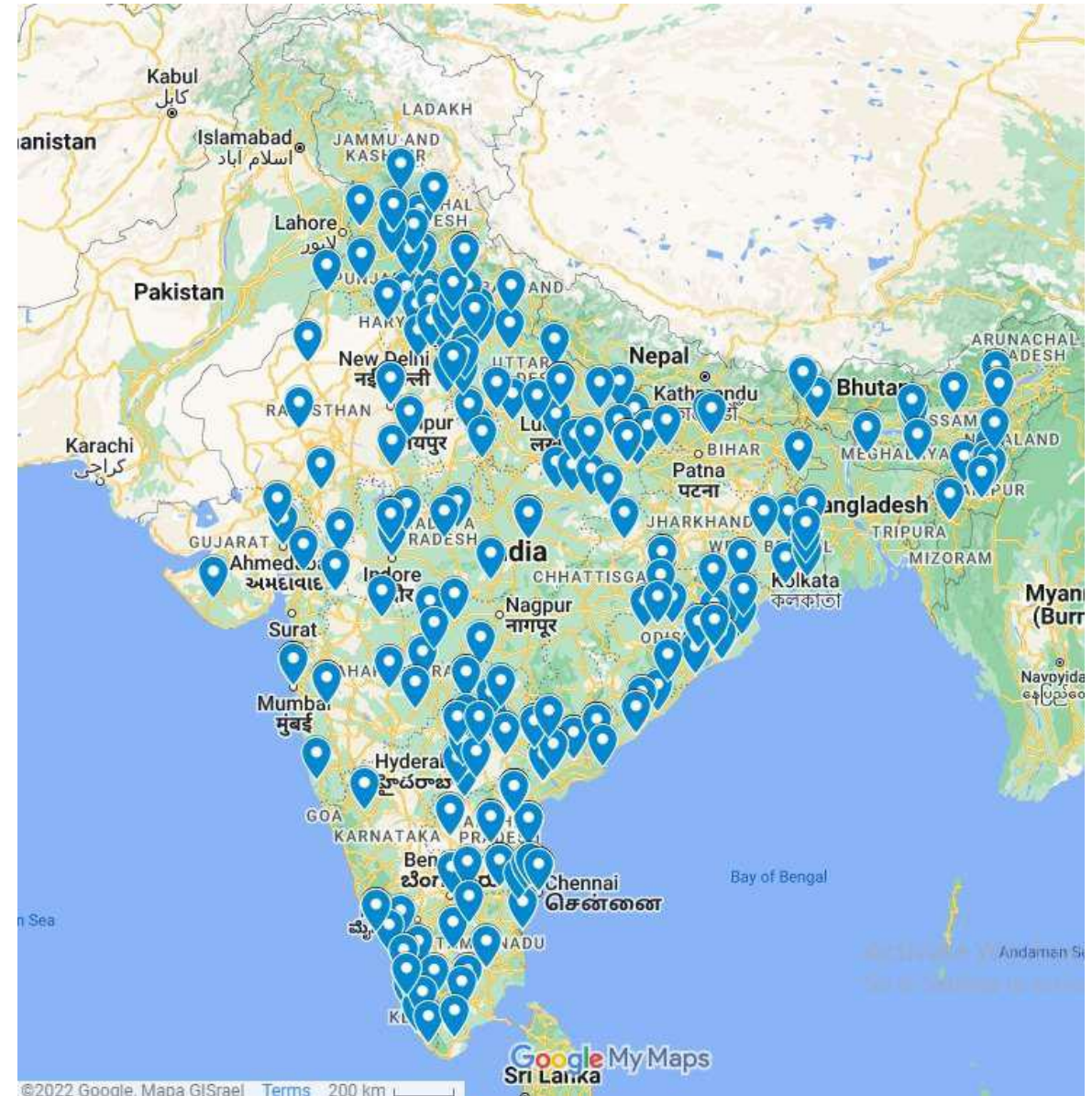

O R D E R**

- 1 The Union government has filed an affidavit through the Joint Secretary in the Department of Empowerment of Persons with Disabilities in the Ministry of Social Justice and Empowerment. Annexure II to the affidavit indicates the status of the implementation of the provisions of the Rights of Persons with Disabilities Act 2016¹ in the States/Union Territories as on 11 May 2023.
- 2 The status of implementation of the legislation indicates a dismal position across the country. For convenience of reference, the tabulated statement, as annexed by the Union of India to the affidavit, is reproduced below:

- 3 From the above statement, it appears that Rules under Section 101 of the Act have yet not been notified by the States of Chhattisgarh, Maharashtra and by the Union Territory of Ladakh. Counsel appearing on behalf of the State of Chhattisgarh states that Rules have been notified by the State of Chhattisgarh.
- 4 The Chief Commissioners are entrusted with statutory duties including the duty of monitoring the implementation of the provisions of the Act. This is evident from the provisions of Sections 75(1)(h) and Section 80(g) which define the functions of the Central and State Commissioners, respectively. Independent Commissioners under Section 79 have not been appointed by several States and UTs, which is evident from Serial No 3 of the tabulated statement, extracted above.
- 5 We direct the State Governments to ensure compliance with the provisions of the Act so as to rectify the deficiencies which have been noted in the affidavit filed by the Union government expeditiously on or before 30 September 2023. Since the Commissioners are entrusted with an important statutory function of overseeing the implementation of the provisions of the Act, the States/UTs shall ensure appointment of the Commissioners by 31 August 2023.
- 6 Since both the Central and State Commissioners are statutorily entrusted with the duty to ensure the implementation of the provisions of the Act

under Sections 75(1)(h) and 80(g), they shall be accountable to this Court for ensuring that due compliance has been effected in terms of this order.

- 7 All State Governments/Union Territories shall upload the relevant data pertaining to the status of compliance on the dashboard of the Union Ministry of Social Justice and Empowerment. The Ministry of Social Justice and Empowerment shall coordinate with all the State Governments/Union Territories through the respective Ministries and submit a status report to this Court by 15 September 2023.
- 8 List the Petition on 18 September 2023.

**UPON hearing the counsel the Court made the following
O R D E R**

- 1 In pursuance of the previous order of this Court dated 6 July 2021, a status report has been filed by the Department of Empowerment of Persons with Disabilities in the Union Ministry of Social Justice and Empowerment. A review meeting was convened online on 12 July 2021 with the Social Justice Departments of the State Governments/Union Territories, in pursuance of which the status report compiles certain information.
- 2 As regards the vaccination of persons with mental illness in mental health care institutions, the Ministry of Social Justice and Empowerment addressed a communication on 7 July 2021 to the Ministry of Health and Family Welfare. The Ministry of Health and Family Welfare has accordingly directed all the States/Union Territories to ensure the vaccination of mentally ill persons who are lodged in mental health care institutions against Covid-19 on a priority basis by their letter dated 8 July 2021.
- 3 In order to ensure that these directions are complied with, all the States/Union Territories are directed to lay down a time schedule for facilitating the vaccination of all persons who are lodged in mental health care institutions within a period of one month from the date of this order. A progress report shall be filled by every State/Union Territory with the Department of Social Justice and Empowerment of the Union Ministry of Social Justice and Empowerment on or before 15 October 2021 explaining:
 - (i) The steps taken; and

- (ii) The number of persons who have been vaccinated against Covid-19 in mental health care institutions.

The vaccination of the inmates must also be coupled with vaccination of all the service providers as well as health care professionals and other staff associated with these institutions. The progress shall be monitored and details submitted to this Court when a status report is next filed in pursuance of the directions contained in this order.

- 4 We have heard Mr Gaurav Kumar Bansal, petitioner-in-person, who has appeared in support of the contempt petition and Ms Madhavi Divan, Additional Solicitor General. We have also heard Mr Sachin Patil, counsel for the State of Maharashtra and Ms Garima Prasad, Senior Counsel for the State of Uttar Pradesh.
- 5 Mr Gaurav Kumar Bansal has highlighted certain issues which need to be flagged in this order since they are of significance for the future course of action.
- 6 As regards the establishment of Half-way Homes, it is not sufficient to re-designate existing establishments as Half-way Homes merely to demonstrate that there has been compliance with the orders of this Court. Many state governments are doing this. In fact this amounts to a breach of the directions and we place all states/UTs on notice of this position.
- 7 As we have noticed earlier, the State of Maharashtra had decided to shift about 186 persons who were overstaying in mental health care institutions to 'beggar homes' or, as the case may be, old age institutions. After the above issue was highlighted by this Court in the previous order, a letter was addressed on 21 July 2021 to the Chief Secretary of the State Government to expedite the process of shifting these persons from beggar homes/old age homes to Half-way Homes.

The State of Maharashtra has since filed a brief note through Mr Sachin Patil. The note states that there were a total of 215 cured patients who had overstayed in mental health institutions, of which 186 were temporarily shifted to old age homes, women's hostels and beggar homes until the establishment of Half-way and Rehabilitation Homes takes place. A meeting was held by the Chief Secretary on 14 October 2019, at which a monitoring committee was constituted. Thereafter, on 23 July 2021, a decision has been taken along the following lines:

- (i) Relocate persons who have been cured of mental illness within three months after identifying and contacting NGOs working in mental health services;
- (ii) Until the above exercise is completed, the public health department has taken the responsibility to provide requisite facilities in terms of medical care, counselling and other requirements; and
- (iii) The exercise of establishing Half-way Homes and Rehabilitation Homes is to be completed expeditiously within six months.

8 The modalities which were adopted by the State of Maharashtra of simply pushing the cured patients who were overstaying in mental health care institutions to beggar homes and old age homes is insensitive and leaves much to be desired. This would not fulfill compliance with the earlier directions of this Court. Now, that the State has become alive to its responsibility and has taken action, we direct that the process be taken to its logical conclusion by ensuring that on or before 30 November 2021, the cured persons are duly placed with institutions which are capable of meeting the requirements of such persons who are no longer mentally ill, but are in need of being placed in Half-way Homes so that their rehabilitation and care can be pursued. The State Government shall

also take steps to abide by its undertaking of setting up Half-way Homes and Rehabilitation Homes within a period of six months. In the meantime, it may seek the co-operation of experienced NGOs as suggested.

9 The Status Report filed by the Union Government indicates that the State of Uttar Pradesh has simply followed the pattern of re-designating old age homes in each of the 75 districts as Half-way Homes. Again, this does not amount to a valid discharge of its duties and obligations by the State Government of complying with the directions of this Court as well as the provisions of the Mental Healthcare Act 2017. Merely, re-designating the existing old-age homes in all the 75 districts as Half-way Homes is only lip service to the need for having actual Half-way Homes where the requirements of rehabilitation are duly observed. The State of UP must rectify the position within three months and submit its compliance on affidavit.

10 We have highlighted the position in the above two States - Maharashtra and Uttar Pradesh to emphasize that there are two separate issues which need to be considered:

- (i) The establishment of Half-way Homes and Rehabilitation Homes must take place on priority across the country by the States/Union Territories and mere re-designation of existing facilities will not serve the purpose; and
- (ii) The task of rehabilitation will not be subserved by merely relocating the persons who have been cured of mental illness.

11 In this context, the guidelines which have been issued by the Union Government which are annexed to the contempt petition provide a detailed blue-print for setting up the homes and for following the model of rehabilitation. We do not find that any genuine progress has been made in that context though different

State Governments have indicated varying time lines for setting up the Half-way Homes.

- 12 We are of the view that it would be necessary for the Union Government to monitor the progress which has been made and to apprise this Court periodically so that the Court is not required to individually take up the case of each State/Union Territory for assessing the progress which has been made.
- 13 Ms Madhavi Divan has suggested that the concern is to ensure that the States take up ownership over the need for setting up of Half-way Homes and for providing rehabilitation for persons who have been cured with mental illness and long term accountability needs to be fastened.
- 14 We direct that the Ministry of Social Justice and Empowerment must set up an online dashboard in which complete details in regard to:
 - (i) availability of institutions;
 - (ii) facilities provided;
 - (iii) capacity;
 - (iv) occupancy; and
 - (v) region-wise distribution of the Half-way Homes is made available state-wise and for the UTs. The availability of Half-way Homes must also be reflected in the online dashboard. The data of each State and Union Territory must be uploaded on the dashboard on a real time basis.
- 15 We direct the Union Ministry of Social Justice and Empowerment to formulate and circulate to all States/Union Territories a model format of its online

dashboard. Upon receipt of the communication from the Union Ministry, all States/Union Territories shall provide all relevant data within a period of four weeks thereafter. The data on the online dashboard shall be updated on a real time basis so that all information which is required to be made available is updated in a seamless manner.

- 16 We propose to adjourn the hearing of these proceedings to December 2021. In the meantime, the Ministry of Social Justice and Empowerment shall hold meetings once every month to track the progress which has been made by the States/Union Territories for setting up the Half-way Homes and for the rehabilitation of persons who have been cured of mental illness. The status report shall be filed at least one week before the next date of listing with a copy being circulated in advance to Mr Gaurav Kumar Bansal and other learned counsel appearing in these proceedings. Any recalcitrant administration of a state or UT will be liable to face contempt action.

IA No 107760 of 2021 in Contempt Petition (C) No 1653 of 2018

- 1 Based on certain research studies conducted in 2016 by NIMHANS and by the National Commission for Women in 2020, it has been highlighted that women, who are institutionalized in government run mental health establishments across the country, face violations of human rights which are detailed below:
- (a) Lack of Sanitary Napkins (violation of Section 20(2)(b) of Mental Healthcare Act 2017)
 - (b) Lack of Privacy (violation of Section 20(2)(c) of Mental Healthcare Act 2017)

- (c) Illegal cutting of hair (violation of Section 20(2)(i) of Mental Healthcare Act 2017)
 - (d) Lack of Identity Cards (like UIDAI/Aadhar Card)
 - (e) Lack of Disability Certificates
 - (f) Lack of Disability Pension (violation of Section 24(d)(g) of the RPwD Act 2016)
 - (g) Women institutionalized in Mental Health Establishments (for treatment or rehabilitation purpose) are not allowed to keep their children with them as there is no separate mother-child ward in many of the government run mental health establishments (violation of Section 21(2) of the Mental Healthcare Act 2017 and Section 24(3) of RPwD Act 2016).
- 2 The issues which have been flagged in the above interlocutory application are of serious concern. The Ministry of Social Justice and Empowerment shall specifically raise each of the above concerns which have been expressed in the research studies and as formulated above with the States/Union Territories in the course of the monthly monitoring that has been directed above. Remedial measures shall be taken by all States/Union Territories and compliance shall be reported on affidavit within 3 months.
- 3 Necessary directions shall be issued for taking steps to ensure that the problems which have been highlighted above, are alleviated by the State Governments/Union Territories by taking necessary measures in that regard. Compliance in that regard shall be incorporated in the status report.

4 List the matters on 14 December 2021.

It has been decided to formulate a policy for establishment of a new Composite Regional Centre for Skill Development, Rehabilitation & Empowerment of Persons with Disabilities (CRC), as under:

- (i) A new CRC, under administrative control of a National Institute (Autonomous Body under DEPwD), will be set up in accordance with Rule 229 of General Financial Rules (GFR), 2017.
- (ii) Every State/Union Territory, irrespective of area and/or population, should have atleast 01 (One) CRC.
- (iii) Bigger states (area and/or population wise) may have more than 01 (one) CRC, subject to a maximum of 05 CRC, depending upon number of Persons with Disabilities (PwDs) and willingness of State Government to provide land and temporary accommodation and other requirements.
- (iv) Since setting up of a CRC has a financial implication of around 25 crore in addition to recurring cost of about 2 crore per year, an advanced projection for setting up of CRCs will be made and before finalization of budgetary requirement for a financial year, in-principle approval of Department of Expenditure will be sought to set up decided number of CRCs in that particular year.
- (v) On getting land as well as temporary accommodation from the concerned State Government/UT, complete proposal, including posts required, for setting up of a new CRC will be submitted for approval and concurrence of Department of Expenditure.
- (vi) After approval, DEPwD will issue establishment order of the new CRC under administrative control of one of the National Institutes. The recruitment process, for filling up of newly created posts at CRC, will be initiated by the concerned National Institute.
- (vii) In the meantime, CRC may start its operation from temporary accommodation, with the support of existing staff of the National Institute or a nearby CRC.
- (viii) The administrative and financial affairs of the CRC will be monitored through Executive Council/Governing Council of the concerned National Institute. The concerned National Institute will also take up the matter with CPWD for construction of permanent building of CRC.
