MINUTES OF THE MEETING OF THE SCREENING COMMITTEE HELD ON 20-21st JANUARY, 2020 TO CONSIDER NEW PROJECT PROPOSALS UNDER DEENDAYAL DISABLED REHABILITATION SCHEME (DDRS)

A meeting of the Screening Committee was held on 20th and 21st January, 2020 under the Chairpersonship of Ms. Tarika Roy, Joint Secretary (DEPwD) to consider the new proposals of NGOs received through State Governments under Deendayal Disabled Rehabilitation Scheme (DDRS). Both the Members of the Screening Committee Shri Subhash Joshi (Paliwal) and Mrs. Sushma Gupta attended the meeting. The entire Programme Division including Director and Under Secretary assisted the Screening Committee.

2. The Screening Committee was informed that as per para 3.6.1.6 of DDRS Scheme-guidelines, the proposals duly recommended by the State Govt. were required to be considered by this Committee. A comprehensive statement (Annexure-I) containing state-wise number of model-projects across the country was presented to the Committee. The statement gave an over-all picture of pan-India coverage of the DDRS scheme. Due to time taken in preparing such a detailed statement, the earlier meeting of the Screening Committee which was scheduled to be held on 16th October, 2019 had to be rescheduled; the previous one scheduled to be held on 14.03.2019 had to be postponed due to a major fire outbreak in the office of this Department on 06.03.2019. As such, a long gap occurred between the last meeting held on 14.12.2018 and the present one.

3. The Committee was apprised of the guidelines of the Scheme. The Committee was informed that the new proposals which would be approved by it, shall be considered for release of funds subject to fulfillment of all other terms & conditions of the scheme.

4. (i) The Committee discussed the parameters for keeping in mind while reviewing the proposals and recommending sanction. It should be obligatory upon all the organizations seeking grant-in-aid to submit a valid recognition/permission from concerned authority in the State Govt. and under PWD Act, 1995 or RPwD Act, 2016. Further, their teaching staff should also conform to the requirements under the RCI Act.

(ii) The over-all scenario of the pan-India coverage of the various model projects of DDRS was reviewed. A list showing number of model projects in various States is enclosed at Annexure-I. At present 489 model projects are being funded under DDRS. Considering the budget allocation for the current financial year 2019-20, it has been felt that there would be budget constraints if more and more new organizations are included. The cost norms of the projects under DDRS have been enhanced by 2.5 times the earlier rates with effect from 1st April, 2018. Up to the current financial year 2019-20, some of the proposals pertaining to 2017-18 are entitled to grant-in-aid at the pre-revised rates. However, from the year 2020-21 onwards all proposals would be at enhanced rate. Hence, considering the objective of Pan-India coverage within the availability of limited budget, it has been viewed that - new applications can be considered more in those districts where the similar model project is not being funded under DDRS. Further, it has been seen that a few model projects like Pre-school & Early Intervention, Community Based Rehabilitation, Half-Way Home, Low Vision Centres, and Rehabilitation of Leprosy Cured Persons etc. are very less. Hence, applications for these model projects need to be given priority as well.

(iii) Processing of already recommended new cases in the previous and current meeting should be taken on priority on receipt of requisite documents and State Govt. Recommendations for the current year. In case grant-in-aid could not be released to any organization which was recommended in the previous meeting due to any reason the said recommended action is revalidated by the present Committee subject to the condition that the NGO still fulfils all the terms & conditions of the DDRS scheme and the present Screening Committee has not specifically refused to revalidate the earlier recommendations considering the over-all coverage of the scheme.

(iv) The NGOs recommended herein should be verified and checked with updated list of NGOs/voluntary organizations blacklisted/debarred/banned by any other Department of Govt. of India. In case of new NGOs from NE states necessary security clearance from Ministry of Home Affairs may be obtained.

(v) All the proposals for the year 2018-19 and 2019-20 which were received after previous Screening Committee meeting (held on 14.12.2018) were kept for consideration in the present meeting. However, due to paucity of time, only the proposals for the year 2018-19 which were 103 in number could be considered by the Committee. The remaining proposals will be taken up in the next meeting of the Committee. Hence, Recommendation of this Committee will be valid till the end of financial year subsequent to the year in which the meeting is held i.e. since the meeting is held during 2019-20, the recommendations will remain valid till 31.03.2021.

5. In all, 103 new proposals were taken up for consideration by the Screening Committee, out of which --

- a) 27 cases were recommended.
- b) 70 cases were not recommended.
- c) 05 cases were deferred.
- d) 01 case was not required to be considered as it was an on-going case.

6. In addition, 8 cases were deferred in the earlier meeting held on 14.12.2018. Those case have also been taken up for consideration in this meeting but could not be recommended due to deficiency of some documents or the other. In another case namely Bison Asha School which was recommended by the Screening Committee in its earlier meeting but the validity of the recommendation expired on 31.03.2019, the Committee considered it again and revalidated the earlier recommendation as it was found to be fulfilled all mandatory conditions of the scheme. The proposals considered by the Screening Committee along with its recommendation/remarks are contained in Annexure-II. The meeting ended with a vote of thanks to the Chair.
