In supersession to this Department Office Memorandum No. P-13013/23/2023-UDID/IT/Statistics dated 04th July, 2024 (**Copy enclosed**), the following revised system of deliver of benefits under the schemes/programmes and services of the Department of Empowerment of Persons with Disabilities (DEPwD) and its associated organizations are hereby directed **with immediate effect and till further orders**:

- i. Only UDID enrolment number is acceptable for distribution of Prosthetics or orthotics equipments.
- ii. UDID enrolment number along with Global Development Delay Certificate shall be required for TLM kit distribution to Persons below 7 years of age. For PwDs above 7 years of age shall have to submit UDID number for obtaining TLM kit.
- iii. For obtaining benefits under DDRS, DDRC and National trust, UDID enrolment number along with Global Development Delay Certificate shall be required for Persons below 7 years of age and UDID number for PwDs above 7 years of age.
- iv. Only UDID number shall be mandatory for obtaining benefits under the following schemes/programmes/services of Dept. and its associated organizations:
 - A. Repeat benefits under ADIP Scheme.
 - B. Scholarship and Free coaching scheme.
 - C. Fee concession given by NIs and CRCs to PwDs
 - D. Any other scheme/programme/services etc.
- 2. All divisional heads in the Department and Head/In-charge of organization (s) under the Department are directed to ensure strict compliance of content of this O.M.
