The Committee considered all the EOIs and recommended as following:

- All 10 organizations mentioned under Table-1 above, who secured 75 marks and above as per marks matrix may be empanelled as Training Partner of this Department subject to cross verification of the placement.
- Committee has recommended for intimating all 34 organizations about score secured on the basis of the marks matrix and given them an opportunity to further provide their comments, if any, on the received marks as well as give representation if any, to amend the score by giving substantial documents for consideration of the Committee.
- Apart from the above, Committee also recommended that the qualifying marks for empanelled as training partner may be reduced from 75 to 70 subject to secure minimum marks under the criteria of Placement in last three financial years i.e. 21% to 30%, for covering maximum number of potential ETP.
- Committee also recommended that the Organizations, those have already worked as ETP, may be considered as ETP subject to successful completion of the previous project.
- The Committee also recommended that an MOU may be signed with the Government organizations/Universities involved in Skill training and organizations under this Department to conduct skill training.

Agenda Item No. 2

<u>Consideration of the new Project Specific Proposals (PSPs) received from</u> Empanelled Training Partners:

The Committee was informed that out of the 10 qualified EOIs mentioned under Table-1 of the various organizations, 04 organizations have submitted PSPs. Further, two fresh PSPs from NIEPMD, Chennai and NIEPID (Regional Center, Noida) are also received. Approval of proposals and allocation of overall and centre wise targets including trades, types of disability and batch size are notional and subject to suitability and capacity of the centres to be decided by the Department on the basis of centre validation report by the SCPWD or having SMART accreditation.
