

Dear Sir,

This is with reference to your email dated 26.03.2024 regarding the clarification about the comments from Shri Bhushan Punani regarding the cost of Computers, cloud based IVRS application software supporting 8 locations, cost of licenses etc.

In this connection please find the following clarifications:

Over all expenditure seems to be higher: This is because the proposal seeks to use the latest cloud based IVRS technology, with advanced computer system [server with windows 12 version], Digital IP phone requires to be configured with the software acquired from Baytalkitec.

AYJNISHD(D) has been implementing the similar help line [Disability Information Line] DIL from 6
centeres using 20 years old server based technology, which has been dismantled on the instruction of Hon'ble
Secretary to update it with latest Cloud Based IVRS technology. Besides No earlier grants were received
under AGP scheme to AYJNISHD(D).

3. The existing languages available for IVRS is Hindi and English only. The information was mostly related to only AYJNISHD(D) and speech and hearing impairment. Now there is need to update/replace the content of information with 21 disabilities and provide them in 10 languages, which require recording, editing and translation works. The quote of Rs.15 lakh for same work to be done as per DAVP rates for multiple languages.

4. The recurring cost of National Disability Information Helpline will be higher, as it is cost for 8 centres in various parts of the country including CRC-Ahmedabad & NIEPMED-Chennai and requires additional staff like Indian Sign Language [ISL] Interpreter and additional 2 Disability Information Executives with bilingual knowledge and who are rehabilitation professionals with CRR number. The recurring expenditure will be also to be funded from AGP scheme.

Kindly arrange to transfer an amount of Rs.39,22,000 as non-recurring expenditure to AYJNISHD(D) at the earliest to implement the NDIHS through '14456' at National Level.
