- 3. Agenda 5: Dhruvh Social Awareness: Some pages are missing, I can not find the budget of the applicant.
- 4. Agenda 8: EDI Gandhinagar: The Applicant wishes to organize a workshop on CSR among the Coprorates. The purpose of EDII is to motivate the corporate to spend CSR funds on disability related activities. According to my understanding, this proposal does fall under the purview of Awareness Scheme. The Applicant should develop a scheme on creating awareness among the masses about the potential of people with disabilities and should invite the Corporate to events as incidental to awareness events. Organizing an event exclusively for Corporate may not fall under the purview of the Scheme. We need to discuss this matter further, hence this proposal may be considered in the next meeting
- 5. Agenda 9: Radio Jingle: As Hon'ble Minister has desired to develop 10 Radio Jingles, a grant of Rs 4,50,000 is recommended
