

Minutes of the 27th Meeting of Selection Committee for skill development of PwDs under NAP held on 02.07.2024 at 11:00 AM.

The 27th Selection Committee meeting to consider the applications of Expression of Interest (EOI) and Project Specific Proposals (PSP), submitted by the various organizations through PM-DAKSH-DEPwD, was held on 02.07.2024, under the Chairmanship of Deputy Director General (DDG).

2. At the outset, DDG welcomed all the members of the Selection Committee (As per Annexure-I). The staff of Skill Section had placed the following agenda for consideration:

Agenda of the meeting

Item No. 1: Expression of Interests (EOIs) received from Organizations for empancment as Training Partners.

Item No. 2: Consideration of the Proposal received from Special School.

Item No. 3: Consideration of the new Project Specific Proposals received from ETPs.

Item No.4: Post facto approval of the Selection Committee w.r.t. proposals of National Institutes (NIs)/Composite Regional Centres (CRCs), which already approved by Secretary, DEPwD.

3. The Committee was apprised that during the 26th Selection Committee meeting, Committee recommended that the qualifying marks for empanelled as training partner may be reduced from 75 to 70 subject to secure minimum marks under the criteria of Placement in last three financial years i.e. 21% to 30%, for covering maximum number of potential ETP. Committee also recommended for intimating the following 34 organizations, not securing 75% marks, about score secured on the basis of the marks matrix and given them opportunity to further provide their comments, if any, on the received marks and if wants to give representation to amend the score giving substantial documents for consideration of the Committee:

4. **Agenda-wise details of the proposals and decision of the Selection Committees are as under:**

Agenda Item No. 1

- ❖ Expression of Interests (EOIs) received from Organizations for empanment as Training Partners.

The Committee was apprised that the total 48 EOIs has been received through PM-DAKSH-DEPwD portal. These EOIs has been examined in the Section and the marks obtained by each organization were shown to Committee. On Scrutiny of these 48 EOIs proposal, the following 09 organizations, which have secured 70+ marks as per marks matrix criteria:

The Committee was informed that out of the 34 Organizations mentioned under Table-1 above, 12 Organizations have submitted their revised EOI and 22 Organizations have not submitted their revised EOI. However, the EOI of all revised and non-revised EOI have been scrutinized, as the qualifying marks have been revised during 26th Screening Committee meeting.

The Committee was also informed that out of the qualified Organizations mentioned under Table-2 above, Medhavi Foundation's overall placement percentage is 62.48%, however, placement percentage for PwDs is 0%. Further, placement percentage in respect of Viklang Sahara Samiti Delhi is 0% for both (PwDs and Non-PwDs) criteria.

The Committee considered all the EOIs and recommended as following:

- Out of 09 organizations, 07 organizations mentioned under Table-2 above, who secured 70 marks and above as per marks matrix may be empanelled as Training Partner of this Department. With regard to "Sanidhya Welfare Society, Uttar Pradesh", Committee has recommended that prior to empanelment as Training Partner, the data provided by the organization may be verified.
- Further, with regard to "Viklang Sahara Samiti, Delhi", the Committee has recommended to seek the further details of placement from the organization and empanel this organization as Training Partner subject to cross verification of the placement data.
- Apart from the above, the Committee has also noted that "Atypical Platform Private Limited", who submitted the EOI, took participate in the Purple talk and purple fest organized by the Department and has effective collaboration with various MNCs and IIMs for placement of their trainee (PwDs). The Committee has also seen the EOI submitted by the organization and noted that the Organization has 100% placement record for their trainees. The Committee members also pointed out that the organization has won the National start-up award from Ministry of Commerce and Industries and also works on the self-employment of PwDs in different sector as per the market demand. Therefore, the Committee has recommended that Atypical Platform Private Limited may be empanelled as training partner conditionally. The Organization may be awarded a batch of 30 PwDs for skilling on the basis of the condition that the same will be monitored, if the output is found satisfactory then the next PSP may be considered.

Agenda Item No. 2

❖ Consideration of the Proposal received from Special School:

The Committee was apprised that during the 25th Selection Committee meeting, it was decided that Special Schools are exempted from regulation of Marks Matrix to explore the Skill Training of PwDs. The Committee was also apprised that the total 12 EOIs from following special schools have been received through PM-DAKSH-DEPwD portal:

The Committee considered all the PSPs submitted by the Special Schools and recommended as following:

- The Committee noticed that "Nagda Zenith Social Welfare Society", "Faith India" and "Open Learning System" have submitted their PSPs for LD, however, these Special Schools are teaching in the specific disability other than LD and also noted that Special Schools are providing the education in the specific disability type shall be considered under department Skill Training programme for that specific disability only. In case, the special school desire to conduct Skill training in any other disability than the special school has to come under full EOI process. Therefore, the Committee has recommended that the aforementioned Schools have to change their PSP as per their specific disability area within fortnight otherwise it will not be considered as Special School.
- The Committee also recommended that Special Schools have to provide their teaching plan for conducting the Skill Training before commencement within 15 days.
- Further, the Committee recommended that the Special Schools are not required the center validation from SCPwD, also the training of trainer from SCPwD may not be required for Special Schools.
- The Committee also recommended that the third installment clause may not be mandatory for these Special Schools.

Agenda Item No. 3

- ❖ Consideration of the new Project Specific Proposals received from ETPs:

The PSPs of 09 organizations, which have secured 70+ marks as per marks matrix criteria along with one already ETP namely "Divya Jyoti Charitable Trust, Karnataka", were placed before Selection Committee. Approval of proposals and allocation of overall and centre wise targets including trades, types of disability and batch size are notional and subject to suitability and capacity of the centres to be decided by the Department on the basis of centre validation report by the SCPWD or having SMART accreditation. Details of the PSPs filed by the organizations are placed under **Annexure-II**.

The Committee considered all the PSPs and recommended as following:

- As per this Department's OM No. SK-22011/2/2023-Skill dated 30.01.2023, Project Specific Proposal of only those ETP will be considered who will include 40% out of the total proposed target of PwDs belonging to categories of Disability other than Locomotor disability, viz. visual impaired, Speech and Hearing Impaired, Intellectual Disability etc., therefore, the Committee has recommended that "**Helping Power Foundation, Meerut, Uttar Pradesh**" and "**Hindustan Latex Family Planning Promotion Trust, Uttar Pradesh**" may be requested to revised their PSPs and resubmit the PSP within 15 days including 40% out of the total proposed target of PwDs belonging to categories of Disability other than Locomotor disability.
- The Committee recommended that the PSP in respect of **Sanidhya Welfare Society, Bareilly, Uttar Pradesh** may be placed before the next Selection Committee meeting, after proper verification and qualification of EOI.
- The Committee also recommended that the PSP of **Viklang Sahara Samiti Delhi** may be approved subject to qualification of EOI.

- The Committee recommended that to meet the criteria mentioned under this Department's OM No. SK-22011/2/2023-Skill dated 30.01.2023, the target in respect of **MNS Skills India, Mohali, Punjab**, may be reduced in the ratio of 60% LD and 40% SHI, as the organization has quoted the target of 60 for SHI out of total 300 PwDs.
- The Committee also recommended to approve the PSPs of the remaining organizations and also recommended that Department will ensure the inspection of the center and hostels of the organizations, where organizations claimed for residential training.
- The Committee also recommended that against fresh EOIs, initially commencement /target for 1st batch may be given for each classroom, further commencement/targets may be considered based on satisfactory completion of training of the 1st batches.

Agenda Item No. 4

- ❖ Post-facto approval of the Selection Committee on the proposals of NIs/CRCs which have already been approved

The Committee was also informed that Secretary, DEPwD directed that the skill training of PwDs from NIs/CRCs may be conducted through PM-DAKSH portal on priority. Accordingly, NIs/CRCs were requested to submit Project Specific Proposal (PSP) on PM-DAKSH portal. The 6 proposals NIs/CRCs/Regional Centres received on PM-DAKSH portal was approved. The same is placed before Committee for ex-post facto approval of the Committee.

- **The Committee has approved all 6 proposals.**

The meeting ended with vote of thanks to the chair.
