

Dear Sir/ Madam,

I have gone through the proposals and my comments/ recommendations are as under:

Agenda 1. NDFDC has been assigned the task of organizing Divya Kala Melas and Divya Kala Shakti programmes and the Corporation has already organized them at various places. The items are similar in all the DKM and DKM programmes. There may be small variation in the cost of certain items at different places and hence the overall cost may be similar. The need for holding these programmes is assessed by the Department and the NDFDC. Therefore, there is not much for the Screening Committee to examine these proposals. The organization should ensure all economy measures and best rates.

Hence, I suggest an upper limit of the budget may be fixed by DEPwD these programmes when the same agency is tasked to organize them. The funds may accordingly be released to the organization with a scope of plus/ minus 5-10% for contingencies. Recommendation of the Screening Committee may not be required as it would be only a formality.

More important aspect would be to ensuring that the sufficient number of persons with and without disabilities participate in the programmes and its quality, which may be monitored followed by impact evaluation.

Agenda 2.

The proposed expenditure on Venue charges (Rs 3,00,000 and Rs. 2,55,000 for Event management charges) appear on higher side. With these observations, recommended for approval.

Agenda 3.

The programme is fairly elaborate and relevant. Recommended for approval.
