- (iii) Purple Fair to utilize local purple ambassadors, local artists, social media influencers & PwD anchors to the extent possible.

- (iv) Care to be taken not to repeat PwDs in different Purple Fairs. Local special schools/NGOs etc. to be invited for showcasing their talent and best practices may be shared for empowerment of PwDs through panel discussion/other engagements in the side events of Purple Fairs.
- (v) All the organizations are asked to submit their detailed report considering the above points after completion of the event.
- (vi) No funds for quarter 2 would be released till utilization of funds of quarter 1 calendar days and submission of requisite bills/vouchers by respective NIs/CRCs.
