

Minutes of the 31st Meeting of Selection Committee for skill development of PwDs under NAP held on 14.01.2026 at 2:30PM

The 31st meeting of Selection Committee under National Action Plan for Skill Development of Persons with Disabilities (NAP-SDP) to consider the applications of Expression of Interest (EOI) for empanelment of training partners and Project Specific Proposals (PSP), received from various organisations through PM-DAKSH-DEPwD portal, was held on 14.01.2026 under the chairpersonship of Ms. Richa Shanker, Deputy Director General, Department of Empowerment of Persons with Disabilities. The list of participants is at Annexure-I.

2. At the outset, the Chairperson welcomed all the members of Selection Committee. The following agenda was placed before the Committee for consideration:

Agenda Item No. 1

Expressions of Interest (EOIs) received from Organizations for empanelment as Training Partners

The Committee was apprised that a total of 62 EOIs have been received through the PM DAKSH-DEPwD portal. These EOIs have been examined and only four EOIs have been found eligible as per marks matrix. The eligible organizations are listed below:

The organizations not meeting the marks matrix criteria were also examined in terms of demonstrating adequate potential and outreach to aspirational districts for placing before the Committee for consideration, if appropriate, as a special case by granting exemption from the marks matrix criteria. One such organization, Gundadhur Seva Shikshan Sanstha, Chhattisgarh has been identified for consideration for empanelment.

Decision of the Committee

The Committee considered the Expressions of Interest (EOIs) and recommended as below:

- To empanel all four (04) organizations meeting the Marks Matrix criteria.
- To empanel one additional organization, Gundadhur Seva Shikshan Sanstha, Chhattisgarh by granting relaxation from the marks matrix criteria in view of its potential and outreach to aspirational districts and assign limited targets to it.
- To reject all other EOIs alongwith PSPs, if any, received from other organizations which did not secure minimum qualifying marks.

Consideration of Project Specific Proposals received from organizations with EOIs

Decision of the Committee

The Committee considered the Project Specific Proposals (PSPs) of 5 organisations and recommended as below:

- To assign limited targets to all five (05) ETPs as per the details at **Annexure-II**.
- The three ETPs viz Gurukul Computer Education, Uttar Pradesh, Adivasi Utthan Gramin Vikas Seva Sanstha, Uttarakhand and B S Education Society, Uttar Pradesh, have proposed batches with hostellers but they have been assigned targets for day trainees. The same may be clearly indicated to ETPs.
- ETPs must finalise and inform about their OJT partners, wherever the OJT is mandatory in job role, before commencement of training.

Consideration of Project Specific Proposals received from Empanelled Training Partners

The Committee was apprised that Project Specific Proposals have also been received from a few Empanelled Training Partners. The empanelment of some of these ETPs has expired or is due to expire within the next three (03) months. The ETPs from which PSPs have been received are as below:

Decision of the Committee:

The Committee considered the PSPs of the 5 ETPs and recommended as below:

- The ETPs which have conducted skill training under the scheme earlier but their performance was not upto the mark or didn't complete the assigned targets, they may not be assigned further targets.
- Andh Mook Badhir Viklang Kalyan Sanstha, though empanelled but yet to be assigned any target, may be assigned limited targets as per the details at **Annexure-III**. ETP must finalise and inform about the OJT partners, wherever the OJT is mandatory in job role, before commencement of training. ETP must also ensure that the training is commenced within two months from the date of the approval of the PSP on the portal, otherwise the approval of PSP will stand cancelled.
- The ETP has proposed batch with hostellers but it has been assigned targets for day trainees. The same may be clearly indicated to ETP.
- PSPs other than those recommended above may be rejected.

Consideration of Project Specific Proposals received from Special Schools

The Committee was informed that during the 25th Selection Committee meeting, it was decided to exempt Special Schools from the applicability of the Marks Matrix. Project Specific Proposals received from the following two Special Schools received on the PM-DAKSH-DEPwD portal were placed before the Committee:

- National Association of Blind Chandigarh and Punjab Branch
- Asha School, Agra

The Committee was further informed that during the previous Selection Committee meetings, the following decisions were taken regarding proposals of Special Schools:

- Special Schools have to provide their teaching plan for conducting the Skill Training before commencement within 15 days.
- The Special Schools are not required for center validation from SCPwD.
- The Special Schools are exempted from having training of trainer from SCPwD, subject to the possession of valid Rehabilitation Council of India (RCI) certificate or having at least 1 year experience working with PwDs. In case the trainer of special schools do not have certificate of RCI and have at least minimum 1 year experience, he/she needs to have only assessment and certification from SCPwD.
- The third installment clause may not be mandatory for Special Schools.

Decision of the Selection Committee:

The Committee considered the PSPs of Special Schools and recommended as below:

- To assign targets to the National Association of Blind, Chandigarh & Punjab Branch and Asha School, Agra, as per details at **Annexure-IV**.
- PSPs other than those recommended above may be rejected.
- The committee decided that the decisions of previous Selection Committees regarding proposals of Special Schools, listed above, will be applicable for the proposals of special schools considered in this selection committee meeting also.

Agenda Item No. 5

Post-facto approval of the Selection Committee on the proposals of NIs/CRCs


The Committee was informed that as per the directions of the then Secretary, DEPwD to NIS/CRCs to conduct skill training of PwDs through PM-DAKSH portal on priority, NIs/CRCs were requested to submit Project Specific Proposal (PSPs) on PM-DAKSH portal and since the last Selection Committee meeting held on 21.02.2025, 56 proposals were received from


NIs/CRCs (details at **Annexure-V**) and the same were approved by the Department. The proposals were placed before the Selection Committee for ex-post-facto approval.




