All specific terms and conditions regarding hiring of the empanelled auditors, assignment of work/tasks, fees, deliverables, etc., shall be mutually decided between the service seekers and service providers, in accordance with the extant law in force and other mandatory provisions.

3. The empanelment is subject to the following terms and conditions:

I. Scope of Work:

The empanelled Web Accessibility Auditors with the Department of Empowerment of Persons with Disabilities (DEPwD) shall be responsible for assessing and evaluating the accessibility of web applications for persons with disabilities. The scope of work shall include, but not be limited to, the following:

i. Conducting accessibility audits of websites, including aspects such as design, ease of navigation, use of visual indicators, contrast and colour, availability of text alternatives for images for screen readers, etc., to ensure compliance with accessibility standards and guidelines notified under Rule 15 of the RPwD Rules.

ii. Documenting and reporting the status of accessibility features on various web applications.

iii. Providing detailed gap analysis reports highlighting areas of non-compliance and suggesting corrective measures. The auditor shall provide a VPAT report and accessibility compliance certificate after the digital platforms are made accessibility-compliant by the concerned Department/Organization/end-user. The certification shall not carry any international agency logo or co-branding.

iv. Monitoring and evaluating the implementation of recommended measures to ensure that they are effectively incorporated and continue to meet web accessibility standards.

v. Staying updated on changes in web accessibility standards and regulations through continuous professional development. The empanelled auditors shall work closely with DEPwD and other relevant stakeholders to contribute towards creating a more inclusive and accessible digital environment for persons with disabilities.

II Discretion of DEPwD

DEPwD, in its sole discretion and without incurring any obligation or liability, reserves the right at any time to cancel the empanelment of the organization/individuals as web accessibility auditors at any time, based on any adverse feedback relating to the performance of the service providers.

4. All the above points may be treated as part and parcel of this OM. This OM supersedes/clarifies this Department's earlier OMs to avoid any ambiguity and to maintain a single, clear reference document.

5. This issues with the approval of competent authority.
