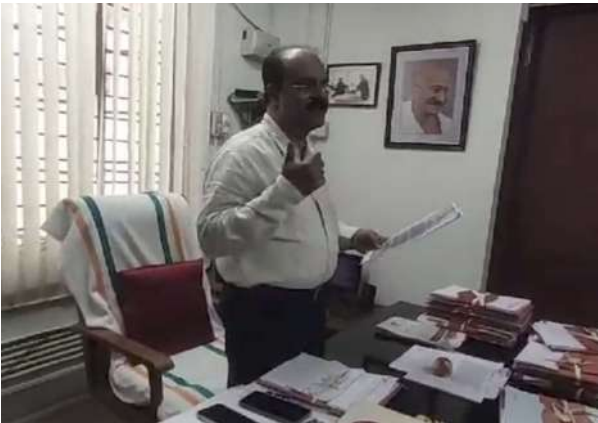


ACTIVITIES OF KeLSA FOR THE MONTH OF NOVEMBER,2024
