Subject: Request to complete the Geo-tagging of Gram Panchayat Bhawans-reg.

The undersigned is directed to refer to the subject above and the D.O. letter of even number dated 2nd May 2025 (enclosed at Annexure-I) and Office Memorandum of even number dated 16th May 2025 (enclosed at Annexure-II), regarding the uploading of geo-coordinates of Gram Panchayat (GP) Bhawans through the Meri Panchayat mobile application.

- 2. As of 10.06.2025, nearly 2.03 lakh Gram Panchayats (GPs), across the country, have geo-tagged their Panchayat Bhawans using the Meri Panchayat App. The statewise progress is provided in Annexure-III. Many states have demonstrated significant progress in achieving the target. However, a few states-namely Mizoram, Madhya Pradesh, Haryana, Himachal Pradesh, Assam, Arunachal Pradesh, Punjab, Jammu and Kashmir, Manipur, Meghalaya, Puducherry, Andaman and Nicobar Islands, and Lakshadweep etc. have either not initiated the geo-tagging process or are significantly lagging behind in meeting the target.
- 3. As highlighted earlier, this data is essential for effective planning, monitoring, and implementation of schemes by this Ministry and other Departments. A user-friendly feature has been provided in the Meri Panchayat App that allows geo-tagging by simply capturing a photograph of the Panchayat Bhawan, which auto-tags the location.
- 4. It is once again requested that the remaining GPs in your State/UT may be suitably sensitized and directed to complete this activity in next 15 days.

On several occasions, it has been observed that the availability of geo-coordinates of Panchayat Bhawans greatly aids in the effective implementation of projects at the Gram Panchayat level. Additionally, various line Ministries have requested this Ministry to provide the geo-coordinates of Panchayat Bhawans for implementing their schemes. Such information is crucial for planning, monitoring, and ensuring convergence of development efforts at the grassroots. A reliable repository of spatial data enhances infrastructure planning and improves service delivery.

- 2. To address this need, the Ministry of Panchayati Raj has enabled a functionality in the *Meri Panchayat* mobile application to capture and upload the geo-coordinates of Gram Panchayat Bhawans. The process is simple and user-friendly—PRI officials can log in to the app and capture real-time coordinates by clicking photographs using the mobile camera. No technical expertise is required. The Standard Operating Procedure (SoP) for this functionality is enclosed for reference.
- 3. As you are aware, the *Meri Panchayat* App is a citizen-centric platform developed by the Ministry to strengthen grassroots democracy. It empowers citizens to access critical information related to their Panchayat's development plans, financial details, works, and meetings. The app promotes transparency, accountability, and public participation by making Panchayat governance more accessible through digital means.
- 4. In light of the above, I request you to kindly direct Panchayat officials in your State to make use of the *Meri Panchayat* App for uploading geo-coordinates of Panchayat Bhawans. To ensure timely and comprehensive coverage, it is advised that this activity be carried out in **campaign mode during the current month**. 
# . How to Download Meri Panchayat App

- 1. Meri Panchayat application can be downloaded from Google Play Store.
- 2. Type Meri Panchayat in the search Box
- 3. Click on Download to view the App content.



# How to Boot Meri Panchayat Application

- 1. Click on the Arrow displayed in the centre of the screen.
- 2. Choose a preferred language i.e. English/ Hindi.
- 3. Read the terms of Conditions and click on Lagree Button at the bottom of the screen.
- 4. Login screen will be displayed.



## 1. Launch the Application

Open the Application on your mobile device. The home screen will display various login options including new and existing users.

# 2. Click on Users of eGram Swaraj Portal

On the Login screen, locate and Click on the Users of **eGram Swaraj Portal option**. This is meant specifically for stakeholders such as Gram Panchayat Secretaries who already have Login Credentials for the eGram Swaraj Portal.


# 3. Enter eGramSwaraj Credentials

A login screen will appear prompting you to enter login details

Enter your username and Password.

## 4. Click on Login Button

After entering credentials, click on the Login button to proceed.



#### Step-by-Step Process

- 1. Login Home Page: After successfully logging into the Application using eGramSwaraj credentials, the Gram Panchayat Secretary is redirected to the Home page of the Application.
- 2. Select the Option- 'Upload Panchayat Bhawan Photos'
  - From the available menu options on the Home Page, the user must select the Upload Panchayat Bhawan Photos Feature
- 3. Panchayat Bhawan Photo Capture Screen-

Upon selecting this option, a new screen is displayed prompting the user to capture and upload three specific photos of the Panchayat Bhawan. The three Mandatory photos are:

- Front Elevation Photo: A clear and complete view of the front of the Panchayat Bhawan
- Left Elevation Photo: A side view capturing the entire left elevation of the building.
- Right Elevation Photo: A side view capturing the entire right elevation of the Building.

#### 4. Capturing and Uploading

- The user is required to capture the Photo using the Device Camera.
- Each Photos includes a dedicated Submit Button.
