## PRESS NOTE

#### 06 ACCUSED ARRESTED IN COPPER CABLE WIRE THEFT AT SURANGI

On 31.08.2021, an FIR vide No. 52/2021 u/s 380, 457, 34 of IPC has been registered at Khanvel Police Station on the complaint of Shri Sandip Sukhlal Goti, General Manager, Sanathan Company r/o. Park City, Silvassa, Dadra and Nagar Haveli against unknown accused for committing theft of Copper Cable Wire from Store Room of Sanathan Company, Surangi.

Brief fact of the case is that, on 30.08.2021, at between 02:00 to 03:00 hrs, 02 unknown accused entered the premises of Sanathan Company, Surangi and stole Copper Cable Wire worth Rs. 1 lakh.

Investigation of the said case was entrusted to ASI K. H. Patel, Surangi Out Post under the supervision of Station House Office, Khanvel, Sub Divisional Police Officer, Khanvel and overall supervision of Superintendent of Police, Dadra and Nagar Haveli.

During the investigation, Investigation Officer checked the CCTV footage and recognized 02 accused namely (1) Navin Shravan Dhangda r/o. Surangi Savarpada (2) Vishal Kurshan Davariya r/o. Chikhli. During inquiry with these 02 accused, they gave names of other 03 accused namely (3) Mukesh Shravan Dhangda (4) Santosh @ Chatai Arvind Dhangda and (5) Manish Kishor Patel all r/o. Surangi Savarpada who were also involved in the said crime and during further investigation all of them confessed with regard to commission of crime. During inquiry, it revealed that accused No. (1) and (2) entered the premises of Sanathan Company, Surangi and stole Copper Cable Wire. Thereafter, with the help of accused No. (3) (4) and (5) who were waiting near Compound Wall of company, took Copper Cable Wire in nearby forest and burned/cut the cable and separated 43 kg Copper from Cable Wire. Thereafter, they sold said copper to Scrap Dealer named Lalaji Ramprit Chaudhary r/o. Khadoli Navapada, DNH n/o. Siddharth Nagar, Uttar Pradesh.

Hence, all 05 accused were arrested on 03.09.2021 and were produced before Hon'ble Court, Silvassa on 04.09.2021 wherein they were granted for Police Custody Remand till 07.09.2021. Thereafter, accused No. (06) Lalaji Ramprit Chaudhary (Scrap Dealer) has been arrested on 06.09.2021. 100% Muddamal of the said case have been recovered on the behest of accused.
