- **HEAVY CRACKDOWN ON ILLEGAL LIQUOR BY DNH POLICE**
- **TWO BOLERO VEHICLES USED FOR TRANSPORTATION OF LIQUOR SEIZED.**
- **ILLEGAL LIQUOR OF WORTH RS.3,99,120/- SEIZED.**

On 02/09/2022, a secret information received about about illegal transportation of Liquor was going on in the area of Khanvel Police Station. Immediately two teams were formed comprising the staff from Special Branch and Khanvel PS headed by PSI Sonu S. Dubey and PSI Jignesh B. Patel respectively on the direction of Shri Siddhartha Jain, Sub Divisional Police Officer and overall supervision of the undersigned.

Efforts were made by the staff of Special Branch and Khanvel PS and checked two Bolero vehicles No.DN-09-R-9620 and No.DD-01-C-9312 while keeping watch in Khanvel area by the police personnel namely PSI Sonu S. Dubey, PC Jamu Bariya, PC Jitu Gavit, PC Sadanand Gavit, PC Visal Pandey, PC P D Patel and PSI Jignesh B. Patel, HC J P Janathiya, PC S D Kadu, PC Jane Borsa, PC V A Kurkutiya of Khanvel PS. On searching the said vehicles, liquor was found loaded inside both the vehicles which was carrying illegally without pass and permit. Details of seized liquor is as under: -

The vehicle No. DN-09-R-9620 was driven by Barku Sone Dhodi R/o Sindoni, Tornichimad Post Mandoni, Khanvel and he is the owner of the said vehicle and he stated that liquor was loaded from Sakar Van Wine Shop, Khanvel Khumarpada and vehicle No.DD-01-C-9312 was driven by Murtuza @Sameer Rafiq Koyelewala R/o Dabheri Post/PS Jawhar Tal. Jawhar Dist. Palghar, Maharashtra and owner of the said vehicle is Pravin Ragho Ozare, r/o Khedpa, Navapada and he stated that liquor was loaded from A. B. Dodiya Wine Shop, Ekta Complex, Khanvel. The abovesaid liquor and vehicles were seized by the DNH police and handed over to Excise Department, DNH for further necessary action.
