District Legal Services Authority, Kurukshetra invites applications from eligible retired Defence Personnel for empanelment as Para Legal Volunteers (PLVs) under the NALSA–Veer Parivar Sahayata Yojana-2025, which aims to provide free and competent legal services to Defence Personnel and their dependent family members.

As per the scheme, Para Legal Volunteers may be selected from amongst the following categories:

- Widows of deceased Defence Personnel
- Ex-Servicemen or their dependents residing in civilian areas
- Spouses or adult children of currently serving Defence Personnel

Interested and eligible persons having a minimum qualification of Matriculation may submit their applications, furnishing personal as well as academic details, along with a character certificate issued by the Sarpanch/Municipal Councillor/Gazetted Officer and **Defence Personnel Number** in the office of District Legal Services Authority, Kurukshetra, on any working day between **09:30 AM to 05:00 PM, up to 31.01.2026**.

It is further clarified that the work of Para Legal Volunteers does not carry any salary, remuneration or wages, except the honorarium as fixed by Haryana State Legal Services Authority, Panchkula, from time to time.
