In pursuance of the instructions issued by the Haryana State Legal Services Authority, Panchkula, vide letter No. 1416-437 LEG/04/PA/HALSA/DO-SUK/01/2025 dated 30.12.2025, applications are hereby invited from eligible Advocates who are Ex-Servicemen, having at least three years' standing at District Bar Association, Kurukshetra as well as Bar Associations Pehowa and Shahabad for empanelment under NALSA-Veer Parivar Sahayata Yojana-2025 for District Kurukshetra, in accordance with the provisions of the NALSA (Free and Competent Legal Services) Regulations, 2010.

The applications shall be submitted strictly in the prescribed proforma alongwith self-attested copies of relevant documents and shall be accompanied by proof of professional experience with special reference to the type of cases which the legal practioners may prefer to the entrusted with. For the proof of professional experience, the certificate issued by President/Secretary, Bar Assoiciation may be used.

The applicant/Advocate shall submit the application in person and applications received through post/courier/e-mail etc. shall not be considered or accepted. The applicant/Advocate shall clearly mention his/her Defence Personnal Number in the application form. The application form shall be submitted in the office of the District Legal Services Authority, Kurukshetra. Incomplete applications or applications received after the due date shall not be considered. **The last date for submission of the application form is 31.01.2026 (up to 05:00 P.M.).**

The selection of Advocates (Ex-Servicemen) for the panel shall be made by interaction or by such mode/method as may be ordered by the Learned District and Sessions Judge-cum-Chairman, District Legal Services Authority, Kurukshetra, or by the Haryana State Legal Services Authority, Panchkula. The date and schedule of interaction or other mode/method of selection shall be notified through a notice on the notice board of the District Legal Services Authority, Kurukshetra and through notice to the District Bar Association, Kurukshetra as well as the Bar Associations, Pehowa and Shahabad, through their Presidents. No separate letter/notice shall be sent to the applicant Advocate and it shall be his/her responsibility to check the notice boards regularly.
