07 POSTS OF CHAIRPERSONS, PERMANENT LOK ADALAT (PUBLIC UTILITY SERVICES)

Qualification:- A person who is or has been a District Judge or Additional District Judge or has held Judicial Office higher in rank than that of a District Judge.
Sitting fee:- He/She shall be entitled to a monthly fee of last drawn salary less the amount of pension received by him/her.

Conveyance Allowance:- For the purpose of attending the sittings of Permanent Lok Adalat, you shall be entitled to conveyance allowance based on the classification of cities as under:-

| 1 | X | 50 Lakhs and above | Rs. 1,000/- |

Age:- Below 65 years (maximum age till the person can hold office is 65 years).

20 POSTS OF MEMBERS, PERMANENT LOK ADALAT (PUBLIC UTILITY SERVICES)

Qualifications:- A person having adequate experience in any of Public Utility Services, as defined in Section 22-A of the Legal Services Authorities Act, 1987.
Sitting Fee:- He/She shall be entitled to a sitting fee of two thousand and five hundred rupees per sitting.

Conveyance Allowance:- For the purpose of attending the sittings of Permanent Lok Adalat, you shall be entitled to conveyance allowance based on the classification of the cities as under:-


