NOTICE REGARDING ONLINE REGISTRATION ON THE UNIVERSITY PORTAL FOR SEEKING ADMISSION IN MANAGEMENT SEATS IN VARIOUS PROGRAMMES BEING CONDUCTED IN SELF FINANCING INSTITUTES

1. This is in continuation to the University Order no. GGSIPU/Admissions/2023/3830 dated 21.06.2023 Notification No. 19/2023 regarding "Important Notice: Management Seats admission in Self Financing Institute 2023-24". Candidates seeking admission under Management Quota are also advised to read the said University Order.

2. The Schedule of Online Registration including submission of "Registration for Management Quota Fee" for all the programmes being conducted in Self Financing Institutes (list enclosed) for the Academic

Session 2023-24 is given below.

Note:-

The candidates who have already submitted application in offline/ online mode directly in any affiliated Colleges/ Institutes for admission in Management Quota seat in any one respective programme are hereby informed that they need not carryout online registration on University portal again for that programme. The candidates have option to obtain form directly from Self Financing College/ Institute and thereafter apply directly in the affiliated Colleges/ Institutes or carry out online registration University portal.

The candidate who has appeared in University CET in more than one programme and is desirous to participate for admission process in Management Seat in more than one programme is required to apply in the respective affiliated college separately or complete online registration on the University portal separately for different programmes.

I) Seats for Management Counselling:

The 10% of the sanctioned seat intake in Self Financing Institutes can be filled by the Self Financing Institutes in accordance with the provisions of Law as Management Quota Seats. The seat matrix in the affiliated Colleges/Institutes for Management Seats Admission shall be displayed by the respective affiliated Institute on their website along with other details containing procedure for filling up the Management Quota Seats. The seat matrix shall also be made available to the University for uploading on the University portal also. The reservation will be applicable for Management Quota Seats as per details as given in the Admission Brochure for the Academic Session 2023-24.

3. IMPORTANT INSTRUCTIONS

The admissions in Management Seats in affiliated Self Financing Institutes for the Academic Session 2023-24 in various programmes being conducted in affiliated Self Financing Institutes will strictly in accordance with;

- a) Provisions of the Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative Fee and Other Measures to Ensure Equity and Excellence) Act, 2007.
- b) Provisions of the Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative Fee and Other Measures to Ensure Equity and Excellence) Rules, 2007.
- c) University's Notification No. 245/2022; No. GGSIPU/Admissions/2819 dated 27.09.2022.
- d) Instructions issued by the University in the Admission Brochure for the Academic Session 2023-24.
- e) Any other instructions issued by the University as Designated Agency to the affiliated Self Financing Institute after issue of this Notice.

4. IMPORTANT INSTRUCTIONS FOR CANDIDATES CLAIMING RESERVATION:-

- (a) The admission in Management Seats shall be based on the aggregate marks obtained by qualified applicants at the qualifying examination as provided in The Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee Regulation of Admission Fixation of Non-Exploitative Fee and other Measures to Ensures Equity and Excellence) Act, 2007 and Rules notified thereafter.
- (b) The candidate seeking admission under reserved categories have to mandatorily provide the entitled supporting certificate in his/her name.
- (c) The reservation certificate should be issued from the respective state under the "Region" in which the reservation is claimed.
- (d) In case the candidate is claiming the seat reserved for DSC/DST category then He/ She should have passed his/ her qualifying exam from Delhi School/College and must have SC/ST certificate issued by the Competent Authority of Govt. of NCT of Delhi only certifying that the candidate is entitled to claim seats against Delhi SC/ST.

(e) The reservation policy for Self Financing Colleges/ Institutes affiliated to University for claiming Management Seats is as follows:

(f) For claiming reservation on a seat reserved for Defence Category, the candidates have to upload the duly filled and signed **Appendix 1** of Admission Brochure 2023-24 by the competent authority as mentioned in Admission Brochure 2023-2024.

5. **GENERAL INSTRUCTIONS:**

- (a) The candidates must read the conditions of eligibility for admission as given in the Admission Brochure for 2023-24 carefully and must satisfy themselves regarding their eligibility.
- (b) It is the sole responsibility of the candidate to ensure that they fulfill the minimum eligibility criteria in the programmes they seek admission.
- (c) If the fee is paid through credit/debit card and status is not 'OK', it means the transaction got cancelled and the amount will be refunded to concerned credit/debit card. Such candidates have to pay the fee once again.
- (d) Online Registration by paying Rs. 25,000/- does not entitles the candidate admitted against Management Quota Seat as the same shall be on the basis of merit.
