Venue of Counselling: Guru Gobind Singh Indraprastha University, Sector 16 C, Dwarka, New Delhi-110078.

1. The CET qualified candidates, whose names appeared in the merit list, drawn on the basis of CET 2023 and subsequently paid counselling participation fee of Rs. 1000/-(non refundable) vide University notification no. 3853 dated 23.06.2023 and 3894 dated 30.06.2023, shall only report in person for 1st counseling for 'Verification of Documents' and for 'Allotment of Seats', at the venue of counseling on the date and time mentioned below as per their Category and Rank. Details are as below:

- a) Allotment of Seats will stop as and when the seats get filled up.
- b) A candidate belonging to any sub-category is also eligible to secure admission in General / Unreserved Category of his/her respective Region, purely on the merit of CET.
- 2. Seat Allocation in Delhi and Outside Delhi Region

- 4. Eligibility Criteria for Programme- Post Basic B.Sc. in Nursing CET Code 188.
 - 1. The candidate should be a Registered Nurse and or equivalent with any State Nursing Registration Council.
 - 2. Pass in General Nursing & Midwifery (GNM) with minimum of 55% aggregate marks.
 - 3. The candidate should have undergone General Nursing & Midwifery (GNM) in an institution which is recognized by Indian Nursing Council.
 - 4. Candidate should be medically fit.
- 5. Offline Counselling Procedure

6. Fee

Bank Draft(s) of Rs. 60000/- is required at the time counselling in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his name, date of admission, phone, address, mobile no, name of the programme, CET Rank and CET Roll Number on the back of the Bank Draft(s). Balance fee (if applicable) shall be paid by the candidate at the allotted institute.

Documents Required for Verification and Allotment of Seats:

- a) Online Registration Form of Rs. 1000/-.
- b) Four passport sized photographs
- c) CET Rank Card/Merit Order of CET-2023 (copy)
- d) CET-2023 Admit Card (in original) 2023.
- e) Filled Admission verification form as per Appendix 6 of Part E of Admission Brochure 2023-24.
- f) Filled Preference sheet as per Appendix 11(A) of Part E of Admission Brochure 2023-24.
- g) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)
- h) Mark-sheets / Certificates of qualifying examination:
- i) The candidate will be required to bring the Original certificates/Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates/ Mark-sheets of qualifying examination.
- j) For Distance / Open Learning Cases: In case of students who have passed the qualifying examination through distance / open education system of any recognized University / Board / Institution, the necessary documentary evidence related to location of his / her study centre i.e. study centre proof, certificate from the University imparting open / distance education certifying the location of the study centre to be submitted.
- k) Physical Fitness Certificate: All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-E in Admission Brochure 2023-24 (As per Appendix 5).
- Reserved Category Certificate: All reservation category candidates who are seeking admission in reserved category in SC / ST / DEF / PWD must bring their reservation certificate (the caste/category certificate should invariably be in the name of candidate himself/herself and not in favour of respective parents/ guardians) in original along with the self attested photocopy of the certificate for claiming seat against the reserved category. The Defence Category candidates, in addition to all the documents, shall also bring Appendix 1 duly completed. The appendices are available in Part E of Admission Brochure 2023-24.
- m) Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
- n) There is no OBC and EWS seats in self financed and minority institute.
- o) Application regarding age or any other relaxation with necessary approval (if necessary).
- p) The required Certificate(s) for reserved categories / classes will be essential at the time of the counselling / admission and no provisional admission shall be admissible for want of caste/category certificate from the local competent authority. Further, the caste / category certificate should invariably be in the name of the candidate himself / herself and not in favour of respective parents / guardians.
- q) <u>Documents required for CHRISTIAN MINORITY CANDIDATES at the time of counselling</u>
 - Baptism Certificate issued by the Pastor / Priest of the Church
 - Confirmation Certificate issued by the Pastor / Priest of the Church
 - Letter from the Pastor / Priest regarding Church membership with dates.
- 7. It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before filling-up the verification slip at the time of verification of documents/counselling/allotment of seats, candidate should ensure that he/she fulfils all eligibility conditions as laid down in the respective Admission Brochure for the session 2023-24. If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions, his/her admission will be cancelled and also disciplinary action will be initiated against his/her and entire fee will also be forfeited.
- 8. <u>Seat Matrix</u>: Region wise and category wise seat matrix will be notified well before the commencement of counselling.

9. DATE AND TIME OF WITHDRAWAL OF ADMISSION

Last Date of Withdrawal is 31.07.2023 from Post Basic B.Sc. in Nursing programme. The same shall be submitted in the Admissions Branch, Administrative Block, Guru Gobind Singh Indraprastha University, Sector 16 C, Dwarka, New Delhi – 110078. A proper receipt for withdrawal will be issued in lieu thereof. It is once again informed that the request for withdrawal has to be made in the Admissions Branch, GGSIPU only and in the prescribed format necessarily.
