IMPORTANCE NOTICE - MD (PAEDIATRICS) 2023-24 CONDUCT OF PHYSICAL COUNSELLING FOR 02 SEATS OF MD (PAEDIATRICS) IN CHACHA NEHRU BAL CHIKITSALAYA FOR ACADEMIC SESSION 2023-24

All the concerned candidates eligible for admission/allotment of seat under GGSIPU State Quota seats are hereby informed that the admission in <u>02 State Quota seats of MD (Paediatrics) in CHACHA NEIIRU BAL CHIKITSALAYA, Raja Ram Kohli Marg, Geeta Colony, New Delhi, for the session 2023-24, shall be carried out by the Guru Gobind Singh Indraprastha University, New Delhi in offline/physical mode for the following Category and 200 point Roster:-</u>

Eligibility: Only candidates who have obtained their MBBS degree from the affiliated medical colleges of Guru Gobind Singh Indraprastha University, New Delhi are eligible for admissions to the State/Institutional quota seats.

Every candidate selected for admission to PGMC shall posses MBBS degree recognized by Medical Council of India and must have completed one year compulsory rotatory internship on or before Specified date of the admission year. The candidate should have obtained permanent registration with the MCI or any of the State Medical College. Only candidates who have obtained their MBBS degree from the Guru Gobind Singh Indraprastha University, New Delhi are eligible for admissions to the State/Institutional quota seats.

Admission Criteria: All candidates must have appeared in the National Eligibility cum Entrance Test - Postgraduate of 2023 (NEET PG 2023) and qualify to be considered for admissions.

All the concerned eligible candidates desirous of seeking admission in MD (Paediatrics) at Chacha Nehru Bal Chikitsalaya against seats reserved for State Quota <u>must submit physical copy of application duly filled with particulars as stated below for participation in Offline Counselling for allotment of seat. The application duly filled with complete particulars must be submitted at Facilitation Centre of Guru Gobind Singh Indraprastha University, Sector-16C, Dwarka, New Delhi w.e.f. 09.08.2023 (Wednesday 11:00 am) till 12.08.2023 (Saturday upto 01:00 pm) along with the documents as stated below:-</u>

- 1. Application request stating:
 - i). Name of the Applicant
 - ii). Father's Name
 - iii). Mother's Name
 - iv). DOB enclose self attested photocopy of class X marksheet
 - v). Address of correspondence
 - vi). Category (UR/SC/ST/OBC/EWS) enclose self attested photocopy of relevant certificate.
 - vii). Qualification (with name of the Institute and Year of Passing)
 - viii). NEET PG 2023 Roll Number & All India NEET PG 2023 Rank.
- 2. Self Attested photocopy of NEET PG 2023 Rank Card.

- 3. Demand Draft of Rs.1,500/- (Non-Refundable Registration Fee) in favour of Registrar, GGSIPU, payable at New Delhi.
- 4. Self Attested photocopy of MBBS degree (only from affiliated medical colleges of GGSIPU).
- 5. Self Attested photocopy of One year compulsory rotatory internship certificate.
- 6. Self Attested photocopy of permanent registration with the MCI or any other State Medical Council.

The envelope containing duly filled application for participation in counselling process for allotment of seat in MD (Paediatrics) against State Quota should be addressed to Incharge (Admissions), Guru Gobind Singh Indraprastha University, Sector 16C, Dwarka, New Delhi. All desirous and eligible applicants need to submit their applications at the Facilitation Centre, O/o PRO, GGSIPU within the notified date and time. Applicants in their own interest are advised to obtain proper receipt for having submitted application. The candidates failing to submit duly filled application along with required particulars in the laid down time shall not be considered for participation in the counselling process for allotment of seat.

Note: Candidates who are already admitted to any Postgraduate Medical Degree/Diploma Course in any University/Institution as on the date of counselling will not be eligible for admission. Candidates will be required to give an Undertaking/Declaration in this respect at the time of counselling/admission.

Any change in reservation policy, if taken by the Government of India/NCT of Delhi or the University, the counselling will be conducted in accordance to that.

All counselling shall be held according to the directions of the statutory regulatory body, Govt. of India, Govt. of NCT of Delhi, Hon'ble Court(s) and /or the University.

The list of candidates having submitted duly filled application at the Fascilitation Centre shall be uploaded on University website on 14.08.2023 (Evening) for information and the candidates may submit observation, if any, in the list on 17.08.2023.

The details of counselling procedure containing information such as date, time, venue, demand draft and documents required at the time of counselling/allotment of seat shall be notified on 17.08.2023.
