This is in continuation to University Notification No. 134/2023 dated 08.08.2023 regarding notice for Conduct of Physical Counselling for 02 seats of MD (Paediatrics) in Chacha Nehru Bal Chikitsalaya for the academic session 2023-24.

In this regard, all the candidates who submitted physical copy of their application duly filled with particulars as stated in the notification referred above for participation in Offline Counselling for allotment of 02 seats of MD (Paediatrics) under State/Institutional Quota, are hereby informed that the process of <u>'VERIFICATION OF DOCUMENTS' AND 'ALLOTMENT OF SEATS'</u> for the above stated programme i.e. MD (Paediatrics) at Chacha Nehru Bal Chikitsalaya is given as below:

Only the eligible candidates from among the list of applicants attached herewith as <u>Annexure 'A'</u>, may appear for Verification of Documents and Allotment of Seats, as per the schedule given above.

Any candidate, who fails to appear in person on the scheduled date and time i.e. on 18.08.2023 at 11:00 A.M. for Verification of Documents and Allotment of Seats, shall not be entertained for the counselling process. At the time of counselling, the candidates shall provide a set of photocopies of documents along with the original documents.

The allotment of seat in the 1st round of Offline Counselling will be done on the basis of 200 roster point, subject to fulfilment of eligibility conditions by the candidates as laid down by the University. This year i.e. for 2023-24, the roster point shall start from 169 (as already notified vide notification no. 134/2023 dated 08.08.2023. The specific roster point will be used to call the candidates of that particular category and all the seats at that point of time will be offered to the candidate. Since the roster points cannot be left blank, the conversion of seats of a category will be done during the first counselling itself. At the end of first counselling, if any seat remains vacant in any particular category for want of eligible candidate in that category, the seat will be converted as per the standard procedure of Govt. of India, which is as below:

Documents required at the time of counselling:

- 1. NEET PG 2023 Admit Card
- 2. NEET PG 2023 Score/Rank Card
- 3. Admission Verification Form, Appendix 6 of Admission Brochure 2023-24 (to be duly filled by the candidate)
- 4. 10th class certificate for proof of date of birth
- 5. MBBS degree
- 6. The compulsory rotatory internship completion certificate
- 7. Registration Certificate from Delhi Medical Council/State Medical Counselling
- 8. Character Certificate
- 9. Passport size photograph 04 nos.

- 10. Demand draft of Rs. 26,000/- (includes Rs. 1000/- Non-Refundable Counselling Participation Fee) in favour of "Registrar, Guru Gobind Singh Indraprastha University", payable at 'New Delhi' to be deposited at the time of allotment of seat. Balance fee, if any, shall be paid directly at the allotted college after seeking admission.
- 11. Copy of Identity Card Passport/Aadhar/DL/Voter Card etc.

Joining at the allotted college:- The candidates admitted through counselling conducted by the University on 18.08.2023 shall report to their allotted college/institute by 20.08.2023.

Withdrawal of admission:- The candidates after allotment of seat in 1st round of Offline Counselling will be allowed to withdraw their admission upto 03:00 p.m. of 25.08.2023. The candidate shall submit duly filled Appendix 11 of Admission Brochure 2023-24 enclosing along with the relevant documents at the time of submission of his/her request for withdrawal of admission.

Procedure for conduct of 2nd round of Offline Counselling, if required: The process for 2nd counselling shall be notified, if any vacancy arises due to withdrawal/non-joining of the allotted seat by the candidate within the stipulated date or otherwise. The process shall be in consonance with the guidelines as enshrined in the Admission Brochure of the University and in pursuance of the directions by Hon"ble High Court of Delhi in the Writ Petition (C) No. 3043/2014, titled "Dr. Sandeep Dhama vs State & Anr".

Note: Bond, if any, is purely between the respective college and the student. The University has no role in this regard.
