IMPORTANT NOTICE:

MANAGEMENT QUOTA ADMISSIONS 2023-2024

- The University from time again have been issued instructions that the admissions in Guru Gobind Singh Indraprastha University self financing affiliated colleges is in accordance with the provisions of self financing Act, 2007 and on the basis of merit in CET through centralized counselling to be conducted by the Designated Agency through a single window procedure except in Management Quota where the Management of the Institute is to conduct admissions for Management seats.
- The admission in Management Quota are in accordance with the provisions of Delhi Professional Colleges or Institutions (prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative Fee and Other Measures to Ensure Equity and Excellence) Act, 2007 (Delhi Act 8 of 2007), and the Rules 2007 notified thereunder, instructions issued by the University from time to time and Orders of the Hon'ble High Court of Delhi in various judgements.
- The Hon'ble High Court of Delhi in LPA 563/2023 has pronounced judgement on 04.08.2023, Para 34 of the said Judgement dated 04.08.2023 is re-produced below:-
 - We hereby dispose off the present appeal upholding the 34. following directions notified in the circular dated 22.09.2022 with partial modification that besides online mode, the candidates shall also be eligible to apply in "offline mode" for Management Quota seats. The directions are as under;-
 - i) GGSIP University to make an online portal to display the branch-wise college wise seats available under Management Quota.
 - Prospective students can apply online as well as offline against available seats under Management Quota.
 - The college shall display the list of aspirant admission seekers (iii) on the online portal as well as on the notice board of the college.
 - The College shall prepare common merit wise list of candidates (iv) who have applied through online and offline mode.
 - The merit list college wise shall be published online". v)

4. Further, the Hon'ble High Court of Delhi in the Review Petition in LPA 563/2023 has issued Order dated 07.08.2023. The Orders of the Hon'ble High Court provides as under:-

"that prospective students can apply online on the portal of the institute as well as offline (in the prescribed form downloaded from the website) of the college against receipt issued from the college) against available seats under management quota."

- 5. The University's issued Notification No. 132/2023; No. GGSIPU/Admissions/2023-24/4128 dated 08.08.2023 on the subject "Directions for compliance of Orders of the Hon'ble High Court of Delhi in the LPA 563/2023 in the matter of VIPS versus Govt. of NCT of Delhi & Anr. had issued directions to the Principals/Directors of the affiliated Institutes to ensure compliance of the aforesaid Orders of the Hon'ble High Court of Delhi in LPA 563/2023. A copy of the said letter dated 08.08.2023, issued by the University, is enclosed for reference.
- 6. The affiliated institutes are hereby directed to ensure that prospective students are provided facilities to apply online on the portal of the institute for admission in Management Quota.
- 7. It is further directed that compliance is required to be submitted by affiliated institutes to the University for having implemented the Orders of the Hon'ble High Court of Delhi conveyed vide Orders dated 04.08.2023 and 07.08.2023 in LPA 563/2023, failing to comply to these Orders of the Hon'ble High Court of Delhi, the Institute will not be entitled for ratification of the management quota admissions.
- 8. It is also directed that as ordered by the Hon'ble High Court, the Colleges shall display the list of aspirant admission seekers on the online portal as well as on the Notice Board of the college and shall prepare a common merit wise list of candidates who have applied through online and offline mode including those who have applied on the University online portal. Thereafter, the merit list of the college-wise shall be published online.
- 9. Affiliated colleges are also to ensure that the candidates are not compelled to restrict their choices of preferences at the time of counselling of Management Quota Admissions subject to availability of the choices at their merit.
- 10. The admission process in the Management Quota shall be completed in a specific time schedule as laid down in the Rules notified under the provisions of the Delhi Professional Colleges or Institutions (prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative Fee and Other Measures to Ensure Equity and Excellence) Act, 2007 (Delhi Act 8 of 2007).
- 11. Issued for strict compliance by the Affiliated Institutes.
