IMPORTANT INSTRUCTIONS

SUBJECT: Compliance of provisions of Rule 8(2) of the Delhi Professional Colleges or Institutions Rule, 2007 and compliance of Notification dated 24.08.2023 of Govt. of NCT of Delhi declaring Public Holidays from 08-10 September, 2023 for Educational Institutions.

- 1. Provisions of Rule 8(2)(a) of Delhi Professional Colleges or Institutions Rule, 2007.
- (a) The provisions of Rule 8(2)(a)(iv) of Rule, 2007 provides that within 02 days of closure of date for receipt of Management Quota applications, the merit list of all applicants on the basis of aggregate of marks obtained by the applicants at the time of qualifying examination, will be displayed on Institution's website and Notice Board.
- (b) The provisions of Rule 8(2)(a)(v) of Rule, 2007 makes it mandatory for the Institutions concerned to conduct admission counselling for allotment of branches/courses to the qualified applicants within a period of three days of drawing up of merit list of qualified management Quota applicants.
- (c) The provisions of Rule 8(2)(a)(vii) of Rule, 2007 provides the last date to fill up Management Quota seats will be nine calendar days after the last date for regular admissions in the University and the concerned course.
- 2. Programme BA LLB/BBA LLB (CET Code 121) and Programme B.Tech. (CET Code 131)
- (a) For the purpose of Rule 8(2)(a)(vii) of Rule, 2007, the last date for closures of regular admissions in Programme BA LLB/BBA LLB (CET Code 121) and in Programme B.Tech. (CET Code 131) was over on 23.08.2023 and 24.08.2023 respectively.
- (b) In order to comply with the provisions of Rule 8(2)(a)(vii) it is mandatory for institutions to conduct two rounds of counselling in Management Quota Seats in BA LLB/BBA LLB and B.Tech. not beyond 01.09.2023 and 02.09.2023 respectively.

Note:- Therefore, the instructions in this Notification shall not be applicable for programmes in BA LLB/BBA LLB (CET Code 121) and Programme B.Tech. (CET Code 131)

3. The Govt. of NCT of Delhi vide Notification No. 53/634/CN/GAD/dsgad/1802 dated 24.08.2023 have notified that in view of G-20 Summit schedule to be held in NCT of Delhi, the Govt. of NCT has decided to declare Public Holidays on 08th September, 09 September, 10 September 2023 for all Educational Institutes of the Govt. National Capital Territory of Delhi. Therefore, the Educational Institutions affiliated to GGSIP University are also governed by the Notification of the Govt. of NCT of Delhi dated 24.08.2023.

- 4. In Order to comply with the Govt. of NCT of Delhi Notification dated 24.08.2023 and Instructions in the Rules, 2007 notified Govt. of NCT of Delhi the affiliated institutes shall take into consideration following:
- (a) The affiliated institutes must upload the merit list of the candidates on the Institutions website and notice board, who have applied for admission in Management Quota within 02 days as mandate by Rule 8(2)(a)(iv) of Rule, 2007.
- (b) The affiliated institutes who have schedule to complete two rounds of counselling for Management Quota Admissions by 06th September, 2023 in accordance with the provisions of Rule, 2007 shall not reschedule the counselling dates for first and second round of counselling.
- (c) The affiliated colleges, in accordance with provisions of Rule, 2007 have scheduled the first round of counselling for Management Quota Admissions on or before 06th September, 2023 shall not reschedule the counselling dates for first round of counselling.
- (d) The Rule 8(2)(a) provides for conduct of second round of counselling on the next day after conduct of first round of counselling, however, since the affiliated colleges who will conduct first round of counselling on 06th September, 2023 shall not be able to conduct second round of counselling on 07th to 10th September, 2023 are hereby directed to conduct the second round of counselling on 11th September, 2023.
- (e) The affiliated colleges who are required to upload the merit list of candidates who have applied for Management Quota Seats on 04th September, 2023 or 05th September, 2023 or 06th September, 2023 shall be required to reschedule the dates for two rounds of counselling for admission in Management Quota by taking into account that no counselling is scheduled on 08 to 10 September, 2023 being declared Public Holidays. Such affiliated institutions shall be required to complete the first round of counselling on 11th September, 2023 and shall prepare the schedule for two rounds of counselling accordingly.

<u>Important</u>: All Affiliated colleges are hereby directed to give wide publicity to this Notice to each and every candidate who have submitted his application in offline, online, institute portal or University portal mode, so that the candidates are not denied opportunity for participation in Management Quota Admissions due to lack of communication.

Under no circumstances the counselling shall go beyond 13th September, 2023 subject to other time schedule as mandated in the provisions of the Delhi Professional Colleges or Institutions Rule, 2007.
