(ii).Important Note:

- The Offline Counselling for Admissions to B.SC(MTR) is made against the sanctioned intake for Rajiv Gandhi Cancer Institute and Research Centre, Sector-5, Rohini, Delhi-110085 affiliated with Guru Gobind Singh Indraprastha University.
- A candidate belonging to any sub-category is also eligible to secure admission in General / Unreserved Category of his/her respective Region, purely on the merit of CET.
- The conversion of seats reserved for SC, ST, OBC, Minority, etc. to General Category shall be done only after the completion of last counselling for the reserved categories and no such conversion will be allowed during the 1st Round of counselling. However, while converting the seats, any unfilled seat(s) reserved for ST Category will be offered to SC Category and vice versa and only after that the conversion of the reserved category seats shall be effected.
- Allotment of Seats will stop as and when the seats get filled up.
- The Counselling for the seats reserved for any region / category shall be stopped as and when the seats in / of such category / region are filled up.

 There shall be no seats reserved for OBC category candidates in Private / Self Financing institutions. However, in Government Institute (if any) seats are reserved for OBC Category candidates. Candidates shall also be eligible for allotment of seats in UR/GEN category or any other applicable sub-category.

4. Eligibility Criteria for Programmes for B.SC(MTR) Code: 158

"Pass in 12th class of 10+2 of CBSE or equivalent with minimum aggregate of 55% marks in Physics, Chemistry and Biology provided the candidate has passed in each subject separately. A candidate also must have passed in English(core or selective or function) as a subject of studies in the qualifying examination. OR

Diploma in Radiotherapy Technology after pass in 12th class of CBSE or equivalent with minimum aggregate of 50% marks in Physics, Chemistry and Biology provided the candidate has passed in each subject separately, having

Admission Criteria:

Admission shall be on the basis of the merit of the written test / CET.

minimum 5 years of experience in the field of Radiotherapy".

5. Seat Matrix

Approved Sanctioned Intake is 04. The reservations as applicable.

6. Documents Required for Verification and Allotment of Seats:

- a) Bank Draft(s) of Rs. 61,000/- (including Rs.1,000/- counseling participation fee non refundable) is required at the time of Counselling in favour of "Registrar, Guru Gobind Singh Indraprastha University", payable at Delhi. The candidate will write his/her name, date of admission, phone, address, mobile no., name of the programme, CET Rank and CET Roll Number on the back of the Bank Draft(s).Balance fee (if applicable) shall be paid by the candidate at the allotted Institute. The eligible Candidates in their own interest are advised to get their draft prepaid well in advance to avoid last time inconvenience.
 - b) Four passport sized photographs (same as that in admit card).
 - c) CET-2023 Admit Card in Original and CET 2023 Result.
 - d) Copy of Admission verification form (Copy of Admission verification form as per Appendix 6 in Part F of Admission Brochure 2023-24).
 - e) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy).

f) Mark-sheets / Certificates of qualifying examination:

The candidate will be required to bring the Original certificates / Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates / Mark-sheets of qualifying examination.

g) Physical Fitness Certificate:

All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2023-24 (As per Appendix 5).

h) Reserved Category Certificate:

All reservation category candidates who are seeking admission in reserved category in EWS/ SC / ST / DEF / PWD must bring their reservation certificate in original along with the self attested photocopy of the certificate for claiming seat against the reserved category. The Defence Category candidates, in addition, shall also bring Appendix 1 duly completed. The Appendix 1, available in Part F of Admission Brochure 2023-24.

- i) <u>Conduct and Character Certificate in original</u> from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
- j) Application regarding age or any other relaxation with necessary approval (if necessary).
- K) The Reservation for EWS category is applicable only in University School of Studies and Government Affiliated Colleges. This will be implemented in accordance with the Government of India and Government of NCT of Delhi Order as applicable. EWS certificate should be issued after 31st March,2023 stating valid for the year 2023-2024. Candidates claiming reservation against EWS category must produce certificate issued by the Competent Authority at the time of verification of documents and allotment of seat.
- l) Experience Certificate (original), if applicable.
- 7. It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before filling-up the verification slip at the time of verification of documents / counselling/allotment of seats, candidate should ensure that he/she fulfils all eligibility conditions as laid down in the respective Admission Brochure for the session 2023-24. If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions, his / her admission will be cancelled and also disciplinary action will be initiated against his / her and entire fee will also be forfeited.

8. Date and time of Withdrawal of Admission:

Last date of Withdrawal upto 15.09.2023 (04.00 P.M.). The refund shall be processed as per the notified Refund Policy 2023-24 of the University, shall mandatorily be submitted in the prescribed format available in Part F, Admission Brochure 2023-24 (Appendix-11). The same shall be submitted in the Admissions Branch, Administrative Block, Guru Gobind Singh Indraprastha University, Sector-16C, Dwarka, New Delhi-110078. A proper receipt for withdrawal will be issued in lieu thereof.
