Important Notes:

1. The details relating to applicability of Domain Specific Subjects / Optional Languages / General Test etc, Online Registration etc for admission to the above programmes is attached herewith as "Annexure - A".
2. The candidates should peruse the details of domain specific subjects required for admission in particular programme, based on the merit of CUET, before filling up the Registration Form. A candidate can apply in multiple courses for paying Registration fees separately for different programmes.
3. The candidates shall register themselves by paying the requisite fee of **Rs. 2500/- per course non refundable**.
4. **IT IS MADE VERY CLEAR THAT ONLY, AND ONLY THE CANDIDATES WHO HAD APPEARED IN CUTE, ARE ELIGIBLE TO REGISTER ONLINE ON THE UNIVERSITY PROTAL. ANY CANDIDATE WHO HAS APPEARED IN UNIVERSITY'S COMMON ENTRANCE TEST (CET)/ NATIONAL LEVEL TEST ARE NOT ELIGIBLE TO REGISTER AND PARTICIAPTE IN THE COUNSELLING THAT SHALL BE CONDUCTED BASED ON THE CUET SCORE.**

ALL THE CET/ NATIONAL LEVEL TEST QUALIFIED CANDIDATES ARE ADVISED TO PARTICIPATE IN THE SPOT ROUND(S) CARRIED OUT BY THE UNVIERSITY BASED ON THE MERIT OF CET. UNDER NO CIRCUMSTNCES CET QUALIFIED CANDIDATES SHALL BE CONSIDERED FOR ADMISSIONS BASED ON THE MERIT OF CUET AFTER EXHAUSTING THE MERIT LIST OF CET.

All the candidates, who have appeared and qualified CUET, shall be eligible to register Online for admission to various courses (based on CUET merit), irrespective of the fact that whether he/she had chosen GGS Indraprastha University as an option, or not: while filling up the form for CUET, with National Testing Agency.


