### **Important Points to be Noted:**

1. It is mandatory for the candidates to pay the Counselling Participation Fees of Rs. 2500/- (non- refundable), during the stipulated time period, failing which the candidature will not be considered for admission.
2. After paying the counselling fees the candidate must present in person for document verification with all relevant documents in original and 2 self-attested photocopies. If the candidate fails to attend the document verification then he/she will not be eligible for seat allocation during counselling.
3. Adhere strictly, to the entry/reporting timings as mentioned above. No one is allowed to enter after the prescribed time.
4. Along with the candidate, either of his/her parents can only be allowed to enter the Institute premises. No relatives are allowed. (For verification of Identity at the entry point, kindly carry your original Photo ID such as an Aadhar Card/Passport/PAN Card/DL etc)
5. All candidates claiming benefits under any of the reserved categories (SC/ST/DEF/PH) shall be present physically along with the desired documents for verification as per the date and time mentioned above.
6. Only Candidates with NOT Admitted Status are eligible to take part in the Counselling for management quota. (Not admitted means a candidate who has not taken admission in any of the Institutes affiliated with GGSIPU nor in University Schools of GGSIPU) or admitted under Management Quota. The original admit card of CET/CUET is mandatory.
7. Candidate shall submit an affidavit / undertaking on e-stamp paper (Rs. 10/-) that he/she has not taken admission and will not seek admission anywhere else in any of the colleges affiliated to GGSIP University once the seat is allotted under Management Quota.
8. Candidates who have already been admitted through online counselling or under the Management Quota in any of the Institutes affiliated with GGSIPU shall not be eligible for consideration for seat allotment under the Management Quota.
9. Candidates once admitted under the Management Quota seat will not be eligible to take admission in any other college affiliated to GGSIPU.

10. The management quota seats will only be filled up on the merit basis derived from the aggregate percentage scored in the qualifying examination and then the seat will be allotted as per the preference of the course or program opted by the candidate.
11. Admission is confirmed only after the submission of the Institute fees in full by the candidate on the same day of the allotment of seat.
12. The entire session of Counselling/Admission will be video graphed.
13. Candidates will be called strictly on the merit of the qualifying examination based on the Aggregate percentage of Class 12<sup>th</sup>.
14. In the inter-se-merit of candidates securing equal aggregate percentage in class 12<sup>th</sup>, the following criteria will be adopted to determine the merit:
