- 1. The CET qualified candidates, whose names appeared in the merit list, drawn on the basis of CET-2025, shall report in person for 2nd Counselling for 'Verification of Documents' and 'Allotment of Seats' at the venue for counselling on the date and time mentioned below, as per their Category and Rank. Details are as below:
- Admission Brochure also mentions that "For MS (Packaging Technology), the candidates who are GATE, UGC-NET, CSIR-NET qualified, who wish to seek exemption from CET, may give an application in writing in the office of Dean, University School of Basic & Applied Sciences, before the last date of submission of application form".

These candidates will also bring a Demand Draft of Rs.2,500/- in the name of "Registrar, Guru Gobind Singh Indraprastha University", payable at Delhi. The candidate will write his name, date of admission, phone, address, mobile no, name of the programme on the back of the Bank Draft(s) towards application fee. This fee will be in addition to the Part Academic Fee, which is required to be submitted at the time of counselling, as mentioned in the succeeding paras.

Note:- Admission in this course will be done as all India basis.

Important:

- A candidate belonging to any sub-category is also eligible to secure admission in General / Unreserved Category of his/her respective Region, purely on the merit of CET.
- The Defence and PWD reservation shall be in all categories in a horizontal manner. If the seats of these sub-categories (i.e. UR-DEF, SC-DEF, ST-DEF, UR-PWD, SC-PWD & ST-PWD remain vacant, they shall be first reverted to the parent category first during the 2nd Counselling.
- No such conversion will be allowed during the 1st counseling.
- The students, who have been admitted during 1st counseling, in any category, will not be allowed to change their category in the subsequent counselling.
- Allotment of Seats will stop as and when the seats get filled up.
- The provision for reservation in OBC category is not applicable for Post-Graduation/ master Level programme. However, the OBC category candidates shall claim seats in General Category in the order of their rank as per merit, as per their respective regions.

4. Reservation Policy

5. Eligibility Criteria for Programme- MS (Packaging Technology)(CET Code 604):-

Eligibility Criteria:

A candidate seeking admission for MS(Packaging Technology) should have passed the full time (not by correspondence of part time) Graduate degree examination in Science (12th +3 years degree entire years in science only) with Physics/ Chemistry/ Mathematics/ Microbiology or Biochemistry as the main subject or one of them as second subject in the three year degree or Agriculture/ Food Science/ Polymer Science or Engineering/ Technology degree of a AICTE/ recognized University with minimum second class. Those with equivalent overseas qualification would also be eligible for admission. The candidate needs to have consistently high academic performance and sound general knowledge. Candidates appearing in the final year of the qualifying examinations can also apply; however, they must submit their results/ provisional results (as given by University) latest on the day of the personal interview and selection, as without their degree result, student are not eligible to appearing for personal interview and will be eliminated from the admission process.

Age Limit: Maximum Age:- 30 years as on 01.08.2025 (Age relaxation: 3 years for OBC and 5 years for SC/ST)

6. Offline Counselling Procedure

Candidates shall please refer to the Chapter 8: 'Offline Counselling Procedure' Part-A, Admission Brochure 2025-26.

7. Fee

Bank Draft(s) of Rs. 96,000/- (Part Academic Fee) is required at the time counselling in favour of "Registrar, Guru Gobind Singh Indraprastha University", payable at Delhi. The candidate will write his name, date of admission, phone, address, mobile no, name of the programme, CET Rank and CET Roll Number on the back of the Bank Draft(s). Balance fee (if applicable) shall be paid by the candidate at the allotted institute.

8. <u>Documents Required for Verification and Allotment of Seats (alongwith a set of photocopies):</u>

- a) Four passport sized photographs
- b) CET Rank Card/Merit Order of CET-2025 (copy)
- c) CET-2025 Admit Card (in original) 2025.
- d) Filled Admission verification form as per Appendix 6 of Part F of Admission Brochure 2025-26.
- e) Filled Preference sheet as per Appendix 11A of Part F of Admission Brochure 2025-26.
- f) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)

- g) <u>Mark-sheets / Certificates of qualifying examination</u>: The candidate will be required to bring the Original certificates/Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates/ Mark-sheets of qualifying examination.
- h) For Distance / Open Learning Cases: In case of students who have passed the qualifying examination through distance / open education system of any recognized University / Board / Institution, the necessary documentary evidence related to location of his / her study centre i.e. study centre proof, certificate from the University imparting open / distance education certifying the location of the study centre to be submitted.
- i) Physical Fitness Certificate:

All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2025-26 (As per Appendix 5).

- j) <u>Result Awaited</u>: candidates seeking admission as result awaited candidate must have to submit Appendix 4 of Part F of Admission Brochure 2025-2026.
- k) <u>Reserved Category Certificate in addition to Appendix 10</u>:

The candidates seeking admission under reserved categories, must have to mandatorily bring the entitled supporting certificate in his/her name. The Candidates for further details <u>must read Chapter 6 (Reservation Policy)</u> of respective Admission Brochure 2025-26.

In case the candidate is claiming the seat reserved for DSC/DST/ category then He/ She should have passed his/ her qualifying exam from Delhi School/College and must have SC/ST/ certificate issued by the Competent Authority of Govt. of NCT of Delhi only.

For claiming reservation on a seat reserved for **Defence Category**, the candidate must have to bring the duly filled and signed **Appendix 1** of Admission Brochure 2025-26 by the competent authority as mentioned in Admission Brochure 2025-2026.

Reserved Category Candidates who fail either to bring documents as per notified schedule or whose documents are not in order will forfeit his/her right for the reserved category claimed and will automatically be converted to General Category as per University rules.

All reservation category candidates who are seeking admission in reserved category in SC / ST /DEF /PWD/ EWS/ KM must bring their reservation certificate (the caste/category certificate should invariably be in the name of candidate himself/herself and not in favour of respective parents/ guardians) in original along with the self attested photocopy of the certificate for claiming seat against the reserved category.

- Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
- m) There is no OBC and EWS seats in self financing and minority institute.
- n) Application regarding age relaxation with necessary approval shall be submitted prior two days before the commencement of Offline counselling (if necessary).
- o) The required Certificate(s) for reserved categories / classes will be essential at the time of the counselling / admission and no provisional admission shall be admissible for want of caste/category certificate from the local competent authority. Further, the caste / category certificate should invariably be in the name of the candidate himself / herself and not in favour of respective parents / guardians.
- 9. It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before the time of verification the verification slip at of filling-up documents/counselling/allotment of seats, candidate should ensure that he/she fulfils all eligibility conditions as laid down in the respective Admission Brochure for the session 2025-26. If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions, his/her admission will be cancelled and also disciplinary action will be initiated against his/her and entire fee will also be forfeited.
- 10. Seat Matrix: Seat Matrix to be displayed at the time of Counselling.
- 11. Procedure for Second Counselling

.

- a) The students, who have been admitted during 1st counseling in any category, will not be allowed to change their category in 2nd Counselling.
- b) The Second Counselling will commence from rank one onwards for all categories / programmes and the seats will be allotted strictly on the basis of merit of the candidates. Such candidates, who were absent in the First Counselling will also be permitted to attend the second counselling.
- c) A candidate who fails to appear in person on the notified date and time for counselling, shall forfeit his/her claim for the seat which could be offered to him/her, had he/she been present on his/her turn. However, if the candidate reports late or reports on subsequent days during the process of counselling, he/she may be considered for allotment of a seat available at that point of time provided he/she had not taken admission earlier.
- d) Open House Counselling / Spot counselling: Counselling on the Open Day will be held only if any seat(s) remains vacant after two rounds of counselling. The said seat(s) will be offered on that day to the qualified candidate(s) in order of merit. The seat(s) shall be offered to the qualified candidate(s) in order of merit irrespective of his/her Region provided he/she has reported for counselling on that day.

- e) De-reservation of unfilled Outside Delhi Quota Seats to Delhi Quota and Vice versa: In the Offline Counselling, Seats reserved for Outside Delhi Category will be converted to Delhi Category and Vice versa during the Open House Counselling (which will only be held if seats are vacant after 2nd round of counselling has been completed in the respective region).
