NOTIFICATION

Creation of One Supernumerary Seat for "ORPHANED CHILDREN" for admission in each UG and PG Programmes offered at University Schools of Studies/Centres of Excellence from the Academic Session 2025-26 onwards.

The Competent Authority of the University has approved creation of one supernumerary seat for "Orphaned Children" for admission in each UG and PG programme offered at University Schools of Studies and Centres of Excellence from Academic Session 2025-26 onwards. The guidelines will be as follows:-

Applicability

- (i) "Orphaned Children".
- (ii) Applicants must be Orphaned (both parents deceased).
- (iii) Must provide valid documentary evidence such as Death Certificate or verification by a recognized Child Welfare Authority or Institution and Affidavit.

Eligibility Criteria for Admission:-

The candidate must fulfil the Eligibility criteria prescribed in the respective Admission Brochure for UG/PG Programme offered at various University School of Studies.

Number of Supernumerary Seat:

One seat in each UG and PG programme offered at University School of Studies except in those wherein Statutory Bodies imposed any restrictions for creation of additional seats.

Note:-

1. This one seat shall be supernumerary in nature only in those programmes where respective Regulatory Body has not imposed any restriction for creation of supernumerary seat.
2. This one seat shall be filled up on All India Basis, i.e, without any Regional allocation (Delhi/Outside Delhi) as well as any other reservation viz SC/ST/Def/PwD/OBC/EWS etc. This seat shall be allotted purely on the basis of merit of applicable National Level Test/Common Entrance Test/Merit of Qualifying Examination as the case may be as mentioned in the respective Admission Brochure of the University.

Fees: Admitted candidates will require to pay entire fees at the time of their admission in the University, however, such eligible candidates will apply for fee 100% waiver under University EWS Scheme, as per rules.
