

5. It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before filling-up the verification slip at the time of Counselling/allotment of seats, candidate should ensure that he/she fulfils all eligibility conditions as laid down in the respective Admission Brochure for the session 2025-26. If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions, his/her admission will be cancelled and also disciplinary action will be initiated against him/her and entire fee will also be forfeited.
6. Admission will be made strictly on merit basis (Rank-wise) and counselling/admissions will stop when all the seats get filled-up for the particular round.
7. The candidates are also advised, in their own interest to check the details of fee, their name, rank, programme, etc. on Admission Slip issued to him/her by the Admission Officer before leaving the counselling hall.

#### **INSTRUCTION TO BE FOLLOWED AT THE TIME OF 2<sup>ND</sup> COUNSELLING :**

- a. The Second Counselling will commence from rank one onwards for all categories and the seats will be allotted strictly on the basis of merit of the candidates. **Such candidates, who were absent in the First Counselling will also be permitted to attend the second counselling.**
- b. A candidate, who fails to appear in person on the notified date and time for counselling, shall forfeit his/her claim for the seat.
- c. Admission will be made strictly on merit basis (Rank-wise) and counselling/admissions will stop when all the seats get filled-up
- d. A candidate, who fails to exercise the option in person during 2<sup>nd</sup> Counselling, shall forfeit his/her right for a vacant seat even if he or she had higher rank, for which the University will not be responsible.
- e. **DE-RESERVATION OF UNFILLED DELHI QUOTA SEATS TO OUTSIDE SEATS AND VICE VERSA: SEATS RESERVED FOR DELHI CATEGORY WILL BE CONVERTED TO OUTSIDE DELHI CATEGORY AND VICE VERSA WILL BE DONE DURING 2<sup>ND</sup> COUNSELING AS OPEN HOUSE COUNSELLING. IT IS CLARIFIED THAT NO SUCH CONVERSION WILL BE ALLOWED BEFORE OPEN HOUSE COUNSELLING.**
