Sometimes it's a rail accident, sometimes a bridge develops cracks right after its inaugutructure failures in the country, Kharge pointed out that the Gujarat bridge collapse was the seventh such incident in the state since 2021. He said the bridge collapse highlights the government's lack of attention to infrastructure safety.

Citing the frequency of accidents and infras-

ration. We haven't even recovered from the recent plane crash when news of a bridge collapse in Gujarat came in."

Quoting previous reports Kharge said: "The bridge was declared dangerous due to vibrations three years ago. Yet, nothing was done."

 राजधानी में लंबे समय से बन रहे 24 अस्पताल दिल्ली सरकार और दिल्ली वासियों के लिए चिंता की वजह वने हुए हैं। इन अस्पतालों पर अब तक लगभग 10,000 करोड़ रुपये खर्च हो चुके हैं, लेकिन इनका काम अभी भी अध्य है। सूत्रों का कहना है कि पिछले दिनों उपराज्यपाल बीके सक्सेना और मुख्यमंत्री रेखा गृप्ता के साथ हेल्थ एक्सपर्ट की बैठक में भी इसे मुद्दे पर गंभीरता से चर्चा की गई और काम में तेजी लाने के निर्देश दिए गए।

दरअसल, पिछली सरकार के समय भी कर लिया जाए, तब भी ये अस्पताल इन अस्पतालों को बनाने का काम की मरीजों को पर्याप्त मेडिकल केयर देने की शुरू हुआ था। लेकिन अब तक एक भी स्थिति में नहीं होंगे। ऐसे में इन अधूरे पड़े अस्पताल जनता की सेवा के लिए तैयार अस्पतालों को पूरी तरह चालू करने के हैं। इनमें लगभग 38 हजार लोगों की


