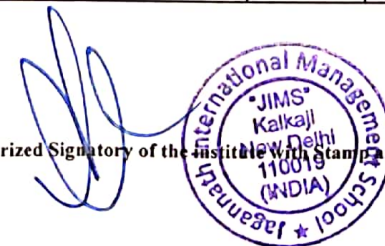

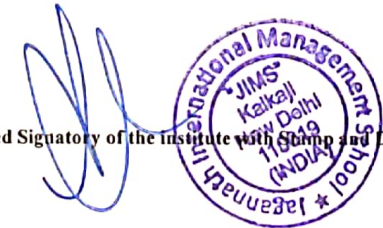

4.2 On reaching the venue, the candidates must mark the Attendance available with the Admission Officer. Allotment of Management Quota seat will be made to a candidate only when he/she attends the counselling session in person.

4.3 The candidates will be called in the order of merit. A candidate who fails to appear in person on the notified venue, date and time for counselling shall forfeit his/her claim for the seat which would have been offered to him/her had he/she been present on his/her turn.

4.4 A candidate who is allotted a seat will be required to pay a notified fee immediately on the spot at the time of counseling/admission via DD/Online payment. If a candidate, fails to pay the fee as mentioned above immediately after the seat is offered to him/her, the offer will be withdrawn on the spot and the seat will be offered to the next candidate in the merit list. Part payment will not be accepted under any circumstances.

4.5 Admission will be made strictly on merit basis and counseling/admissions will stop when all the seats gets filled up.

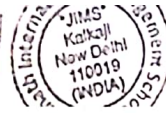
