- 2. All the eligible PG CET/CUET qualified candidates for M.Sc. (Microbiology) shall report in person for counseling for Verification of Documents and "Allotment of Seats", at the venue of counseling, on the date and time mentioned below, as per their category and rank.

## Important Points:

Offline Counseling Procedure

Candidates shall please refer to the Chapter-8: 'Offline Counseling Procedure' Part-A, Admission Brochure 2025-26.

1. There is an increase in intake of seats in M.Sc. (Microbiology) from 22 to 30.

2. Eligibility Criteria for Programme - Master of Science in Microbiology

Graduation in Science (B. Sc./B. Tech./B. Pharm.) Degree with atleast 50% marks in aggregate.

3. Fee

Bank Draft(s) of Rs. 96,000/- (Rupees Ninety-six thousand only) in favor of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his/her name, date of admission, phone, address, mobile number, name of the programme, CET/CUET Rank and CET/CUET Roll Number on the back of the Bank Draft(s).

- 4. Seats will be allocated as per the preference of Rank in CET, remaining vacant seats will be allocated to CUET candidates.
- 5. The defense and PWD reservation shall be in all categories in horizontal manner. If the seats of these sub categories remain vacant, they shall be reverted to the parent category after 12:00 noon.
- **6.** A candidate belonging to any sub-category is also eligible to secure admission in General/Unreserved Category of his/her respective region, purely on the merit of CET.
- 7. The conversion of seats reserved for SC, ST to General category shall be done only after 12:00 noon.
- **8.** New candidates who have not registered can registered themselves by paying the registration fees. The registration fee is Rs. 2,500/- (Rupees Two thousand five hundred only).
- 9. Allotment of seats will stop as and when the seats get filed up.

## Documents Required for Verification and Allotment of Seats (along with a set of photocopies):

- a) Four passport sized photographs
- b) PG CET/CUET Rank Card/Merit Order of PG CET/CUET-2025 (copy)
- c) PG CET/CUET-2025 Admit Card (in original) 2025
- d) Filled Admission verification Form as per Appendix-6 of Part-F of Admission Brochure, 2025-26
- e) Filled preference sheet as per Appendix-11A of Part-F of Admission Brochure, 2025-26
- f) Proof of date of birth (Secondary School Mark-sheet and Certificate) (Original and Photocopy)
- g) Mark-sheets / Certificates of qualifying examination:

The candidate will be required to bring the Original Certificates / Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificate / Mark-sheets of qualifying examination

h) For Distance / Open Learning Cases:

In case of students who have passed the qualifying examination through distance / open education system of any recognized University / Board / Institution, the necessary documentary evidence related to location of his/her study centre i.e. study centre proof, certificate from the University imparting open / distance education certifying the location of the study centre to be submitted

i) Physical Fitness Certificate:

All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2025-26 (as per Appendix-5)

i) Result Awaited:

Candidates seeking admission as result awaited candidate must have to submit Appendix-4 of Part-F of Admission Brochure, 2025-26

k) Conduct and Character Certificate in original form from the Head of the Institution from where the qualifying examination has been passed or from Gazetted Officer in original, not more that 06 (six) months old

- 1) Application regarding age relaxation with necessary approval shall be submitted on or before 10.09, 2025.
- m) The required Certificate(s) for reserved categories /classes will be essential at the time of the counseling /admission and no provisional admission shall be admissible for want of caste/category certificate from the local competent authority. Further, the caste/category certificate should invariably be in the name of the candidate himself/herself and not in favour of respective parent/guardians
- 10. It will also be the sole responsibility of the candidate themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before filling-up the verification slip at the time of verification of documents/counseling/allotment of seats, candidate should ensure that he/she fulfils all eligibility conditions as laid down in the respective Admission Brochure for the session 2025-26. If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions, his/her admission will be cancelled and also disciplinary action will be initiated against his/her and entire fee will also be forfeited.

### 11. DATE AND TIME OF WITHDRAWAL OF ADMISSION

#### Date of Withdrawal is 19.09.2025 (Friday).

The candidates must submit filled and signed Appendix-11, i.e. form for withdrawal of Admission of Part-F of Admission Brochure, 2025-26 (Appendix-11) in the Room No. 002, CEPS, GGSIPU, Sector-16C, Dwarka, New Delhi-110078. A proper receipt for withdrawal will be issued in lieu thereof. It is once again informed that the request for withdrawal has be made in the Academic Branch, GGSIPU only and in the prescribed format necessarily.
