- These seats are filled up on All India Basis i.e. without any Regional allocation (Delhi/ Outside Delhi) as well as without any other reservation viz SC/ST/Def/PwD/OBC/EWS etc. These seats shall be allotted purely on the basis of comprehensive merit meant for Sports Quota to be displayed on the University website on 12.09.2025 (tentatively).
- 2. The admission process shall be governed by University's Notification No.75/2025; F.No. IPU-7/Academic/SQ/2025-26/613 dated 06.06.2025 titled "Guidelines for Admission under Sports Quota for various UG/PG programmes offered at University Schools of Studies and Centers of Excellence for the Academic Session 2025-26".
- 3. The candidates are advised to go through the University's Notification No.75/2025; F.No. IPU-7/Academic/SQ/2025-26/613 dated 06.06.2025 in detailed.

4. Eligibility Conditions

Eligibility Criteria, for admission in a particular programme(s) shall be as per the Admission Brochure 2025-26. The candidates are required to kindly go through the eligibility criteria laid down in the UG/PG Admission Brochures 2025-26.

- The allotment of seat shall be done on fulfilling the common minimum eligibility as mentioned in the Admission Brochure and rank/marks obtained in NLT/CET/CUET whichever is applicable.
- 6. The Candidates whose names appeared in the merit list will only be allowed for participation in the Counselling.
- 7. Guidelines pertaining to grant of provisional admission as mentioned in the Admission Brochure 2025-26 shall be adhered to.

8. Documents required at the time of counselling.

(a) Undertaking by the parents and student for seeking admission in Sports Quota in UG/PG Programme being conducted in University Schools of Studies for Academic Session 2025-2026 (copy enclosed as Annexure-A).



- (b) Bank draft(s) of Rs.96,000/- (Ninety Six Thousand Only) towards Seat Acceptance/Part Academic Fee is required at the time of counselling in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. Balance fee will be deposited by the candidate at the time of Reporting in the respective University School of Studies.
- (c) 4 passport sized photographs.
- (d) CET Rank Card/CET Admit Card 2025
- (e) NLT Rank/NLT Score Care 2025 (whichever is applicable)
- (f) Filled Admission Verification form as per Appendix 6 of part F of Admission Brochure 2025-26.
- (g) Preference Sheet as per Appendix 11A of Part F of Admission Brochure 2025-26.
- (h) Proof of date of birth (Secondary School Mark Sheet & Certificate) (Original and Photocopy).
- (i) Mark-sheets/Certificates of qualifying examination: the candidates will be required to bring the Original Certificates/mark-sheets of all the year wise or semester wise in original alongwith photocopy of Certificates/mark-sheets of all the year wise or semester wise in original alongwith photocopy of certificates/Mark-sheets of qualifying examination.
- (j) For Distance/Open Learning Cases: In case of students who have passed the qualifying examination through distance/open education system of any recognized University/Board/Institution, the necessary documents evidence related to location of his/her study centre, i.e, study centre proof, certificate from the University imparting open/distance education certifying the location of the study centre to be submitted.
- (k) Physical Fitness Certificate: All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical certificate in given in Part-F in Admission Brochure 2025-26 (As per Appendix 5).
- (I) Result awaited: Candidates seeking admission as result awaited candidate must have to submit Appendix 4 of Part F of Admission Brochure 2025-26 and also refer Para 3.4 of UG/PG Admission Brochure 2025-26.
- (m) Conduct and Character Certificate from the Heat of the Institution from where the qualifying examination has been passed or from Gazetted officer in original, not more than 06 six months old.
- 9. It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfil all the conditions prescribed for admission. Before filling up the verification slip at the time of verification of documents/counselling/allotment of seats, candidates should ensure that he/she fulfils all eligibility conditions as laid down in the respective Brochure for the Session 2025-26. If it is found at any stage during the entire period of the programme that the candidate does not fulfil the requisite eligibility conditions, his/her admission will be cancelled and also disciplinary action will be initiated against his/her and entire fee will also be forfeited.
- 10. At the time of admission, the candidate must submit an undertaking at the time of admission stating that the candidate will practice and participate for the College, and if selected, will represent the University in the Sports Competitions as determined by University. In case the student violates the above referred undertaking the University has the right to cancel his/her admission.
- 11. All admission on the basis of Sports Quota are provisional and are subject to forensic examination/verification of the originals of uploaded/submitted Merit/Participation Sports certificates of the candidates. Candidate submitting false/fake Merit/Participation Sports certificates for seeking admission on the basis of Sports Quota, shall be debarred from admission to the University for three years. Such admissions will be cancelled and strict legal action will also be initiated against the student.
