1. This is in reference to University's notification no. 328/2025 dated 12.09,2025 informing all the candidates regarding conduct of "Special Round of Offline Counselling" for the given below programmes:

- 2. Special Round of Offline Counselling will be conducted only for "NOT ADMITTED" candidates in various Programmes. It is stated that the candidates should not be in possession of a seat (in that particular programme where one is desirous of seeking admission) as on 10/09/2025 (including who have withdrawn through online mode only). Candidates withdrawing thereafter will NOT BE TREATED as "NOT ADMITTED" candidate. Candidates who have already taken admission in the Management Quota in affiliated Institute/College shall not be considered in the Special Round of Offline Counselling.
- 3. CLAT 2025 UG/PG Candidates who have not registered earlier for LLB (Code 121) and LLM (Code 112) on NIC Admission portal, are required to bring DD of Rs. 2,500/- Application Fee (Non Refundable) in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. In addition, Bank Draft(s) of Rs. 96,000/- towards part academic fee is required, which is mandatory at the time counselling in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi.
 - →In order to prevent yourself from being debarred in this Round of counseling, you need to submit/edit your consent in order to verify your CLAT UG/PG 2025 Score/ Rank.

To submit/edit your consent, you can follow the below steps to edit your consent (as directed by the Consortium of NLUs):

- 1) Clear your browser cache
- 2) Log in to your CLAT account
- 3) Select as 'Consent' in the drop down box
- 4) Click on the 'Submit consent' button
- 5) To verify, click on the Print Application and see the last page.

NOTE: THE FEE OF Rs. 96000/- IF PAID DURING THE COURSE OF ONLINE COUNSELLING PROCESS SHALL NOT BE ADJUSTED DURING THIS ROUND. THE FEE PAID EARLIER WILL BE REFUNDED SEPARATELY. HENCE, IT IS MANDATORY TO BRING THE DEMAND DRAFT FOR OBTAINING SEAT IN THIS ROUND OF COUNSELLING.
