**Important:**

- Extended Open House Counselling will be conducted only for "Not Admitted candidates. It is stated that the candidates should not be in possession of a seat (in that particular programme where one is desirous of seeking admission).
- Allotment of seat shall be done on the basis of CUET. It is reiterated that remaining seats will be offered to the CUET candidates in the order of merit.

**2. Eligibility Criteria for Programme-B.Sc. Medical Imaging Technology (MIT)(CET Code-134):**

Candidates who have passed 10+2 of CBSE or equivalent examination with a minimum aggregate of 50% marks in Physics, Chemistry and Biology in the case of general students and 45% marks in case of candidates from SC/ST categories"..

**3. Eligibility Criteria for Programme-B.Sc. Medical Technology Radiotherapy (MTR)(CET Code-158):**

Pass in 12th class of 10+2 of CBSE or equivalent with minimum aggregate of 55% marks in Physics, Chemistry and Biology provided the candidate has passed in each subject separately. A candidate also must have passed in English (core or elective or functional) as a subject of studies in the qualifying examination.

OR

Diploma in Radiotherapy Technology after pass in 12th class of CBSE or equivalent with minimum aggregate of 50% marks in Physics, Chemistry and Biology provided the candidate has passed in each subject separately, having minimum 5 years of experience in the field of Radiotherapy.

**5. Documents required at the time of EXTENDED OPEN HOUSE Offline Counselling :**

**For the Programme B.S.c(MTR) :**

The Demand Draft/Bank Draft(s) of Rs. 96,000/- towards Part Academic Fee is required at the time of counselling in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his/her name, date of admission, address, phone no., mobile no, name of the programme, CUET Merit Rank and CUET Application Number on the back of the Bank Draft(s). Balance fee (if applicable) shall be paid by the candidate at the time of reporting in the allotted institute.

OR

**For the Programme B.Sc. (MIT)**

The Demand Draft of Rs. 60,000/- towards Part Academic Fee, is required at the time of counselling in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his/her name, date of admission, address, phone no., mobile no, name of the programme, CUET Merit Rank and CUET Application Number on the back of the Bank Draft(s). Balance fee (if applicable) shall be paid by the candidate at the time of reporting in the allotted institute.

**Documents Required for Verification and Allotment of Seats (alongwith a set of photocopies):**

- a) Four passport sized photographs
  - b) Duly filled and duly signed Admission verification form as per Appendix 6 of Part F of Admission Brochure 2025-26.
  - c) 10<sup>th</sup> class passing certificate as Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)
  - d) Mark-sheets / Certificates of qualifying examination:  
The candidate will be required to bring the Original certificates/Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates/ Mark-sheets of qualifying examination.
  - e) Physical Fitness Certificate:  
All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate given in Part-F in Admission Brochure 2025-26 (As per Appendix 5).
  - f) Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
6. The conduct of the Extended Open House Counselling is to facilitate those candidates only who had registered but had not opted.
  7. Physical presence of the candidate is mandatory at the time of Offline Counselling, except for medical reasons.
  8. Any candidate who have taken any seat in any programme/college through CET of the University and has "ADMITTED STATUS" shall not be granted any seat in any through the merit of CUET.
  9. It will also be the sole responsibility of the candidate to ascertain and make sure that he/she possesses the requires eligibility and qualifications prescribed for admission in a particular course.
