- Last and Final Round of Offline Counselling will be conducted only for CUET UG 2025 qualified "NOT ADMITTED" candidates from among the vacancies arose due to withdrawal applications submitted by the candidates in the University.
- 3. It is stated that the candidates should not be in possession of a seat (in that particular programme where one is desirous of seeking admission). Candidates who have already taken admission in this programme in any offline round of counselling and/or if withdrawn shall not be considered eligible for participation in this Round of Offline Counselling.

- 5. Registration fee of Rs. 2500/- (Non-refundable) and Part Academic Fee of Rs. 96000/- to be mandatorily submitted at the counselling venue in the form of Demand Draft in favour of the Registrar, GGSIPU.
- 6. The allotment of seats shall be irrespective of Region and Category and on All India basis.
- 7. It will be the sole responsibility of the candidates to ascertain and make sure that he/she possesses the requisite eligibility and qualification prescribed for admission.
